I would appreciate it if paper presenters for the 1995 Conference would prepare an abstract to give to me at the Conference. Presentation in the format of previous *Newslatters* would greatly assist in speeding up the editorial work.

REPORT FROM THE PRESIDENT

Wonderful memories of the Berlin conference in 1993 are still strong, but now we all look forward to the next conference in 1995 in Prague, a city which AKSE has not yet visited for one of its meetings. Progress on organizing the conference is excellent, thanks to Vladimir Pucek and his team, and Prague promises to be a memorable occasion.

PACKS: From 21 to 25 July 1994, Boudewijn Walraven and I attended the conference in Tokyo of our sister organization, the Pacific and Asian Council for Korean Studies (PACKS). I presented a general paper describing the activities of AKSE members and the current situation of Korean studies in Europe, and both of us enjoyed making as many contacts as possible with Koreanists in the Pacific region (which includes countries as far apart as Australia and the United States).

It is hoped that in the future members of AKSE, ideally members with something important and scholarly to offer (as distinct from Council members) will attend the PACKS conference, and vice-versa. Each organization will attempt to budget for travel grants for this purpose. The next PACKS conference is planned for Australia in 1996, probably in the summer months. I hope to be able to announce preparatory arrangements at the Membership Meeting in Prague.

AAS: A similar arrangement now exists with the Association for Asian Studies, which is a very large international association based primarily in the United States. Your *Newsletter* editor, James Grayson, and I attended the last AAS conference in Boston from 24 to 27 March 1994. It is planned for AKSE members, especially those who formerly have not had such an opportunity, to be invited to present papers at AAS conferences in the future, beginning with the 1995 conference (6-9 April in Washington, D.C.), and for Koreanists in AAS to be invited to the biennial AKSE conferences as well, beginning with the Prague conference next year.

Arrangements with AAS are complicated by the enormous size of the organization and the consequent necessity of preparation of the conference program well in advance of the conference. The final deadline for AAS to make its final decisions about participation is 1 August of the year preceding the conference. AKSE members who wish to be considered for participation at AAS (which includes a travel grant for air fare) should therefore contact either the current chair of the AKSE Korea program committee or me, by the end of June (and preferably sooner).

AKSE Workshops: only a couple of applications for workshops were received in preparation for the non-conference year 1994, sadly too late for obtaining grants for sponsorship. It was possible, however, for AKSE to lend its name to a separately-funded workshop on economics organized by the KOREA-Studiengesellschaft in Germany [see Reports of Studies, Germany, Dusseldorf]. AKSE members are encouraged to submit proposals for workshops, especially in the years intervening between regular AKSE conferences. The essential guidelines are these: 1) the workshop should be of high academic quality and devoted to a specific academic topic; 2) all participants should be specially invited; 3) all papers should be submitted in advance, to allow for detailed and intensive discussion; 4) numbers of participants should be limited to fewer than twenty, ideally more like ten to twelve. Proposals for 1996, including detailed budgets, should be submitted to

the AKSE Council as early as possible, ideally within a month or two after the Prague conference, that is, by the end of June 1995, to allow for discussion and consideration between Council and proposer, and also to allow for timely submission to funding agencies.

Electronic mail: the number of AKSE members (and, indeed, Koreanists worldwide) obtaining access to electronic mail and the Internet grows almost daily. Email allows one to make nearly immediate contact with other scholars worldwide, sharing information, asking questions simultaneously of a large number of fellow scholars, and holding discussions with like-minded scholars at any time of the year. AKSE itself has an informal email discussion group which as yet has little activity, but which is available immediately for use. As soon as participation becomes large enough, we can expand the discussion group to a proper "list" which operates itself (with little human operator intervention). Anyone wishing to join should send an email message to me, at r.c.provine@durham.ac.uk. Joining is not limited to AKSE members, and the current email address list includes scholars from all around the world.

An example of the recent use of the AKSE email discussion group is the catalogue of the rare issues of the *Lyeguk sammun* held in Paris, submitted by Didier Barbas: anyone interested in having the catalogue may receive it quickly by email. Any such documents that are in a computer file may be distributed on the discussion group. Another example was an open request for information on locations holding issues of a rare newspaper, which quickly produced a helpful reply from the United States.

I look forward to meeting as many of you as possible at Prague. In the meantime, I am available as always by email at r.c.provine@durham.ac.uk and by FAX at a new direct number, +44 (91) 374-3219.

REPORTS OF ACTIVITIES AND RESEARCH RELATED TO KOREA

Korea Library Group

BELGIUM

Leuven

Coen de Keuster defended his thesis at the University of Leuven on 18 February 1994. His title was "From Modernization to Collaboration, the Dilemma of Korean cultural Nationalism: the Case of Yun Ch'i-ho (1865-1945)". This study offers an analysis of the reasons for the collaboration of Yun Ch'i-ho with the Japanese occupation authorities during the colonisation of the Korean peninsula. The dissertation is divided into two main parts: the first deals with Yun Ch'i-ho's biography, the second with an analysis of his thought.

BRITAIN

British Association for Korean Studies (BAKS)

There was not a 1994 annual meeting as the three academic associations with interests in East Asia, the British Association for Chinese Studies, the British Association for Japanese Studies, and BAKS hosted the First Joint East Asian Studies conference at the University of Leeds from 6 to 8 April 1994. The Conference was well supported by the British Academy. The theme of the Conference was "Nationality and Nationalisms in East Asia" with a special plenary session devoted to the subject. Prof. Michael E. Robinson of the University of Southern California spoke on the history of nationalism in Korea. Other conference papers included Dr. James H. Grayson (Sheffield) "Ideology, Religion and the Roots of Nationalism: Two Studies of Revitalisation in Late Koryō and Late Chosōn Times"; and Mr. Stephen Creigh-Tyte (Warwick), "Vocational Education and Training in Korea". There was also a special archaeology section organised by Dr. Gina Barnes (Cambridge) on "Protohistoric Sources of National Identities" with several speakers from Japan and Korea. Dr. James E. Hoare chaired a session on "Korean Unification and its Implications for the Region". Speakers included Dr. Peter Lowe (Manchester), Aidan Foster-Carter (Leeds) and the chairman.

Volume 5 of the *Papers of the British Association for Korean Studies* and *British Association for Korean Studies Newsletter*, New Series, Number 3, have recently been published. Interested persons should contact the Publications Editor, Dr. Keith Howard (SOAS).

Council Members for the Association for 1994/1995 are Dr. James E. Hoare (Foreign and Commonwealth Office), President; Prof. Keith Pratt (Durham), Secretary; Dr. Gina L. Robert C. Provine, also occasionally known as the AKSE President, visited Korea briefly in October 1993 and again for the month of July 1994, Korea's hottest month on record. During the July visit, he read a paper at the tenth anniversary conference of the Society for Korean Historic-Musicology (Han'guk ūmaksā hakhoe) in Taegu, lectured at the Korean Traditional Performing Arts Centre (Kungnip kugeagwon) in Seoul, continued research on the *Akkak kwebeom*, and laid some foundations for a future project researching the life and work of Pak Yǒn, the fifteenth-century music theorist. The 1994 Korea trip was preceded by nearly a month in Vietnam and Malaysia: he presented a conference paper in Hanoi (on preservation of Korean traditional music) and collected comparative musical material in several locations. After Korea, he spent a week in Tokyo at the conference of the Pacific Area Council for Korean Studies (PACKS).

In May 1993, he presented a paper on Korean ritual music at a conference on Music in Chinese Ritual held at the University of Pittsburgh, and the paper will be published in 1995. Since he was on research leave from the university in 1993-94, he was able to travel to the United States to present a paper on sijo at the conference of the Lyrica Society, together with lectures on Korean music at Yale, Harvard, Smith, Tufts, and Cornell. In March 1994, he represented AKSE at the Association for Asian Studies conference in Boston.

London (School of Oriental and African Studies)

1. Prof. Martina Deuchler was on sabbatical leave during the past academic session. She was honoured with the Wiam Chang Chiyon Prize for Scholarship in History for her book *The Confucian Transformation of Korea*. The Prize was awarded at the Korea Press Centre in Seoul on 1 November 1993 under the joint sponsorship of the Wiam Chang Chiyon Memorial Association and the Korea Press Centre. In the Spring, 1994, Prof. Deuchler spent three months in Korea on a grant from the Korea Research Foundation collecting materials on the social class system in the late Chosön period which are held in the Kyujanggak archives. In acknowledgement of her continuous use of the archives over a twenty-five year period, some of her research activities were filmed as part of a documentary on the Royal Archives. Materials collected there and in Andong and Chonju will be used in preparation for the Reischauer Memorial Lectures which she has been invited to give at Harvard University in April, 1995.

2. Dr. Ross King became Chairman of the Centre for Korean Studies and taught Korean language at all levels. SOAS took on the Foreign and Commonwealth Office Korean language training programme, training a total of seven British diplomats during the academic session. Two completed the course leading to the Intermediate Certificate. Dr. King has been developing a video-supported course based on the Korean soap opera "Rainy Day Afternoons" for use in this teaching. Dr. King and Mr. Jae-hoon Yeon continued work on *Korean: A Foundation Course*, which will be published in 1995. Dr. King received a grant of US\$30,000 from the Korea Research Foundation, the British Academy and the SOAS Research Committee to host the Ninth Meeting of the International Circle of Korean Linguistics. Held from 20 to 22 July 1994, 100 scholars from twelve countries attended. During the academic session 1994/95, Dr. King will be a Korea Foundation Postdoctoral Fellow at the Centre for Korean Studies of the University of California, Berkeley. From the academic session 1995/96, he will take up an appointment as Assistant Professor of Korean Language and Literature at the University of British Columbia.

3. Dr. Keith Howard continued to teach courses on Korean music and Korean culture and society. He has received a grant of £42,000 over two years from the Korea Press Centre for a Research Assistant to develop a Schools Pack on Korea for British secondary schools. Ms. Tessa English is now at work on the project. Dr. Howard received £3,500 from the British Academy for a research visit to North Korea, £450 from the British Council for a conference in Moscow, and in collaboration with Dr. Katrina Hayward £1,800 from the Korea Overseas Information Service for a project on *p'ansori*. Dr. Howard also wrote and presented "Seoul Music", a BBC Radio broadcast on 8 April 1994, has given 25 radio and television interviews since December, 1993, and produces *Inflight* programmes of Korean pop music. From this academic session, he will be the Chairman of the Music Centre at SOAS.

4. Dr. Youngsook Pak on 10 February 1993 gave a lecture in Seoul on Koryo Buddhist Art at the Hoam Art Museum, and on 25 May 1993 she was the 1993 Annual Barlow Lecturer at the University of Sussex, where she gave a lecture entitled "Ancient Korean Wall Paintings: The World of Mortals and Immortals". She was Visiting Professor at the University of Heidelberg from October, 1993 to February, 1994. She has continued to teach the Sotheby's and SOAS Asian Art course and was convener and lecturer in the Korean and Japanese art module. She is presently working on three book projects - *Koreans (Oxford, Blackwell) with Prof. Deuchler, Handbook of Korea Art*, and *The Monuments of Namsan in Kyōngju*. She was also advisor on Korean Art for the TV programme, "Visions of Asia", which had a grant from the National Endowment for the Humanities in the USA. Dr. Park was also consultant on Korean art acquisitions for the Metropolitan Museum of Art, New York.

5. Mr. Iae-hoon Yeon has submitted his thesis "Grammatical Relation Changing Constructions in Korean: A Functional-Typological Study" to the Linguistics Department, SOAS. He has continued to teach all levels of Korean and to work with Dr. King on their forthcoming textbook.

6. Lisa K. Bailey, a Ph.D. candidate under the supervision of Dr. Pak will take up a part-time post as curator of the Korean Samsung Gallery at the Victoria and Albert Museum from September, 1994. She will complete her thesis on Silla royal tombs in December.

7. Choi Mi-jeong, Professor of Korean Language and Literature at Kyemyōng University, will be a Visiting Scholar at the Centre until March, 1995.

8. The Centre for Korean Studies received a grant of US\$96,000 from the Korea Research Foundation for staff salaries. The Korea Foundation has granted the Centre US\$52,000 per annum for five years for Postgraduate Scholarships in Korean Studies. Two Ph.D. and one M.A. grant awards were made for the current session. The Centre was visited by the President of the Foundation, Mr. Son Chu-Hwan, in April, 1994.

1. Dr. James Lewis has been appointed as Lecturer in Korean Studies at the University of Oxford in the Oriental Institute. This post is supported by a generous grant from the Korea Foundation. A separate language instructor has also been appointed.

Newcastle (University of Newcastle, East Asian Centre)

1. Dr. Roland Wein of the Politics Department taught the courses "Tradition and Modernisation: Korea", "Contemporary East Asian Political Systems: Korea", "Korean Domestic Politics", and "Korea in the International System". He spent two months in Seoul on a grant from the Korea Research Foundation researching the development of local autonomy and party politics in the ROK.

2. Shin Koo-sik received the Ph.D. with a thesis on "EC-Korea Trade and Protectionism", and Kang Ryang received the same degree with a thesis on "A Comparison

of Foreign Policy Making Processes in Japan and South Korea: The Case of the Loan Negotiations between 1981-1983". There are currently six postgraduate students in the Department studying Korea.

3. Beginning with the next academic session, the East Asia Centre will offer an MA in East Asian Politics with Korea-related seminars on the issues of democratisation and unification. The MA in East Asian Studies done jointly with the University of Durham will continue.

4. Currently there are 15 students in the Department who are studying Korean language of whom 12 are enrolled in the four-year degree programme "Politics and East Asian Studies (Korean)". Three students are at Kyōngbū University studying Korean language for one year and gaining work experience in a Korean company. Ian King, a 1994 graduate, is studying Korean in Seoul for one year under a Korea Foundation grant.

5. The East Asian Centre hosted the Fourth Annual *Korea Week* from 21 to 25 February 1994. There was a special seminar on "The Two Koreas in a Changing World", at which speakers included Chin Mi-Kyung (Ajou University), Aidan Foster-Carter (Leeds), and Dr. Wein. A second seminar on Korean-European Economic Relations included the following speakers: Alan Twist (EC Chamber of Commerce and Industry, Seoul), Kim Ui-On (UOK Trading, London), and Soo Hee LEE (Sheffield). Other special presentations included James H. Grayson (Sheffield), "The Impact of Christianity on Democratisation: The Case of Korea"; Robert C. Provine (Durham) on traditional Korean music; and Moon-Nyeo CHANG who talked about traditional Korean dance and gave a performance.

Studies offered jointly with the Department of Politics. Mr. Lee gave a talk on "The Prospect of Unification in the Post-Cold War Era" at the Advisory Council on Democratic and Peaceful Unification meeting hosted in Berlin on 15 to 17 December 1993. He presented the following papers during this academic session: "The East Asian Model of Capitalistic Development", at the Sheffield School of East Asian Studies, Seminars Series, on 15 February 1994; "The Integration of the Single Market in the EU and Korea's Economic Strategy", during the University of Newcastle's *Korea Week* on 23 February 1994; "Industrial Competition and Economic Integration in Pacific-Asia", at the Anglo-Japanese Symposium on "The Future of Regionalism: Focus on Pacific-Asia", at the Sheffield Department of Politics on 12 March 1994; "The International Business Environment in Asia", at the School of Management, Cranfield University, 15 March 1994; and "Current Trends of Democratisation in South Korea", at the Economic and Social Research Council Conference on "Democratization and Economic Liberalisation", hosted at the University of Exeter on 20 March 1994.

3. Mrs. Hyang-jin LEE was appointed in September 1994 as Teaching Fellow in Korean Language with special responsibility for developing language teaching materials for use in the Centre for Korean Studies.

4. The School of East Asian Studies at the University has been re-organised with the creation of the Centre for East Asian Research and the East Asian Languages Unit in addition to the existing Centres. Two Senior Research Fellows and five Junior Research Fellows have been appointed to the research centre. Dr. Ha-Won CHANG, who recently received the D.Phil. degree from the University of Oxford, was appointed Junior Research Fellow for Korea.

5. Forty students studied Korea-related subjects in the School of East Asian Studies during the past academic session. Three students received the BA degree in Japanese and Korean Studies in June, 1994, of whom Rupert Atkinson received a First Class Honours degree. Mr. Atkinson received a one-year grant from the ROK Ministry of Education to study Korean language with the possibility of a research scholarship at the end of this study.

6. The modularisation of courses and the semesterisation of the academic year has resulted in increased numbers of students taking East Asian subjects in the academic session 1994/1995. Twenty-two students are taking First Year Korean, and nearly a hundred students are registered for other Korea-related subjects.

7. The Korea Foundation made a grant of US\$15,000 for the purchase of special research materials which was used in part to purchase portions of the *Choson sotokufu kampō* not held in the Korean Collection of the Library. The Korea Research Foundation made a three-year grant of US\$95,000 for the provision of a Korean Studies subject librarian with responsibility for cataloguing materials and the creation of a computerised vernacular catalogue. Other gifts made to the Centre for Korean Studies include the entire 1991 Korean Census records and a subscription to the *Choson ilbo* by the Kyobo Insurance Corporation. The family of the late Peter Farrar donated his Korean library to the University.

It is with great sadness that we report the death of our colleague Lubuše Boháčková on 8 April 1994. Liba was a dear friend, devoted to AKSE and to the support of Korean culture.

Report by Dr. Albrecht Lein: A three-day workshop, "Regional Cooperation in Northeast Asia: Problems and Prospects for Korea" under the auspices of AKSE was organized by the KOREA-Studiengesellschaft in cooperation with Friedrich-Ebert-Stiftung and held 25 - 27 May 1994 at the Gustav-Heinemann-Akademie in Freudenberg, near Köln.

The introductory session dealt with the prospects of the five most advanced projects for regional cooperation in Northeast Asia. The keynote speaker was Dr. Albrecht Lein, chairman of KOREA-Studiengesellschaft, Düsseldorf.

The second session concentrated on the Tumen Area Development Program, and the keynote speaker was Professor Eckart Dege, University of Kiel. Mr. Kang Yong Mo, until November 1993 Chairman of the DPRK Committee for the promotion of external economic cooperation, was invited to this session, and he took part in the discussion.

The third session was devoted to the debate on unorthodox forms of regional economic integration and consequences for Korea. Prof. Pascha of the University of Duisburg was the keynote speaker. This session was enriched by a lecture by Dr. Elvenkenkemper, also of the University of Duisburg, questioning whether there is an Asian factor in international economic relations.

The sixteen participants in the workshop unanimously stressed that it was very successful. The main asset of the workshop was the intense and real cooperation of economists, Koreanists, Japanologists, Sinologists and geographers on one subject. The participants expressed the desire to have another workshop in 1995. They believed that it is important to link Koreanists and regional specialists from universities and other interested parties both to interact and to cooperate.

The International Institute for Asian Studies (IIAS) was established in January 1993 and formally opened in October 1993. To quote from the first annual report (1994):

"The disciplinary and geographical scope of IIAS covers the study (ancient and modern, the Humanities -- the classical oriental studies -- and Social Sciences) of the languages, cultures, and societies of South Asia (Pakistan, India, Nepal, Bhutan, Sikkim, Bangladesh, Sri Lanka, the Maldives), Central Asia (Afghanistan, Kazakhstan, Kirgizistan,

Tadzhikistan, Mongolia, Tibet), Southeast Asia (Burma, Thailand, Laos, Cambodia, Vietnam, Indonesia, Malaysia, Philippines, Brunei, Singapore), and East Asia (China, Taiwan, Japan, Korea, Hongkong, Macao)."

The IIAS has the following activities: "1) to set up and execute a post-doctoral programme for Dutch and foreign researchers; 2) the organization of international scientific gatherings; 3) to act as a national centre for Asian Studies to improve international cooperation in the European context; and 4) to develop other activities in the field of Asian Studies, such as the publication of a newsletter and the establishment of a database, which should contain up-to-date information on current research in the field of Asian Studies."

AKSE has cooperated with IIAS fully, and many readers of the AKSE Newsletter will already have received two substantial newsletters from the IIAS, describing its activities and many other matters of interest, such as reports on international conferences in Asian Studies and descriptions of Asian studies programmes in many countries and institutions. IIAS is also associated with the European Science Foundation's (ESF) Committee for Advanced Asian Studies (see entry under General Information). This is particularly revealing itself in the matter of the database, which will eventually contain information on current research by scholars in all areas of Asian studies, a matter of concern for ESF as well.

RUSSIA

St. Petersburg

1. Prof. Marianna Nikitina taught Korean literature and culture to students of the Department of Korean History and Philology of the Oriental Faculty of the St. Petersburg State University. She will be teaching Korean literature this coming academic session at the new Oriental Institute. Prof. Nikitina has given special lectures on rare literary works such as "Ch'ōngsōk-ka" and "Tongdong tari". She currently tutors five undergraduate students.

2. Dr. Sergey Kurbanov taught Korean history and religion in the Departments of Korean History and Philology of the Oriental Faculty. He has given courses on "Modern Korean Religions and Ideology" and "Historiography of Modern Korean History", and he has taught Korean language. He attended the Second Conference on "Christianity in the Far East", held in April at St. Petersburg State University, and gave a paper on "The Russian Orthodox Mission in Seoul: Its Past and Present". He spent six months in Korea in 1993 with a grant from the Korea Research Foundation.

3. Prof. Anatoly Vasil'yev taught Korean language in the Departments of Korean History and Philology, lecturing on Korean grammar dialects, lexicology, and the history of the Korean language. He gave special courses on synthetic subclasses of Korean verbs, adverbial participles, Sino-Korean vocabulary and Korean classical texts and lessons on reading textbooks, fiction, newspapers, and translating from Russian into Korean.

4. Prof. Adelaida Trocevich taught Korean classical prose, which is her principal research topic at the Russian Academy of Sciences. She has begun to make a catalogue of all old printed Korean books and manuscripts held in the library of the Oriental Faculty of the University. She spent three months in Korea in the autumn of 1993 on a Korea Research Foundation grant.

5. Hwang Sun-jung, a doctoral candidate, gave several special lectures at the Oriental Faculty and did some practical language teaching. His thesis topic is the history of the Russian Economy. Another doctoral candidate, Vladimir Tikhonov, is conducting research on the history of Karak-kuk. He gave a paper to the University's Annual Conference for Young Researchers on "The Concept of the Divinity of the State and the Ruler in the Karakkuk-ki".

EUROPEAN JOURNAL OF KOREAN STUDIES

European Journal of Korean Studies

At the 1993 AKSE Membership Meeting in Berlin, there was a proposal that a European journal of Korean studies be initiated under the auspices of AKSE. In order to investigate the feasibility of such a journal, a questionnaire was distributed with *Newsletter* 17 (1993). This is a short report on the results of the questionnaire, and further comments from *Newsletter* readers are welcome.

The *Newsletter* went out to 529 individuals and institutions worldwide. Of these, 274 were European; of the remainder, the two largest groups were 129 Korean recipients (including north and south) and 97 in the USA. A total of 87 questionnaire responses (16%) were received: 60 from Europe, 13 from the USA, 9 from Korea, and 5 from others or of unknown origin.

The following is a tabulation of the responses to the questions. Numbers do not always add up, as some respondents did not answer all questions, and in some cases multiple responses were appropriate:

Comments:

Of those who responded to the questionnaire, there was strong support in all countries for the idea of a European journal. On the negative side, fewer than a fifth of European recipients were interested enough to send in a response. A clear majority of respondents favoured a once-yearly publication and by nearly two to one, Europeans favoured a journal rather than an occasional paper series. No clear picture emerges on the language question, except that a publication purely in English had little support. A large majority supported a refereed publication, and Europeans wished to include the work of younger authors.

Most wanted an extensive book review section (49 from Europe), but when asked if they were willing to help, less than half the supporters (24 from Europe) were prepared to do so.

A large majority supported acceptance of articles from outside Europe. The publication figures show that 60 European respondents had published 63 articles in refereed journals in the last three years, while 13 USA respondents had published 24 such articles. We should consider whether we are simply half as productive as the Americans or whether the absence of a European journal genuinely inhibits our productivity. The European figures were better for non-refereed journals.

Questions 13 and 14 asked about other journals read by the respondents. While a total of 32 journal titles were cited, many respondents either gave no titles, or listed only one or two journals in Korean studies which they regularly read. Most Europeans in Korean studies, it seems, subscribe privately to few, if any, journals on Korean studies. The only journals privately subscribed to by more than 5 European respondents were the *Journal of Korean Studies* (6) and the *Korea Journal* (11). The larger list of journals regularly read (but not privately subscribed to) expands this more-than-five list only by adding *Koreana*. Most of the remaining titles were cited by only one or two respondents. A number of respondents listed general Asian studies journals like the *Journal of Asian Studies*; one person even listed 10 titles, none of which was a journal on Korean studies (but which might occasionally include an article on Korea).

There were not many further comments supplied by respondents. A few suggested that there be both a journal and occasional papers. One suggested that book reviews be included in the *AKSE Newsletter*.

My own view is that for a journal to be viable, there must be a strong and active core of productive writers and willing helpers, on the order of 75 to 100 persons. There are considerable problems associated with running a journal: finance, printing, distribution, editing, and contributions. These would require a substantial team effort, and I am concerned that the questionnaire, while showing that most people would like to receive a European journal of Korean studies, does not seem to indicate that a sufficient body of supporters exists. A possible alternative to a European journal is described in the next section below.

The matter of the European journal should be discussed again in Prague, both informally and at the Membership Meeting. The Council looks forward to hearing your views there, or by letter in advance of the conference.

KOREAN STUDIES IN HAWAII: ALTERNATIVE TO A EUROPEAN JOURNAL?

GENERAL INFORMATION

AKSE has been approached by the editors of *Korean Studies*, the well-known and long-established journal published by the University of Hawaii. *Korean Studies* wishes to expand its editorial board to a more international membership and to seek good articles for publication from a broader base. We are only at a discussion stage, especially in light of the proposal to found a European journal (discussed above), but the following points are currently on the table:

- 1) AKSE would have at least one member (out of two representatives from Europe) on the *Korean Studies* international editorial board, and that member would be identified in the journal as representing the interests of AKSE. There would also be three representatives from North America, and three from Asia. The members of the international editorial board would help to solicit contributions.
- 2) *Korean Studies* wishes to broaden its perspective and expand its appeal, and the international editorial board would assist them in this endeavour.

3) *Korean Studies* wants to bring new contributors and new interests into the journal, and to expand its readership. All this would lead to a stronger, less fragmentary field.

4) All articles would be refereed. The members of the international editorial board would help to identify referees.

5) Articles would be published in English, as is the present practice with *Korean Studies*. There are, however, some funds for translating articles into English from foreign languages.

In a number of ways, the *Korean Studies* proposal is an attractive alternative to a new European journal: the editorial base already exists, the publication and distribution system is already in place, financial backing does not need to be sought for a new venture, AKSE would be specifically represented on the editorial board, and it would not be necessary to solicit a set number of European articles before an issue could be published (as would be the case for a European journal). This is an easy solution, and one which responds to most of the preferences stated in the responses to the questionnaire about a European journal.

Responses to the questionnaire show, however, that AKSE members would prefer to work with a publication in mixed languages, and that point is now being considered by Hawaii.

I hope that a representative from *Korean Studies* will be able to attend the Prague conference for direct discussions with the AKSE membership. In any event, responses from the AKSE Newsletter readership concerning the possibility of a European journal and the alternative of joining forces with *Korean Studies* are most welcome.

The Union Catalogue goes Electronic!

The Union Catalogue of Korean Periodicals in Europe, a long-standing project of AKSE, is now available on computer disk. It combines research done by Robert R. Adami (published in two volumes by the Staatsbibliothek Preussischer Kulturbesitz in Berlin, 1981 and 1987) and Allard M. Olof (unpublished). The research was assisted by a grant from the Korean Traders Scholarship Foundation.

The disk comes complete with the database (containing 2,162 different Korean periodicals in 71 different European libraries) written in dBASE IV and a compiled (stand-alone) dBASE retrieval program for operation on PCs with DOS. This means that it is fully operational without dBASE or any other program. The database and the retrieval program are contained in compressed form on one 3.5" HD disk. An installation program is included; it will automatically decompress and install the database and retrieval program on your hard disk. 9 MB of free hard disk space are necessary to hold the database and program, and another 4 MB to operate the retrieval program.

The President has received a letter from Kim Sang-Tai (Kim Sangt'ae) as follows:

"I take the liberty of informing you that a Nationwide Committee for the Restoration and Improvement of the Homogeneity of Korean Language and Culture -- Uri mal uri munhwa tongjilsong hoebok ch'ujinhoe -- has been established in Seoul on February 24, 1994 in conformity with the unanimous appeal of 123 university teachers.

"... The principal objective of the committee is to restore and improve the homogeneity of Korean language and culture in the way that the restored homogeneity may contribute towards achieving a peaceful unification of the divided country.

"We wholeheartedly welcome to our committee all who agree with our proposal, and we solicit their active participation and support. Since any betterment of the Korean language and culture requires wisdom and cooperation, we extend our appeal also to scholar

and people of culture from all over the world who are interested in Korean culture, for their advice and encouragement."
