A Note from the Editor

As in the last few years, this issue of the Newsletter will be published in electronic form only, as will future issues for the time being. AKSE would like to encourage colleagues who did not submit the report this year to make the effort to compile a report for the next issue.

The **SUBMISSION DATE** for Newsletter 44 will be October 31st, 2021

Please observe the following: 1) Submit your next report according to instructions given below. The format of your submission should follow the style in the entry for your country and university. Please do not submit the same reports that you used for AKS or the Korea Foundation since they ask for items that are not usually included inAKSE newsletters.

2) As AKSE is becoming more globalized and interacts more with scholars in both America and Korea, there is more pressure to adopt American spellings of English. For future issues, American spelling conventions will be preferred.

3) For now, either of the two main romanization systems is acceptable - McCuneReischauer or Revised Romanization. As in the past, the Yale System can be used for linguistic purposes, and a non-standard Romanisation is acceptable if used in a title or if it is the preferred spelling of a person's name, such as Syngman Rhee.

4) Please do not submit any text in Korean or Chinese characters, and please use standard English forms of punctuation, especially with quotation marks. The reports should NOT include any hyperlinks as they make the text difficult to edit.

SUBMISSION GUIDELINES:

Please organise the information into the following categories:

1. General Information: You may include basic information about your department or program, such as the names of main faculty members, assistant instructors, and visiting scholars.

2. Academic Program: You may include here reports on the academic programme of study at a university or other academic institution, including reports on new developments in the programme of study, the number of students pursuing a particular degree course, numbers of graduates, or any other information relating to the academic programme of Korean Studies during the past year.

3. Seminars and Lectures: You may provide a list of seminars and lectures on Korea at your university during the past year. For each event, please give the date (in the format, daymonth-year), title of the talk, and the event and venue.

4. Other Activities: Activities relating to Korean Studies which took place in your institution or country during the past year. Reports of cultural events and radio and TV programmes on Korea should be included here.

5. Scholars' Reports: You may include any papers presented, research undertaken or contemplated, performances presented, conferences attended, or any other scholarly activity related to Korean Studies. Publications, however, should NOT be included here, but under category 4. Please note that a separate paragraph should be written for each person for whom information is provided. For talks and paper presentations, the format should be: date (daymonth-year), title of the paper, name of the event, and name of the venue.

6. Publications: You may include here you own publications or the publications of anyone else in your country which may be of serious interest to scholars of Korean Studies. You should NOT list any publications that are due to be published in the following academic year. As a model, see the format used under entries for any university.

Univerzita Karlova v Praze (Charles University)

Department of Korean Studies, Institute of East Asian Studies and Prague Centre for Korean Studies

General information

The faculty of Prague Korean Studies, headed by Miriam LÖWENSTEINOVÁ, includes two full-time assistant professors - Tomáš HORÁK, Marek ZEMÁNEK, one full time junior assistant professor Vladislava MAZANÁ, one part-time junior assistant professor Karolína ŠAMÁNKOVÁ (since autumn 2019) – and a full-time lecturer, JUNG Younwoo. The department is a recipient of the Academy of Korean Studies Core University Program for Korean Studies grant (CUPKS, 2011-2020). The CUPKS allowed the substantial increase of both the size of the department (number of teachers/scholars, students, library holdings) and the quality of research (publications, international cooperation, and recognition). In 2016, the Prague Centre for Korean Studies was established. The information about our activities is available on Facebook and a website of the project, where we share the results of grant activities as well. For detail, see www.facebook.com/korffuk/ and korea.ff.cuni.cz/. Every year we have been organizing conferences and workshops, organize lectures, produce monographs and various materials. Both the department of Korean Studies and the core staff of the Centre consist of six full-time scholars and an assistant to the centre. They are supported by project assistants, mostly doctoral and graduate students. The current structure of the staff covers different areas in Korean Studies, and we reached balance in terms of age and gender.

In 2019, the Institute of East Asian Studies and the Institute of South and Central Asia were merged into the all-embracing Institute of Asian Studies.

In March 2020, the exhibition "Korean Studies Yesterday and Today: 70 years of Korean Studies at the Faculty of Arts" was opened, see **http://korea.ff.cuni.cz/en/node/607**. In 2020, we also commemorate 30 years since the beginning of diplomatic relations between Czech Republic and Republic of Korea.

In 2019 - 2020, 3 students entered the doctoral programme.

Conferences

In August 2019 we co-organized The 14th ISKS International Conference of Korean Studies (제 14 차 코리아학 국제학술토론회). The conference aims at bringing together academics and researchers from around the world for a rewarding exchange of insights, views and the latest achievements in Korean Studies. We welcomed more than 170 scholars and guests from all over the world including North Korea, had eight simultaneous panel sessions for a

day and a half and a concluding symposium Exploring Prospects for Systematic Peace Building on the Korean Peninsula. For details, see http://www.isks.org/office/head/conf2019.html

Scholars' Reports

Associate professor Miriam LÖWENSTEINOVÁ (PhDr., PhD) has coordinated the Academy of Korean Studies (AKS) project and taught various new courses (Diaries, Letters, Primers; Interpretation of History - Modernisation, Nationalism and Traditionalism; Canon and Narrator). She with Vladimir Pucek and Matěj Valošek, prepared a bilingual text about Ch'oe Sŭnghŭi in Czechoslovakia in 1956 "Čchő Sŭnghŭi a An Sŏnghŭi v Československu/Ch'oe Sŭnghŭi and An Sŏnghŭi in Czechoslovakia" (Nová vlna 2019). She has attended conferences such as Bratislava's Poetry and Theology (20 - 21 September 2018), paper title: "Ch'angsega, the Song of the Creation of the World" and Korean Intellectuals In Between: Configuring knowledge in periods of transition, Bochum (20 - 21)June 2019), paper title: "Nationalism and Internationalism, Modernity and Tradition: Han Hŭngsu's presentation of Korea". She is preparing the Reader of Classical Korean Literature that will try to cover the cardinal works of Korean literary history. She edited and coauthored a book Made in Korea II (Nová vlna, 2019). In 2020 she edited and authored the main part of a book about Classical Korean Literature (translations with commentaries, with colleagues and doctoral students) *Čítanka klasické korejské literatury* (Reader of Classical Korean Literature, Nová vlna, 2020). She organized Korean Literature Translation Workshop and as a result of it, Kim Önsu novel Kaebinis will be published during summer of 2020. Recently, she and Vladimir Glomb finished the monograph of Kim Sisup, collecting about 10 studies of specialist on the theme. She attended a conference Korean Intellectuals In Between: Configuring knowledge in periods of transition, Bochum, 20 – 21 June 2019, paper title: "Nationalism and Internationalism, Modernity and Tradition: Han Hŭngsu's presentation of Korea". In May, 2019 she taught a series of lectures at Wroclaw University, series of lectures about Korean Literary Canon.

Tomáš HORÁK (Ph Dr., PhD) has been working on translation of No Kwanbŏm's Kojŏn t'ongbyeŏn, a book of essays on intellectual history of Korea from eighteenth to twentieth centuries. He has attended the International Symposium: One Way - Three Languages (Prague, 26 – 27 April 2019) and presented a paper "Problems of learning Korean in the field of teaching Korean studies with a focus on the morphological-syntactic features of Korean Lexics". He taught various new courses (*Theoretical Korean Grammar I, II, Special Korean Terminology*). He has attended the following conference: *Mezinárodní sympozium: Jedna cesta – tři jazyky [International Symposium: One Way - Three Languages*], Prague, (April 26

– 27, 2019), paper title: "Problematika osvojení korejštiny v rámci oborové výuky koreanistiky se zaměřením na morfologicko-syntaktické rysy korejského lexika" [Problems of learning Korean in the field of teaching Korean studies with a focus on the morphologicalsyntactic features of Korean Lexics]. https://sympozium.c3j.ff.cuni.cz/program/

JUNG Younwoo (Mgr.) continued her linguistic research. She prepared (with Marek Zemánek) a textbook "Chinese characters for learners of Korean II" (Čínské znaky pro koreanisty II). She taught several language courses and continued her linguistic research. She finished the second volume of the Chinese character primer, *Chinese characters in Korean for Czech learners II (Čínské znaky pro koreanisty II)* with Marek Zemánek. She is also responsible for organizing the CEEPUS (Central European Exchange Program for University Studies) lectures.

Vladislava MAZANÁ (Mgr., PhD candidate) continued her Ph.D. studies. She was the editor (with Karolína Šamánková) "Korean Ways of Diversity" (Proceedings of the Young Koreanists).

Karolína ŠAMÁNKOVÁ (Mgr., PhD candidate) is current project assistant and doctoral student, since fall 2019. She was coeditor (with Vladislava Mazaná) of the publication "Korean Ways of Diversity" (Proceedings of the Young Koreanists). She has attended The 4th International Conference of Young Koreanists (Prague, 8 March 2019), PBBP workshop in Berlin (15 - 16 March 2019) paper title: "The publication system of Korean history textbooks"http://korea.ff.cuni.cz/system/files/Programme_PBBP%20Workshop2019.pd, and the Worldwide Consortium of Korean Studies Centers Conference (WWC) in Berlin (18-21 August, 2019), paper title: "Nationalization of Korean History". She also teaches Modern history and lectures related to Korean society.

Marek ZEMÁNEK (Mgr., MA, PhD) continued his research on Korean Buddhism both old and modern, namely Buddhist rituals. He published (with JUNG Younwoo) a textbook "Chinese characters for learners of Korean II" (Čínské znaky pro koreanisty). He has attended the AKSE 2019 conference in Roma (11-14 April 2019) and presented a paper "Milk on the Altar: Abortion in Buddhist Rituals of 21st Century Korea". He teaches five to six courses per semester (e.g., Introduction to Korean Religions, Korean Buddhism, Introduction to Buddhism, Chinese Characters and Hanmun). In past years, he intended to further his research on Korean Buddhist Rituals during a postdoctoral fellowship. Since all his applications were refused, he usurped the position of the director of the newly established Institute of Asian Studies (see above), which allows him to ventilate the previously accumulated Han (恨). In 2019, he finished the second volume of the Chinese character primer, Chinese characters in Korean for Czech learners II (Čínské znaky pro koreanisty II) with Jung Younwoo. He presented a paper on reflection of abortion in Buddhist rituals at the AKSE Conference in Rome: "Milk on the Altar: Abortion in Buddhist Rituals of 21st Century Korea", (April 11-14, 2019). He dedicated most of the summer of 2019 to the coorganization of the ISKS Conference. Currently, he is working on an English translation of Biographies of Korean monks, and as always, is preparing a conference.

Olomouc

<u>Univerzita Palackého v Olomouci</u> (Palacký University Olomouc) Katedra asijských studií (Department of Asian Studies)

General Information

Korejština (Korean) was established as a section of the Department of Asian Studies at Palacký University in 2015, joining the established sections for Chinese and Japanese studies; Indonesian studies came in three years ago while Vietnamese studies were added last year. Students of Korejština combine intensive language training with courses on Korean culture, history, and society, along with a variety of courses in general and economic studies to be taken outside of the Filozofická Fakulta (Faculty of Arts). In autumn 2019, the fifth cohort of Korean studies students began, a group of 25, in autumn 2020, even 38 could start. These numbers could be much higher if it would be possible to accommodate all who interested. The acceptance rate during recent years was between one-to-five and one-to-seven! The winter semester of 2019 marked the start of both a new MA program in Asian studies, including a track specializing in Korean (for which 8 students formed the first cohort), as well as a PhD program in Asian Studies that will be open for specialization in Korea-related topics. Between December 2017 and June 2020, the section has been a recipient of a Korean Studies Promotion Service (Academy of Korean Studies) SEED project grant titled "Consolidation and promotion of Korean studies at Palacký University through international cooperation, academic research, research-based teaching and involvement of students." As in previous years, many single-semester scholarships could be offered to students of Korean studies from Olomouc thanks to partnerships with Korean universities. A fortunate situation is also the strong presence of Korean businesses in the region provides many opportunities for internships, part-time jobs, and full-time employment.

Academic Program

Korean language courses and the various Korean studies subjects are covered by four assistant professors (Dr. Blanka FERKLOVÁ; Korea Foundation visiting professor KAWK Bumo, PhD; Dr. Andreas SCHIRMER; Dr. SHIN Gyu-Ho), three regular lecturers (Youngran BAŠTANOVÁ KWAK, MA; Martin ŠTURDIK, MA; Petra SVÁKOVÁ, MA) and varying "irregular" lecturers (for the past years these included **Ruda SCHIMERÁ**, MA; **Marie CIBULKOVÁ**, BA; **Mina KIM**, BA). At the macro-level, Korean studies at Palacký University are steered by Dr. **David UHER**, previous head of section (until September 2020), Dr. Andreas SCHIRMER, current head of section, and Dr. **František KRATOCHVÍL**, head of department.

An important upgrade of the teaching offer has been possible thanks to the SEED project. A centerpiece of this project is a "carousel lecture," i.e., an annual themed lecture series. The second carousel lecture series was organized in the spring/summer semester 2019. Titled "Issues defining contemporary Korea," it comprised lectures from seven scholars:

- *Hangul Nationalism in the 20th Century* by **Thorsten TRAULSEN** (Bochum), February 15;
- "Your pancakes are so incredibly crispy! What on earth is the secret ingredient?": Korean 'Feel-Good Talk' Linguemes through the Lens of Linguistic and Cultural Semiotics by **Stefan KNOOB** (Duisburg), March 1;
- *Contemporary South Korean Literature: A Key to Korean Culture* by **Anastasia GURYEVA** (St. Petersburg), March 15;
- *The Practice of* ki suryŏn *('Life Energy Training') in Contemporary South Korea* by **Victoria TEN** (Jeon Yeonhwa) (Leiden), March 29;
- Korean Migration and Diaspora in Contemporary East Asia: Mobility, Identity, and New Forms of Belonging by Markus BELL (Sheffield), April 12;
- North Korean Ideological Discourse: Hwang Sok-yong's Novel Baridegi as a Mirror of Reality by Andrii RYZHKOV (Mexico City), April 26;
- Along the Mountain-Spine of All Korea: Trekkers, Tourists, Spirits and Sacred-Sites of the Baekdu-daegan Range by **David MASON** (Seoul), May 10.

The third carousel lecture series was organized in the spring/summer semester 2020. Titled "Between Nostalgia and Nausea Attitudes towards the Past in Contemporary Korea," it comprised lectures from seven scholars. All were done online, except for the first lecture. The lecture by Luis Botella was possible thanks to an EPEL grant.

- *The Periodization of Korean Archaeology in the Context of Reimagining a Collective Ancient Past* by **Luis BOTELLA** (Malaga), April 17.
- *The Tide Turns? Recent South Korean Critiques of Ancient Pseudohistory* by **Andrew M. LOGIE** (Helsinki), April 24.

Another major asset of the project was a "Winter School" providing a two-week language boost just before the start of the spring/summer semester in January/February, 2018, 2019

and again in 2020. This intensive teaching (240 minutes every day, for two groups each, 1st and 2nd year students) was very well received by, on average, 30 students every year. For 2019 and 2020, the invited teachers were **Paweł KIDA** (Poznań) and **YUN Sun Young** (Vienna). In 2019, **Petra SVÁKOVÁ** augmented the Winter School teaching offer with several classes for 3rd year students.

One further special program in 2019 was a two-week "Late Summer School" (during vacation, but participation was rewarded with normal credits) in the first half of September with two intensive courses, **YUN Sun Young** (Vienna) teaching on "Sino-Korean Vocabulary", and **Zuzana VAVRINCOVÁ** (Bratislava) on "Modern Korean History."

With support from CEEPUS, SEED, and the Erasmus+ programme, the workshop "Global Communication in Korean" was held as a three-day intensive course for two groups, for which 12 invited students from Cracow formed an energizing new learning community with students from Olomouc. Participating as session chairs were also Antonetta Bruno (Rome), Somin Chung (Rome), and Miriam Löwensteinová (Prague).

Since 2016, the department has been a "participating partner unit" (i.e., an active member) of a Korean studies network under the umbrella of the Central European Exchange Program for University Studies (CEEPUS). For the 2019/20 term, the network has been awarded 59 "mobility months" (single-month scholarships) which will be distributed among students and teachers. Going into its tenth year, the CEEPUS network for Korean studies now comprises

15 participating partner units from nine countries: Bratislava, Bucharest, ELTE Budapest, Cluj-Napoca, Kraków, Ljubljana, Novi Sad, Olomouc, Poznan, Prague, Pula, Sofia, Vienna, Warsaw, and Wroclaw. As for the past year, Olomouc could welcome **YUN Sun Young** (Vienna) for an intensive course on Sino-Korean vocabulary and *hantcha* (17 September – 5 October 2019) thanks to CEEPUS. One "incoming" one-month CEEPUS mobility was used by a student from Vienna whose enthusiasm was infecting. As for outgoing teaching mobilities, Andreas SCHIRMER visited Babeş-Bolyai University Cluj-Napoca, Romania, to teach on Modern Korean Literature (26 May – 2 June); and two students used one-month outgoing mobilities (to Vienna and Warsaw respectively). Thanks to CEEPUS, Olomouc also hosted one student from Vienna for one month, and one from Babeş-Bolyai University Cluj-Napoca, Romania, for a whole semester. Likewise, 12 students from Cracow were hosted for the Summer workshop thanks to CEEPUS (however, SEED funds were used to upgrade their stay a bit).

As in previous years, many single-semester scholarships were offered to students of Korean studies from Olomouc thanks to partnerships with Korean universities. A fortunate situation is also the strong presence of Korean businesses in the region provides many opportunities for internships, part-time jobs, and full-time employment.

Despite the Corona situation, 10 students from Olomouc were staying in South Korea for the duration of the whole summer semester of 2020 at various universities, within the organizational frame of our exchange programs.

Andreas SCHIRMER (PhD) served as director of the SEED project and thus the main organizer and convener of the various activities and events. His teaching comprises themed courses for the BA and MA programs and literature courses jointly taught with colleagues from the other section of the department. His current research mostly relates to the representation of current discourses and issues in contemporary Korean literature, translation studies, and the historical interaction between Koreans and Central Europeans. He has continued to coordinate the CEEPUS network *Korean Studies in Central and Eastern*

Europe, which he initiated in 2011. Under the auspices of this CEEPUS network, he visited Babeş-Bolyai University, Cluj-Napoca, Romania, for a course on "Modern Korean literature" (26 May – 2 June 2019). For the *International Summer School "Corso di Formazione sugli Studi Coreani"* (16–20 July 2019) at the Università per Stranieri di Siena, Italy, he contributed a series of six introductory lectures on Korean matters of debate. He also gave a special lecture at the College of Education, Kangwon National University, Chuncheon (17 Jan 2019). At the University of Tübingen, Germany, he gave a guest lecture (29 Jan 2020) on "Migration and 'multiculture' in South Korean literature: Real world mirrored in fiction" within the frame of the *Korean Studies Lecture Series* "Korean Literature and Culture." A guest professorship at the Jagiellonian University Kraków, Poland, in March and April 2020, eventually did not materialize due to the Corona situation. For Mykolas Romeris University, Vilnius, Lithuania, he gave online the equivalent of a semester course on translation issues by a series of a dozen online lectures, during October and November 2020.

1. General Information

The Korean Studies staff consists of **Barbara Wall** (Assistant Professor Korean Studies), **Karin Jakobsen** (Teaching Associate Professor Korean Language) and **Hyun Joo Choi** (Teaching Associate Professor Korean Language).

The following graph shows the growing numbers of applicants (upper line) and new students (lower line) in Korean Studies at the University of Copenhagen between 2011 and 2017. In September 2019 we took in 24 new students, which was still only about one fourth of the number of applicants.



2. Academic Program

The students enjoyed the first translation workshop with Gong Jiyoung in November 2018, which was made possible by the generous support of the Literature Translation Institute (LTI) Korea. We also organized a review contest on Gong's bestseller novel *Our Happy Time*. The next translation workshop will take place in November 2019.

The highlight of the last semester were the Nordic Korean Studies Days, organized together with the universities in Helsinki, Oslo, Stockholm, and Turku. REPORT 2018-2019

1. General information

The CKS is part of a joint research unit called "China, Korea, Japan," bringing together staff from the EHESS, CNRS, and other institutions. As an administrative and educational unit proper to EHESS, the CKS includes the following permanent faculty and staff: Ms. Eunjoo Carré-Na ("ingénieure d'études" in charge of the research library and communication at the CKS), Prof. Alain Delissen ("Directeur d'études" in modern history), Prof. Valérie Gelézeau ("Directrice d'études" in cultural geography), and Dr. Isabelle Sancho (a specialist of pre-modern Korea, "Chargée de recherches de première classe" at the CNRS appointed to the CKS). The current director of the CKS is Alain Delissen.

As a team of research however, the CKS also comprises several statutory research associates from different partner institutions, including nine permanent members (all tenured professors or associate professors) from Paris Diderot University (Yannick Bruneton, Florence Galmiche, Justine Guichard, Kim Jin-Ok, Kim Kyung-mi, Marie-Orange Rivé-Lasan, Pierre-Emmanuel Roux, Yim Eunshil and Yun-Roger Soyoung) along with Evelyne Chérel-Riquier (University of La Rochelle). Five honorary members must also be mentioned (Marc Orange, Alexandre Guillemoz, Francis Macouin, Martine Prost, and Li Jin-Mieung).

Completing the picture are other research associates, whether statutory PhD students or nonstatutory professors from other French or South Korean universities, Korea Foundation Post-Docs (in 2018-2019 **Dr Eugene Lee**, a specialist of pre-modern Korean literature with a PhD from SOAS) and "young research associates" ("jeunes chercheurs soutenus"), a new status created in 2013 in order to facilitate their future professional integration in French academia). As of 2019, 15 PhD Students were enrolled at the CRC-CCJ under the supervision of Alain Delissen (Choi Jimin, Marion Delarche, Marion Gilbert, Hong Sora, Park Jinsu, Seo Miwon), Valérie Gelézeau (Marion Casella, Feng Saier, Oshima Yukiko, Suzanne Peyrard, Wu Xiao, Son Youna), Yannick Bruneton (Damien Peladan, Bryan Sauvadet) or Marie-Orange Rivé-Lasan (Lee Jang Kyu).

As of January 2019, **Valérie Gelézeau** became the new director of the China, Korea, Japan EHESS-CNRS umbrella Research unit.

2. Academic program

Being embedded in a Graduate school, all teachings at EHESS partake of the research seminar format. The explosion in the number of undergraduate students who pick up Korean studies experienced elsewhere in France cannot (yet?) be observed at the graduate level. All in all, the number of EHESS enrolled students remains stable with a yearly average of 5 to 10 students for each level and for each professor. Should be noted, however, that EHESS seminars are also attended, in growing number, by students interested in Korea from other universities of the Paris area.

This seminar alternates general sessions about "problem areas" (e.g. "Teaching History in South Korea: insights into recent textbook controversies" or "Heating systems and society in South and North Korea – a comparison" or "What about Confucianism?") and research lectures by advanced PhD students/young scholars (**Dr Eugene Lee** on Travel Writing in Chosŏn. Two of **Prof. Park Bae-Gyoun's** lectures were given in this framework with **Prof. Françoise Ged** (Cité de l'Archirecture et de Patrimoine) or **Prof. Henri Desbois** (Université de Nanterre) as their discussant.

3. Workshops and conferences

The CKS under **Alain Delissen** engaged with its desire for reconvening what had disappeared from view over the years because of the thriving development of all at once highly specialized niches and more globalized (Europeanized) "Korean studies", that is: moments and venues putting together all the disciplines and topics available at the CKS. It has been decided that, once a year in November, all CKS members would "re-center" while sharing a one-day workshop of intensive exchange. On November 23, 2018, 24 "high speed" presentations could thus be listened to avenue Wilson about the actual research lines of each presenter.

On January 8-10, 2019 **Prof. Marie-Orange Rivé-Lasan** organized the workshop "Hate Speech in Asia and Europe: a comparative approach" at Paris Diderot University.

Prof. Marie-Orange Rivé-Lasan was also the main organizer of an international Conference that took place at Paris Diderot aimed at celebrating the Centenary of the Samil movement. It had "Korean Independence Movement and Europe: Comparing "small and weak" nations independence movements after the First World War" for a title and offered three panels and two roundtables on June 26-27, 2019. 4. Scholars' individual reports

Alain Delissen

Alain Delissen's main activities in 2018-2019 were again very heavy in administration (director of the CKS, deputy-director of the CNRS China, Korea, Japan Institute, director of the Institute of Korean Studies at Collège de France, co-administrator of the RESCOR in the name of its EHESS component, with **Yannick Bruneton** (Université Paris Diderot) and **Kim Daeyeol** (Inalco) and equally heavy in teaching (including in Geneva again) and tutoring. He had two Master students and Six PhD students, regularly enrolled at EHESS under his direction while sitting on the PhD committee of three other candidates. The two Master memoirs he tutored (**Jean-Baptiste Alary** and **Adriana Bonzy's**) were defended in September 2018 and June 2019 respectively. Two PhDs under his supervision (**Mrs Hong Sora** and **Seo Miwon's**) were completed and ready for defense as of October 2019. He was also the "warrant" for **Prof. Mathieu Guérin's** (Inalco) HDR (Habilitation thesis) defended at EHESS on June 25, 2019.

– In 2018-2019, **Alain Delissen** chose the 50+-volume series Han'guk minjung kusul yölchön that put together, in 2005, the life stories – and photographies – of ordinary old people from South Korea for the core topic of his research seminar.

Valérie Gelézeau

In 2018-2019, **Valérie Gelézeau** was busy with two major scientific commitments. The first one is the project CITY-NKOR (City, urbanism and architecture in North Korea) for which she received a large grant from the French National Research Agency (2018-2023). This pluridisciplinary project in the field of social sciences associates the Centre for Studies on China, Korea and Japan (UMR8173), the EFEO (École française d'Extrême-Orient, resp. **Elisabeth Chabanol**) and Leiden University (resp. **Koen De Ceuster**).

In part of this project, **Valérie Gelézeau** conducted a 2-week fieldtrip to Pyongyang, with a team of 4 people: **Yannick Bruneton** (Université Paris Diderot), **Pauline Guinard** (ENS), **Benjamin Joinau** (Hongik University) and herself. After participating in the Kim II Sung University international symposium with 4 papers, the team spent about 10 days at the Pyongyang University of Architecture, with two days of seminars and lectures, and the rest on thematic urban and professional visits (see below the general abstract of CITY-NKOR).

From January 1st, 2019, after she started being the director of the Centre for Studies on China, Korea and Japan, most of her time was devoted to train for that new function and taking care of the Centre. Nevertheless, she still took part in AKSE 2019 in Roma, with a paper co-presented on Songdo with one of her Ph.D. student, **Suzanne Peyrard** within a panel entitled "Place, space, power and scales: new geographical perspective on the ROK", including **Jamie Doucette** (University of Manchester), **Park Bae-Gyoon** (Seoul National University) and **Shin Hyun-Bang** (London School of Economics). A first version of this panel was tested during a one day workshop she organized on March 20, 2019, and which included also a round table about fieldwork techniques in the study of North Korea.

Besides these two major commitments, she teaches two seminars, is the advisor of 4 master and 6 Ph.D. students, and also the President of the AFPEC (Association Française Pour l'Etude de la Corée), the French association of Korean Studies.

Isabelle Sancho

In 2018-2019, **Isabelle Sancho** kept doing her part of collective duties: sitting in diverse evaluation committees and participating in the scientific management of the joint research unit "China, Korea, Japan" at EHESS, the IEC (Institut d'études coréennes) at the Collège de France and the RESCOR II (Le Réseau des études sur la Corée).

She also kept teaching with **Alain Delissen** and **Valérie Gelézeau** the CKS post-graduate methodological seminar in Korean studies at EHESS, "Intelligences de la Corée." In

September 2019, she started teaching one class at the undergraduate level (Licence 3), at the University of Paris (former Paris-Diderot University), about classical materials in Korean studies.

In early January, she acted as a discussant for South Korean students at the graduate students workshop jointly organized in Paris by the University of Paris, Pusan National University, and the "China, Korea, Japan" joint research unit at EHESS. In the 2019 AKSE Conference in Rome, she participated in the panel "Modes of Rejection and Strategies of Acceptance: Chosŏn Literati and the State" and presented a paper entitled "Saga toksŏ : a royal patronage of Sage Learning in Chosŏn?" In May, she presented in the University of Paris another paper, "Hwadam's cosmology of the Changes and the definition of the orthodox Confucian tradition in Chosŏn Korea," at the international conference organized by the National Research Foundation entitled "Tasan Jeong Yak-yong's Thought of Zhouyi from the Perspective of the Study of Confucian Classics in East Asia." She participated in June in the roundtable "Savoirs et techniques, pratiques, objets, circulations" organized by the joint research unit "China, Korea, Japan" at EHESS, and in November in the study day of the CKS about scientific monitoring in Korean studies.

She participated in two "comités de thèse," assessing the progress of PhD students at EHESS and supervised the Korea Foundation post-doctoral fellow at the CKS, **Dr. Eugene Lee** from SOAS. She wrote an assessment for a PhD manuscript submitted at the Institute of Area Studies of Leiden University and participated in the defense of the thesis at Leiden University in November 2019.

In November as well, she was able to do a short field trip in South Korea, in Seoul and Pusan.

As for publications, she completed in June and made available 150 biographical notes for the on-line teaching materials of the RESCOR II website. After achieving in the late Spring the

full manuscript of the annotated translations of all of the prose writings from Sŏ Kyŏngdŏk's Hwadam chip, planned to be published at Korean Classics Library of the Hawaii University Press, she finally received in late October the two external reviews of her work. She will dedicate the few months to come to the final revisions and, hopefully, embark on other publication projects and write her habilitation proposal next year.

GERMANY

Berlin Freie Universität Berlin Institut für Koreastudien (Institute of Korean Studies)

1. General Information:

For the 2018/2019 period, the various research units of Korean Studies at Freie Universität Berlin continued and initiated several academic projects while also engaging in teaching activities. The scope of research and teaching at the institute was further expanded through special lectures by invited experts and cooperation with other institutions. More information on the following events can be found on the website of the IKS.

The 2018/2019 period marked the last year of the AKS Core University Program for the Korean Studies project "Transcoding as Cultural and Social Practice," organized by the Korean Studies Institute of Ruhr-University Bochum (RUB) and the Institute of Korean Studies at the Freie Universität Berlin. This grant project supported the two Korean Studies institutes in the development of teaching materials, exchange of lecturers, and gave financial support for students and scholars of nearly all status groups as well as providing for research on transcoding/cultural translation as a core aspect of knowledge circulation. The 4th Korean Studies Summer School was organized in August 2018 under the title "Gendered Legacy and Future of Unification in Korea" and took students for a week to Korea to experience expert-lead on-site training, which included excursions to Hwagye Temple and the Institute for Unification. Further, with support from the AKS program, the Korean Studies in Berlin hosted the "PBBP Workshop" from March 15th to 16th 2019 providing a space for presentations and exchange between graduate students from Freie Universität Berlin, Ruhr-Universität Bochum, INALCO Paris, Charles University in Prague, and Yonsei University. In June 2019 the concluding workshop of the program was held at Ruhr-Universität Bochum.

The Berlin Forum on Korea on the 2nd of October 2018 brought together different experts from Germany and Korea to discuss questions related to "Peace and Security on the Korean Peninsula and the Question of Korean Unification." This followed up on the idea of the Forum, which was established in the previous year, to offer a platform for stakeholders from the fields of politics, the diplomatic service, the economy, and the cultural sector to debate long-standing issues regarding contemporary developments on the Korean peninsula. On November 8th 2018 a book launching event celebrating the first publication of Kim Dae-Jung's autobiography titled "Conscience in Action" organized by the Kim Dae-Jung Presidential Library was held at the IKS, with short talks given by the current Ambassador of the Republic of Korea to Germany H.E. Dr. Bum Goo Jong and the former Prime Minister of the Republic of Korea Han Myeong-Sook, as well as a laudation by Dr. Werner Pfennig.

From the end of September to the beginning of October 2018, a delegation from the IKS visited North Korea to participate in the International Conference at Kim Il-Sung University in

Pyongyang. Besides giving presentations and participating in the discussions of the various panels the group also went for several excursions related to research topics on Korean history, politics, and cultural heritage. After the conference a Letter of Intent between Freie Universität Berlin and Kim Il-Sung University was signed to encourage further cooperation between both institutions.

The subproject of the IKS researching the history of Confucian Academies within the Collaborative Research Center (CRC) "Episteme in Motion" organized a research trip to South Korea for members of the CRC in October-November 2018. Together with experts from Nagoya University the group visited Confucian Academies in Korea and came together with Korean scholars from the Academy of Korean Studies and the Korean Studies Institute in Andong. The field trip was rounded up by the FU-KoreaNet Workshop 2018 on October 30th, held at the Kyujanggak Institute of Korean Studies at Seoul National University. From April 15th to 16th 2019 the project organized the workshop "Asymmetries of Knowledge" in Berlin together with the subproject of Prof. Horst Simon on linguistics. As part of the annual conference of the CRC "(Nicht)Wissen – Dynamiken der Negation in vormodernen Kulturen" Prof. Eun-Jeung Lee gave a presentation on Western knowledge in 18th-century Korea.

The past year was further marked by many special events such as several IKS-FU talks, e.g. on current developments on the Korean peninsula by Prof. Hannes B. Mosler and Dr. Eric Ballbach, on the 100th anniversary of the March 1st Movement by Dr. Hee Seok Park, and a talk by Lee Jae-Joung (Superintendent of the Gyeonggi Province Office of Education) on Education in Korea. On the 7th of June, the "European Forum of Health Equity and Health System in North Korea" was also held at the Institute of Korean Studies in Berlin.

As of June 1st 2019, Prof. Dr. Hannes B. Mosler is a tenured full-professor (W2) for Korean politics at Freie Universität Berlin.

2. Academic Program and Special Lectures

Besides regular courses on language, history, politics, and economics, several lectures by invited experts were offered for students and the public. The focus of IKS Winter Special Course in 2018/19 was on the island of Jeju and its history, which featured lectures by Prof. Dr. Kim Dong-taek (Sogang University) on 'Korea's political economy', Prof. Dr. Kim Hyun Mee (Yonsei University) on 'Jeju and Refugees', Prof. Dr. Kim Eun-Shil (Ewha Womens University) on 'Jeju and the 4.3. Uprising' and Prof. Dr. Paik Won-Dam (Songkunghoe University) on 'East Asia after Globalization and the Aporia of the Islands.' In the regular Special Lectures series of the IKS, lectures were held by Yong Suk Jang (Director of International Exchange Team at Arts Council Korea) on the topic of 'North Korea through the Eyes of its Literature', Dr. Heyryun Koh (Dankook University) on 'Ch'usa Kim Chŏnghŭi', Dr. Jiyeon Park (FU Berlin) on 'Saram i saraganŭn kongganŭro ŭi pukhan sahoe yŏn'gu', Lee Sangwoo (Author) on 'Modern Culture', Prof. Dr. Carey Park (Hongik University) on the 'Mount Paekdu in North Korean Art' and 'A Study on North Korean Art in Africa', Gong Jiyoung (Author) on 'Power and Sacrifice in Literature and Politics', Dr. Young Su Park (FU Berlin) on 'The Mobilization Clinic: The Governmentality of the Korean Developmental State in the Global Health Projects in Ethiopia', Soyeon Schröder-Kim (NRW.Invest) on 'Korean Companies Investing in Germany', Dr. Deok Ryong Yoon (Korea Institute for International Economic Policy) on 'Global Financial Safety Net and Korea's Exchange Rate Policy', Prof. Seung-Wook Baek (Chung-Ang University) on 'Examining remaining questions concerning the March First Movement and its place in Intellectual History in the context of the Discourse on Divisions in East Asia', Prof. Joon-Kyung Kim (Korea Development Institute) on 'Why the Saemaul Undong is so important to Understanding Korea's Social and Economic Transformation', Em. Prof. Chongko Choi (Seoul National University) on 'Pearl S. Buck and Korean Culture', and by Dr. Daniel JW Jeong (Hanhwa Q Cells) on 'Korean Entrepreneurship in Germany - Hanwha Q Cells.'

3. Scholars Reports

Eric J. Ballbach offered courses on North Korea's Political Culture, The Political Systems of North and South Korea (with Hannes B. Mosler), as well as an introductory course on Korean politics and economy for students at FU Berlin. He continued his position as a Visiting Researcher at Stiftung Wissenschaft und Politik (SWP) and published several articles on current affairs within the SWP. During the previous year Dr. Ballbach participated in several informal Track 1.5 initiatives involving high-ranking representatives from the DPRK, e.g. in Sweden, Mongolia, and Madrid. He also provided advisory functions to domestic and international organizations and produced expert opinions on security issues concerning the Korean Peninsula and North East Asia. In this role he also provided numerous interviews for a range of media outlets including NDR, SWR, WDR, FAZ Online, and Deutsche Welle as well as an article (together with Eun-Jeung Lee) in the Frankfurter Allgemeine Zeitung. Some of the topics among the workshops and conferences he actively participated were: The Maintenance of Peace on the Korean Peninsula (2018 International Conference at Kim Il Sung University, Pyongyang), Denuclearization and Peacekeeping on the Korean Peninsula: The Role of Germany and Europe (2018 Korea Global Forum: Berlin Forum on Korea), Comparing the Negotiation Processes between North Korea and the U.S. and between North and South Korea (WIFIS Conference 2018), No Strategy Beyond Sanctions? Assessing the Role of the EU in the Nuclear Issue on the Korean Peninsula (Royal Elcano Institute, Brussels), Suitable Mechanisms for regional security and cooperation in Northeast Asia, (Expert workshop on regional security in Northeast Asia, organized by SIPRI), A Strategy Beyond Sanctions? On the Role of the EU in the Nuclear Conflict on the Korean Peninsula (International conference "How to solve the North Korean nuclear issue: the role of Korean and European actors" Fondation de Recherche Stratégique, Paris).

Holmer Brochlos has continued teaching courses in Korean grammar, language practice, and translation on different levels. He hosted several special lectures with IKS guest authors, for example with Park Chan-soon (박찬순, May 2019) and Chae Gil-soon (채길순, July 2019). He also offered several presentations, for example at the International Academic Conference of Kim Il Sung University, Pyongyang, DPRK (September 26, 2018), and at the BK21-Plus International Conference of Chunnam University in Gwangju (January 17-18, 2019).

Daniela Claus-Kim in the last year expanded on her previous research about youth movements as well as on the Korean diaspora in Europe. She also continued teaching courses on modern Korean culture, gender and social movements, religion and education, and methods of Korean Studies. Furthermore, she oversaw student affairs at the IKS and managed the exchange program between Freie Universität Berlin and several Korean universities.

Martin Gehlmann in 2018/19 worked within the various conceptual study groups of the CRC 980 'Episteme in Motion' and moved into the final phase of his dissertation project on the knowledge transfer between Chinese and Korean Confucian academies. He also continued to teach a course on Hanja and presented his research at the following conferences and

workshops: *Private Academy vs. State School. Dilemmas of Confucian Education* (29th AKSE Conference 2019, Rome), *Songdang Pak Yong and the White Deer Grotto Regulations* (FU-KoreaNet Workshop 2018, Seoul National University), *Paengnoktong kyu chŏnsong* (International Conference on the Development of Science and Human Welfare, Kim II Sung University).

Vladimir Glomb continued his work at the CRC 980 'Episteme in Motion' and was concerned with the research on Authority in Korean Confucianism. As member of the CRC he gave the following lectures: *Tongmong sŏnsŭp (First Exercises for Uneducated Youth)*, (Asymmetries of Knowledge, Berlin), *Houses for Sages. 16th century enshrinement policy and its contradictions* (29th AKSE Conference 2019, Rome), *Some Notes on T'oegye's Notion of the Genealogy of the Way (Daotong)* (27th International Conference on the Confucianism and T'oegye Studies, Vietnam National University, in absentia), *Studies of Confucian Academies in North Korea* (FU-KoreaNet Workshop 2018, Seoul National University), *Ri Ryulgok ŭi sŏwŏn kwan* (International Conference on the Development of Science and Human Welfare, Kim Il Sung University), *Korean Sŏwŏn between Global and Local*, (Chosŏn/han'guk ŭi munhwa, sahoe ŭi simch'ŭng kujo, University of British Columbia).

Eun-Jeung Lee continued her duties as Head of the Institute of Korean Studies at Freie Universität Berlin. In this function she managed the move of the IKS into the facilities. She further taught classes on theories and discourses of Korean Studies, Korean politics and culture from an historical perspective, supervised the Open Research Seminars, etc. She also organized the Winter Special courses that served as preparational classes for the upcoming 5th Korean Studies Summer School with the topic of Jeju. A few of the several presentations given in the last year include Hope for peace in East Asia (Understanding Korea: Past, Present and Future, Helsinki 2018), Frieden und Sicherheit auf der koreanischen Halbinsel (panel discussion by the Rosa-Luxemburg Foundation, 2019) Zwischen Himmel und Universum. Selektion von westlichem Wissen im Korea des 18. Jahrhunderts (7th Annual Conference of the CRC 980 2019, Berlin), Bloß nicht übertreiben - Höflichkeit nach der konfuzianischen Lehre (Long Night of the Sciences at Dahlem Humanities Center, 2019). Eun-Jeung Lee also participated in the 2018 Tumen River Forum, the International Conference on the Development of Science and Human Welfare at Kim II Sung University in September 2018, the Berlin Forum on Korea in October 2018, the FU-KoreaNet Workshop 2018 at Seoul National University, the 17th German-Korean Forum in Daejon, and Tongsö Perüllin kyönghöm üro pon chibang chöngbu ŭi nambuk hyŏmnyŏk pangan mosaek t'oron hoe at the National Assembly Library of Korea in September 2019. She contributed to several media outlets in the last year, such as: "Pukhan sŏ panmi pangmulgwan to kugyŏng mot'age hae" (Yonhap, October 2, 2018), "Pukhan e to Sŏwŏn ŭn saraitta... p'oŭn hwadam yulgok chach wi orosi" (Joongang Sunday, December 1, 2018), "Europa sollte Trumps Nordkorea-Politik unterstützen" (FAZ February 25, 2019, with Eric Ballbach), "Han'guk kwa togil sai rŭl kyot'ong hanŭn munhwa pŏnyŏkka" (brunch.co.kr, April 15, 2019).

Gabriel Dae-In Lux continued the work on his dissertation project on "Narratives of Unification in North Korean Historiography" and worked as a researcher in the IKS at Freie Universität Berlin. His teaching activities include an introductory course to Korean history and an advanced seminar on the concept of nation and nationalism in Korean culture and history. He also wrote an article on the meaning of the islet of Ssuksŏm in North Korean historiography (publication is planned for fall 2019).

Hannes B Mosler in 2018/19 has been teaching courses on the Political System of South Korea, a Research Colloquium for PhD and MA candidates, an Open Research Colloquium for PhD candidates and scholars, on Socio-Scientific Research Methods for BA candidates, Eins@FU Lecture Series "Freedom", and Democracy in South Korea: Ideas, Forms, and Practices. Together with Dr. Eric J. Ballbach he taught the course The Political Systems of North and South Korea. He published the co-edited volume The Quality of Democracy (Palgrave), academic journal articles such as "Translating constitutional norms and ideas: Genesis and change of the German 'Free Democratic Basic Order' in Korea" (Verfassung und Recht in Übersee) and "Regionalwahlen in Südkorea 2018" (ASIEN - The German Journal on Contemporary Asia), and the book review "Scott A. Snyder. South Korea at the Crossroads. Autonomy and Alliance in an Era of Rical Powers. New York: Columbia University Press, 2018. 355 pages" (International Quarterly for Asian Studies). Regarding book chapters, besides the "Introduction" and "Conclusion" of The Quality of Democracy, he also contributed the chapter "Democratic Quality and the rule of law in South Korea: The case of the prosecution" as well as the chapter "Citizenship and migration in South Korea: in the forefront of democracies?" General Information:

In 2018/2019, the Korean Studies Institute of Ruhr-University Bochum (RUB) continued and concluded the AKS Core University Program for Korean Studies project "Transcoding as Cultural and Social Practice", which was jointly conducted alongside the Korean Studies Institute of Free University Berlin (FUB) from September 2014 until August 2019. The concluding conference of this project, titled Korean Intellectuals in-Between - Configuring Knowledge in Periods of Transition, was held successfully at Ruhr University Bochum in June 2019. Active participants included Ilmo Yang (Seoul National University), Vladimir Tikhonov (University of Oslo), and Daeyeol Kim (INALCO). The two Korean Studies institutes of RUB and FUB have continued to collaboratively develop teaching materials (such as workbooks for courses on the history of Korean literature as well as Classical Chinese), exchange lecturers, create and deepen networks within European Korean Studies, finance post-doctoral fellowships, support M.A. students as well as PhD-candidates, and conduct research on transcoding/cultural translation as a core aspect of knowledge circulation. Also, the two Korean Studies Institutes successfully organized a summer-school on the topic of "Thinking Korea through Jeju Island", which was jointly conducted on Cheju Island in August 2019. Additionally, members of RUB Korean Studies have continued close cooperation with the Kaete-Hamburger-Kolleg/CERES "Dynamics in the History of Religions between Asia and Europe".

In 2019, the Korean Studies Institute at RUB continued to intensify teaching and research in the field of literary translation. As a result of a translation seminar offered during

the summer term 2019, a German language translation of the short-story *Danny DeVito* by South Korean author Hwang Jeong Eun, entirely prepared by undergraduate and graduate students of RUB Korean Studies, was presented within the framework of a public reading with the author present in July 2019. The translation will be published in the 2019 fall-issue of *Hefte für Ostasiatische Literatur*.

In the realm of the now well established Bochum Korean Studies Lecture Series, which is being held regularly during the semester, in 2018/2019 the RUB Korean Studies welcomed scholars such as Boudewijn Walraven (Leiden), Cho Haesug (Seoul National University), Sem Vermeersch (Seoul National University), Jiyoon An (Tübingen University), or Henrik Sørensen (CERES). In the upcoming winter term 2019/2020, the Lecture Series will host scholars as such as Burglind Jungmann (UCLA) or the Kayagum artist Kwak Sooeun (Yeungnam University).

With the gradual transfer of Dr. Florian Poelking from the Korean Studies Institute to the Institute for East Asian Politics (POA) of the same faculty, the cooperation between the two is strengthened and thereby reaches a new level. Since two years, students of the BA programme of POA were already eligible to participate in Korean language classes. However, the Institute for East Asian Politics was lacking a position for a specialist on Korea. As qualified Koreanist, Dr. Poelking now is in charge of the Korea-track within the POA BA and MA programme which to date comprised specific foci on China, Taiwan and Japan. Overall, Korean Studies at Bochum therefore now feature both a humanities track and a social science track.

In cooperation with the Embassy of the Republic of Korea (Bonn), RUB Korean Studies organized the preliminary round to determine the German contestant for the popular KBS television show "Quiz on Korea" (venue: LSI Bochum). The "Korea Day 2019", an event aiming to introduce various aspects of Korean culture to a wider public audience, was simultaneously held at the venue. Lecturers of RUB Korean Studies were moreover actively involved in the 2019 Korean Speech Competition in Germany (held at the University of Duisburg-Essen).

The RUB "Korean Studies Film Club", which entails three movie-screenings (contemporary and classic films) per semester, was carried on continuously in 2018/2019, drawing much enthusiasm and support from students of Korean Studies.

Goethe University Frankfurt

General Information

Since 2011, Korean Studies has been one of the main areas of study within the fields of Empirical Linguistics and East Asian Studies, with Korea-related courses having been introduced to Goethe University Frankfurt in 2007. With the generous support of the Korea Foundation, a new professorship was established in December 2014.

Professor Yonson Ahn has been the director of Korean Studies at Frankfurt University since December 2014. During the past academic year, Korean language courses were taught by Soyeon Moon, Dr. Hyuk-Sook Kim, Youngju Shin, and Yeongeun Choi. Tanja Eydam, Marion Wambold, and Mikah Lee joined Korean Studies Frankfurt as doctoral research assistants in the past year. Guest lecturers Dr. Michael Fuhr and Prof. Dr. Heike Hermanns offered block seminars during the winter semester 2018/2019, and Prof. Dr. Dong Ju Kim offered another block seminar during the 2019 summer semester. Vanessa Bähr also joined as administrative staff.

The second round of funding through the Seed Program for Korean Studies from the Academy of Korean Studies and the South Korean Ministry Education has been approved for three years (2018-2021), supporting the institute in conducting a research project entitled "Strengthening the Korean Studies Education Capacity through the Glocalization of Frankfurt Korean Studies". The overall objective of strengthening Korean Studies Frankfurt and its glocalization will be further pursued in addition to research on the topic "Korea and the Global Society: Engagement and Reciprocity".

Frankfurt's Korean Studies library collection continues to grow, thanks not only to our own efforts, but also through generous donations by the Korea Foundation as well as individuals. Prof. Dae Sook Kim, Dr. Eja Na, the Korea Foundation, and the Korea Publication Association, for example, supported us with kind donations from their valuable collections on Korea. These contributions continue to be catalogued by the Korean Studies librarian.

In addition, this year, a promotional video for Korean Studies Frankfurt was produced and uploaded on YouTube (https://youtu.be/AUSJMNwwpxI).

Academic Program

Frankfurt's Korean Studies Department offers several study options: A combined BA degree with the Institute for Empirical Linguistics (as a major or minor), an internal minor programme within a BA Empirical Linguistics, and since the beginning of the 2017/18 academic year, an independent minor programme in Korean Studies. There are presently around 220 students enrolled in Korean Studies as of the 2019 summer semester. In the winter semester of 2018/2019, Korean Studies at Goethe University Frankfurt welcomed nearly 100 new students, making it one of the fastest growing subjects. Currently, the field of Korean Studies at Goethe University Frankfurt is helmed by one full-time professor, three part-time (50%) lecturers/researchers, and two part-time (50%) language lecturers. Korean Studies can now be chosen as a BA program major within Empirical Linguistics with a standard duration of 8 semesters. The number of MA students in the Modern East Asian Studies (MEAS) programme who have chosen Korea as their focus is also increasing each semester, with around 10 students enrolling in Korean Studies seminars as of the 2019 summer semester.

The content courses offered include various aspects of Korean society, culture, politics, and history within an interdisciplinary framework. The variety of these courses enables students to discuss Korea-related issues from a critical perspective and tailor their studies according to their own specific interests. Our students have also had the opportunity to take part in E-school seminars on Korean society and culture by means of the Korea Foundation Global E-School programme.

Students can choose to spend a semester at a partner university in Korea (Korea University, Ewha Women's University, Chungang University, Yonsei University, Sungkyunkwan University, or Sogang University), for which we have also managed to secure sponsorship from Asiana Airlines for an airline ticket scholarship, called the Asiana Flying Scholarship, as well as discounted tickets for our students. Further opportunities to study abroad have been secured through additional memorandums of understanding for exchange programmes with Yonsei, Sungkyunkwan, and Sogang University since 2017.

Project K – The 7th Korean Film Festival, October 26–28, 2018, Cinestar Metropolis, Frankfurt

Originally a project started by Korean Studies students, Project K has developed into a standalone event. 9 different Korean movies were screened over three days. Various Korean cultural experiences were offered during the opening ceremony, and a promotional video for the Korean department at Goethe University was also presented. Around 6,000 people participated in this event. This event was not only an opportunity to promote the Korean Studies department, but also for the students at the department to interact with the public.

The 2nd German UCC Contest for Korean, November 23, 2018, Goethe University Frankfurt

On the 23rd of November 2018, the Korean Studies department at Goethe University held the "2nd German UCC Contest for Korean." The Theme this year was 'The Beauty of Korea.' Participants produced video clips in which they utilized their Korean language skills to talk about their experiences of Korea. This was not only a chance for students of Korean Studies and Korean language learners to apply their language skills and present what they have learned so far, but also a chance for them to introduce Korea, about which they have been learning, in a creative way. The prize for the first and second place winners was a scholarship for a language course held at the language institute at Ewha Womans University in Korea.

8th Conference of Korean Studies in German speaking Countries (VfK), November 30-December 1, 2018, Goethe University Frankfurt

The 8th annual conference of Korean Studies in German speaking countries served as an opportunity for fellow researchers to exchange ideas and network. Around 120 people joined the opening ceremony of the conference, with opening speeches from the dean of Language and Culture Studies Prof. Dr. Thomas Betzwieser, Consul General of the Republic of Korea Mr. Chang-rok Keum, and Prof. Dr. Yonson Ahn, and keynote speech by the prominent scholar Dr. James B. Lewis. Within two days, 47 papers on various research areas were presented at 13 different panels.

Translation workshop: "Das Spray" by Kyung-Uk Kim, April-June 2019, Goethe University Frankfurt

Dr. Hyuk-Sook Kim led this fortnightly literature translation workshop. Students tried their hands at translating a classic of Korean literature, "The Story of Sukhyang", which was translated into modern Korean by Sang-Gu Lee, as well as a related story by Hyeran Cho. The result was the German translations "*Die Geschichte der Sukhyang*" and "*Die bedauernswerte Sukhyang, die ausgesetzt wurde*", both of which are planned to be published in a literary magazine.

<u>Eberhard-Karls-Universität Tübingen</u>, Asien-Orient-Institut, Abteilung für Koreanistik und Center for Korean Studies

General Information

The Center for Korean Studies at the University of Tübingen has initiated four new projects in 2018-19. Firstly, the project "Everyday History in Korean Studies" was launched as a joint project by Prof. You Jae Lee and Prof. JUNG Byung Wook (RIKS, Korea University), and in cooperation with Prof. Itagaki Ryuta (Doshisha University). The project is funded by DAAD and NRF. Secondly, with the Korean-German Comparative History Forum at the Institute for Korean Historical Studies, the Center for Korean Studies initiated a project on the history of German-Korean relations and held its first workshop on July 20-21, 2018 in Tübingen and the second workshop is planned on September 27-28, 2019 in Seoul. Thirdly, the Center for Korean Studies plans to translate and publish an anthology of 100 modern Korean short stories in German. In the spring semester of 2019, two public readings and a translation workshop with author SON Bomi were organized with funding from the LTI Korea. Lastly, the Center arranged its first annual joint graduate workshop in cooperation with the BK21+ program of the Department of Korean History at Korea University in July 2018 in Tübingen and will have the second workshop in September 2019 in Seoul.

Furthermore, the Center for Korean Studies has successfully continued its five-year, "Tübingen Global Korea Project" (TGKP), supported by the AKS Core University Program for Korean Studies Grant (September 2016 to August 2021). It hosted two internal/regional workshops (February 1-2, 2019 and July 5, 2019) and the third international conference ("the Developmental State and Social Conflicts in Cold War Korea," July 12-13, 2019).

The department has also helped strengthening the regional network of Korean Studies programs. For two semesters (WS 2018-19 and SS 2019), Dr. Ji-yoon An served as Acting Professor at Duisburg-Essen University. Prof. Jong-Chol An delivered block seminars in the Korean Studies program at Ca' Foscari University of Venice in March 2019. Prof. Jong-Chol An, Dr. Birgit Geipel and Max Altenhofen provided block seminars for BA and MA students in Korean Studies at the University of Bonn in the spring semester of 2019.

Academic Program

The department currently offers five degree programs, including Bachelor of Korean Studies, Master of Korean Studies, Double Master of Korean European Studies (MAKES), Master of Politics and Society of East Asia (MA PGO), and Doctorate of Philosophy in Korean Studies. In the last two semesters, the department has renewed the BA and MA programs and successfully received accreditation. For this, faculty members visited and consulted with Korean Studies programs and scholars in different countries and surveyed first-semester students at the department. In the new BA program, its unique one-year study in Korea at one of the ten partner universities has become intensified with additional intercultural training modules. The MA program has developed new modules focusing on translation and interpretation and continues the successful dual degree program with Seoul National University. In addition, the department is to introduce the admission quota system in WS 2019-20 in light of the continuous increase in the number of applicants, which saw over 400 students (incl. 114 new BA students majored or minored in Korean Studies) enrolled in the winter semester of 2018-19.

Additionally, a new e-School program with the Department of Political Science and International Relations at Korea University was launched in the spring semester of 2019. The department continues to offer e-School courses with Seoul National University.

The Korean branch of the department, the Tübingen Center for Korean Studies at Korea University (TUCKU) and the King Sejong Institute in Tübingen continue to operate successfully.

Seminars and Lectures

This year three conferences and workshops were organized in the context of the continuing Tübingen Global Korea Project (TGKP): The third international conference of the Tübingen Global Korea Project, "The Developmental State and Social Conflicts in Cold War Korea," July 12-13, 2019, brought scholars from Korea, Japan, the USA, and Germany together to engage in lively discussions on the Cold War and the developmental state. The department also organized 5th and 6th Internal TGKP-Workshops (February 1-2, 2019 and July 5, 2019). The internal workshops are designed as forums to assess individual research progress, to provide constructive feedback for PhD candidates and young researchers and to foster exchanges and relationships with scholars from other universities.

Apart from the TGKP-events, the following conferences, workshops and lectures took place: The LTI Korea Translation Workshop with Author SON Bomi in Calw (June 27-29, 2019); the workshop "Everyday History in Korean Studies" in Tübingen (July 19-20, 2019); the workshop "Korean Law in the World- Focus on Public Law Education" in Seoul with Seoul National University Asia-Pacific Law Institute (July 29, 2019).

From September 2019 onwards, he conducts research in Korea as a graduate fellow at the Academy of Korean Studies.

Dr. **Ji-yoon AN** is currently on leave for Winter Semester 2018 and Summer Semester 2019, as Acting Professor of Social Sciences (with a focus on Korea) at Duisburg-Essen University. During this time, she has published an article entitled "The Lost Children of Korea: Ounie Lecomte's *A Brand New Life* (2009) and Kim So-yong's *Treeless Mountain* (2009)" in *Cross Currents: East Asian History and Culture Review*, no. 29. Another article titled "Mother Thrillers: A Monster or Just Modern?" is forthcoming in *The Journal of Japanese and Korean Cinema*, 11(2). Dr. An also gave the following invited talks: "Monsters in Korean Cinema", University of Copenhagen (September 21, 2018); "The Return of Superman: A Reading of Yeon Sang-ho's *Train to Busan* (2016)", University of Bochum (December 11, 2018); and "Superhero Daddies: Patriarchy Amidst Disaster Blockbusters", University of Hamburg (January 17, 2019).

Jun.-Prof. Dr. **Jong-Chol AN** is a legal historian who is interested in the legal history of Korea, especially the Korean Constitution and the Nationality Law with its historical changes and US legal advisors' activities in Korea. He is currently working on his second book on Modern Korean history, the tentative title for which is *From Continental to Common Law: US Military Occupation, Republic of Korea and Legal Basis, 1945-1950.* Dr. An served as Deputy Director of the Tübingen Global Korea Project (Core University Program for Korean Studies funded by the Academy of Korean Studies) between September 2016 and August 2018. He organized two international conferences: "Korean Constitution Today: 21th Century Challenges to Korean Democracy," University of Tübingen (July 4, 2018); "Third

International Conference of the Tübingen Global Korea Project: The Developmental State and Social Conflicts in Cold War Korea" (AKS Core University Project), University of Tübingen (July 12-13, 2019). Dr. An went to the Ca' Foscari University of Venice as a visiting professor in March, 2019 and taught classes on Modern Korean history and Pre-Modern Korean history. Dr. Birgit GEIPEL continues in her position as a Visiting Assistant Professor with a research focus on contemporary Korean literature. In the academic year of 2018/19 she has taught BA courses on premodern and modern Korean history and modern Korean literature and co-taught MA courses on translating Korean literature. In addition, she has held a MA block-seminar on themes in modern Korean literature at the University of Bonn. She has been in charge of the visiting scholars' program until April 2019 and organized the department lecture series for Summer Semester 2019. In the last year she has given presentations at Internationales Literaturstraße Symposium 2018, Tübingen, at the 8. VfK Conference at Goethe University Frankfurt and at the 10-Year Anniversary of the Asia-Orient-Institute of the University of Tübingen. She has also organized a panel at AKSE Rome, where she presented her research paper "North Meets South: New Imaginative Possibilities and Literary Perspectives in the Twenty-First Century." She has received the Korean Literature Translation Workshop Grant 2019 and organized two public readings with the author SON Bomi in Tübingen and Stuttgart on June 25 and 26, as well as a Translation Workshop together with Prof. Dr. You Jae Lee at Hotel Kloster Hirsau-Calw on June 27-29, 2019. Additionally, she is participating in the departmental research project "The Concept of Everyday in Korean Studies - Transnational Encounters between Germany and Korea" (funded by the DAAD GEnKO-Program).

Dr. Unsuk HAN is the Managing Director of the Tübingen Center for Korean Studies at Korea University (TUCKU). He published "Chaedok han'guk yŏsŏng moimeŭi han'guk minjuhwa undonggwa t'ongil undong [The Korean Women's Group in Germany and Their Work on Korea's Democratization and Unification]" in *K'orian tiasŭp'orawa ilbon sosuja munje [Korean Diaspora and Minority Issues in Japan]*, Jeju National University, Center for Zainichi Jeju People, 4 (2019). Dr. Han also translated Reinhart Koselleck's Book on Revolution in Korean. He gave several lectures in the past year, including: "Learning from the Unification of Germany" at Chonbuk National University (November 9, 2018); "Rezeption der deutschen Wiedervereinigung durch die südkoreanischen Wissenschaftler" at Heidelberg University (January 30, 2019); two lectures on German society and culture for journalists specialized in North Korea and unification (May 28 and June 3, 2019).

Dr. **Taejin HWANG** departed Tübingen in the spring of 2019 to join the Department of History at Kyungpook National University as Assistant Professor.

Isabella JUKAS is a research associate and PhD candidate at Tübingen University. Her dissertation project deals with the topic of North Korean foreign relations, focusing on connections with the Global South. She co-authored an introductory textbook on hanja that was published at Helmut Buske Verlag in June 2019 (title: *Einführung Hanja*). In addition, she co-organized an international conference on the history of German-Korean Relations, *Geschichte der Deutsch-Koreanischen Beziehungen* (July 20-21, 2018), and the Fifth Research Workshop as part of the AKS Tübingen Global Korea Project (February 1-2, 2019). Besides teaching classes on North Korean society and on Chinese characters in Korean, she has been in charge of the department website and social media. Ms. Jukas is conducting research in Korea with the funding of the Kyujanggak Institute for Korean Studies at Seoul National University as a Kyujanggak Junior Fellow as of April 2019.

Dr. Hojve KANG is working as a Visiting Assistant Professor with a research focus on Science-Technology and Policy in North Korea. In the academic year of 2018/19 he has taught MA courses on the history of North Korea and academic writing. In addition, he has taught BA courses on North Korea and computer skills for Korean Studies students. He has also organized "Conversion of North Korean Science-Technology and Startup" with AJOU Institution of Unification (14th December, 2019) and "Karrierewege für Koreanisten-2019" for Korean Studies students (16th January, 2019). He has published articles entitled "The Basic Principle for Exchange Cooperation Between South and North Korea", National Reconciliation (vol.97) (2019), pp. 44-47, "North Korea Could Not Be Testbed", The Hankyoreh (20th February, 2019), "North Korea Could Not Be Testbed - Counterargument to North Korea as Smartcity", Tongilnews (26th February, 2019), "Changing of Innovation Focus: From Small Part To Whole System", Tongilnews (11th February, 2019). Dr. **Euna KIM** has continued teaching Korean language courses. On 25th May 2019, she was invited to present on "Bilingual Education in Han'gŭl Hakkyo" at the International School Stuttgart. This seminar was hosted by the southern Germany Han'gŭl Hakkyo Association and the audience were Korean language teachers from 13 schools located in the south of Germany. On 18th and 19th July 2019, she participated in the 11th Annual Conference of *the International Society of Korean Applied Linguistics*, held at the Institute of Korean Cultural Center, Berlin. At this conference, she presented a paper entitled "A Study on Korean Learning Styles and Preference for Classroom Activities of German Korean Learners".

Jee-Un KIM continues her dissertation project on the rise of copyrights, piracy and the popular music industry in the digital age in South Korea. She participated at the Korean Studies Graduate Students Convention (KSGSC) from Sep. 27-29, 2018 in Rome with a presentation titled *"Regulating and Controlling Music. The Transformation of Copyright Law in South Korea"*. Kim is a board member of the KSGSC organization committee.

The Hanja textbook is designed for adult learners and includes an introduction to the study of Hanja, 225 characters with related vocabulary and numerous exercises. Currently he is working on a source book for Modern Korea together with Prof. You Jae Lee. Besides teaching courses, he remodeled the curricula for the Korean Studies Bachelor and Master programs and was responsible for the process of evaluation and accreditation of the programs. In addition, he is in charge of the Korean Studies Library and the preparation for the planned library merger with the Institutes of Asian and Oriental Studies.

Dr. **Moon-Ey SONG** has continued teaching Korean language courses. Together with Dr. Euna Kim, Dr. Song completed writing and reviewing "the Korean Grammar Textbook for German Students", which is expected to be published in 2020-2021 with the support of AKS. Currently, she is preparing for the translation and publication of the book.

Jun.-Prof. Dr. **Jerôme DE WIT** was chosen as the new vice-president of the Association of Korean Studies in the German-speaking Area (Verein für Koreaforschung in Deutschsprachigen Raum (VfK)) in November 2018. <u>The University of Sheffield</u> School of East Asian Studies

Academic Programme:

As in recent years, the numbers of students doing a four-year degree programme (Single Honours or Dual Honours with other subjects) has continued to increase, as has the number of students doing modules on Korean Studies, or modules with Korean content. The number of entering students to do a four-year Single Honours or Dual Honours degree in Korean Studies for the session 2019/2020 was 59 students.

In 2019, the School of East Asian Studies celebrated forty years since the start of teaching about Korea. In 1979, Korean language was taught as an integral part of the dual honours degree in Japanese Studies and Linguistics. The first Korean lecturer was appointed in 1980, and the first four-year degree in Korean Studies (with an intensive language year abroad in Korea) was offered in 1994. The forty years of Korean Studies was celebrated by a year-long seminar series. Presentations included: 15 February - 'East Asian Cinema: From Colonialism

to Fandom' by Prof. Moonim Baek of Yonsei University and Prof. Hwajin Lee of Inha University; 21 February – 'The Korean War and East Asia through the Prism of the Interrogation Room' by Prof. Monica Kim of New York University; 18 September – 'The Issues Facing Korean Studies: A Panel Discussion' with Professor Suk-Yong Kim - Head of Performance Studies at the University of California at Los Angeles , Professor Laurel Kendall – Chair of the Division of Anthropology at the American Museum of Natural History in New York, and Dr. James E. Hoare formerly of the Foreign and Commonwealth Office of the United Kingdom; and 'North Korea: A Cultural Psychology' by Prof Hyang-Jin Jung. The Senior Language Tutor Cho Sukyeon arranged for Kim Jinsik, a renowned carving artist, to create two *changsŭng* (tutelary guardian poles). These have been placed in a prominent place on the campus as a permanent commemoration of the fortieth anniversary.

Scholars' Reports:

Dr. Markus Bell, Lecturer in Korean Studies, reported that he taught the module 'Ghosts, Conflict, and the Race to Modernity: An Ethnographic View of the Two Koreas' for taught post-graduate students and 'Understanding Contemporary Korea: Violence, Reconciliation and Modernity', and 'Understanding North Korea'. He also instructed 'Advanced Korean Translation: Year 2' and 'Advanced Korean Translation: Year 3. He gave the following special lectures: February 2018, 'Memories of Exodus to North Korea, 1959-1984' for the Japan Society in London; March, 2018 'Why nuclear war with North Korea is not imminent and other common myths explained,' for the Royal Geographic Society Speaker Series, London; June, 2018 'North Korea's Nuclear Attack, the Bloody Nose Strike, and the Failure of Economic Sanctions' at the Oxford University Geographic Society; June, 2018 'Contemporary Security Concerns and North Korea' as a talk to members of Her Majesty's Forces, Leeds; August, 2018'The Politics of Public Discourse: Conditional Inclusion and c Celebrity North Korean Defectors' at the European Association of Social Anthropologists conference, Stockholm; April, 2019 'Contemporary Migration in East Asia: New Migration Flows, New Challenges' at the Charles University, Czech Republic; April, 2019 "Refuge and Migration in Contemporary East Asia: Belonging, Mobility, Identity' at Palacký University Olomouc, Czech Republic. He also reviewed manuscripts for North Korean Review, Asian Studies Review, The Pacific Review, The Asia Pacific Journal of Anthropology, and European Journal of Korean Studies.

Dr. Hyun Kyong Hannah Chang, Lecturer in Korean Studies, joined the staff of the School of East Asian Studies from September, 2019. In the autumn term, she will be teaching a postgraduate module called 'Media, Culture, and Society in East Asia'. In the Spring of 2019, she taught two modules at New York University, where she was a Visiting Assistant Professor, entitled 'K-pop' and 'Global Musicologies'. She gave a paper 'A Dissident in Exile or an Eminent Composer ? The Politics of Performing Isang Yun in South Korea' at the Annual Meeting of the Association for Asian Studies held in Philadelphia, Pennsylvania from 22-25 March, 2018. On 8 December of 2018, she gave an invited paper 'Trans-Pacific Listening: Boat Songs, Audible Prayers, and North American Missionaries in Early-Twentieth Century Korea' at the conference 'Acoustics of Empire, Sound, Media & Power in the Long 19th Century' at the University of Cambridge. She also organised the conference panel 'Music Among Allies: Korean-German Connections in the Making of Contemporary Art Music' for the 2018 Annual meeting of the Association for Asian Studies.

Dr. Chang says that her research bridges the gap between musicology and East Asian studies, and between the history of everyday practices and large-scale processes. In her research, she considers nineteenth- and twentieth-century Korea within the intertwined histories of the U.S., Japan, and Korea, paying attention to the aspects of musical diffusion that intersect with the history of empires and the formations of new selfhoods. She is writing a book which draws on English, Korean, and Japanese archives pertaining to vocal practices which came out of North American missionisation in the early twentieth-century Korea, such as hymn singing and confessional prayers. The book is to be titled *A Vocal Interior: Korean Hymns and Prayers between US and Japanese Empires*.

Mrs. Sukyeon Cho, Senior Korean Language Tutor, reports that the School of East Asian Studies the new Level 1 Curriculum successfully. This was a major change which required a complete re-designing of the Level 1 Korean Language programme, making it even stronger than before. As part of 40th Anniversary of the teaching of Korean Studies at The University of Sheffield, Mrs. Cho I invited an artist who carves *changsung* poles representing Korean village tutelary guardian to carve two totem poles which have become a nice art feature on the Sheffield campus. With Professor Youngmin Park of Korea National University of Education, she conducted research on 'Characteristics of Korean Language Writing by Students at the University of Sheffield'. This project involved analysing Level 2 and 3 (years 3 and 4 respectively) students' compositions which they wrote as part of their assessment in order to understand how these students actively use Korean in their writing. She says that this research helped her to understand the characteristics of their writing and thus to help the Korean language staff in teaching to suit the needs of students. This research was published in a Korean journal in 2018. She also made a presentation at an international conference at Chonnam National University, Korea in January 2019 at their invitation. This research paper was entitled 'The Present Situation and Tasks of Korean Language Education at the University of Sheffield' and was published in a Korean journal in March 2019.

Dr. Deokhyo Choi, Lecturer in Korean Studies, reported that he had taught two modules in the past academic session, 'Two Koreas and Their Neighbours' for final year (fourth-year) students, and 'Understanding Korea 2' for first-year students. On 12 November, 2018, he gave a paper 'The Empire's Contentious Homecomings: The Dissolution of the Japanese Empire and Reciprocal Return Migrations of the Japanese in Korea and Koreans in Japan' at the International History of East Asia Seminar of the University of Oxford. On 20 March, 2019, Dr. Choi presented at paper 'The U.S. Occupation of Japan and the Korean Minority Question' as an invited speaker at the Centre for Japanese Studies Seminar Series of the University of East Anglia. General information

Since its establishment in 1987 with the kind support of the Korea Research Foundation, and subsequently the Korea Foundation, SOAS Centre of Korean Studies (CKS) has been the leading academic centre of its kind in Great Britain. It coordinates work done on Korea in various departments of the School, and offers expert knowledge and advice on Korea to interested outside parties. In 2018/19 20 academics, including full-time SOAS academic staff as well as professorial research associates, research associates, research fellows and post-doctoral fellows were linked to the Centre. In addition, it hosted a number of visiting scholars from South Korean academic institutions and government ministries. During the academic year 2018/19 the Centre was chaired Dr Grace Koh followed by Dr Charlotte Horlyck. Dr Anders Karlsson has taken over as chair from 1 September 2019.

In 2016/17 CKS initiated and organized more than 20 events, including seminars, workshops, panel discussions, film screenings and artists' talks. Some were co-hosted with other institutions and centres.
