- **1. General Information**: You may include basic information about your department or program, such as the names of main faculty members, assistant instructors, and visiting scholars.
- **2. Academic Program:** You may include here reports on the academic programme of study at a university or other academic institution, including reports on new developments in the programme of study, the number of students pursuing a particular degree course, numbers of graduates, or any other information relating to the academic programme of Korean Studies during the past year.
- **3. Seminars and Lectures**: You may provide a list of seminars and lectures on Korea at your university during the past year. For each event, please give the date (in the format month-day-year), title of the talk, and the event and venue.
- **4. Other Activities:** Activities relating to Korean Studies which took place in your institution or country during the past year. Reports of cultural events and radio and TV programmes on Korea should be included here.
- **5. Scholars' Reports:** You may include any papers presented, research undertaken or contemplated, performances presented, conferences attended, or any other scholarly activity related to Korean Studies. Publications, however, should NOT be included here, but under category 6. Please note that a separate paragraph should be written for each person for whom information is provided. For talks and paper presentations, the format should be: date (month-day-year), title of the paper, name of the event, and name of the venue.
- **6. Publications:** You may include here you own publications or the publications of anyone else in your country which may be of serious interest to scholars of Korean Studies. You should NOT list any publications that are due to be published in the following academic year. As a model, see the format used under entries for any university.
- **7. Announcements**: You may include here announcements on any events pertaining to the academic study of Korea.

**PLEASE NOTE: Romanisation** of Korean words and terms can be done according to either the **Revised Romanization System** or the **McCune-Reischauer System** unless the **Yale System** is used for linguistic purposes or a conventional spelling of a name is used. **Spelling** of English words should follow **American** conventions. Please do not use *Hangeul* or Chinese characters and do not use superscript text since it will appear too small to be easily readable.

Information should be provided as either an email attachment or on a diskette.

Any materials MUST be in MSWord.

Materials to be included must reach the Editor by 31 JULY 2017 at the latest.

As I am writing in late October 2016, we are preparing for the 28th biennial AKSE Conference to be held in Prague from 20 to 23 April 2017, under the able guidance of our colleagues, Associate Prof. Dr. Miriam Löwensteinová and Mr. Marek Zemánek of Charles University. The organisers received over 600 individual paper proposals and distributed these to a wide variety of reviewers to select 160. The large number of submissions indicates the importance of our biennial Conference, and now we are spoiled with too many riches from which we must choose. The AKSE Council will gather in Prague in mid-November to finalise the selection of papers and applicants will be notified shortly thereafter. At that time, we will also notify the membership with details about the hotel, which is located close to the old city, and any necessary booking information. Our panels will be held in the hotel and the opening ceremony will be held in the grand halls of Charles University, founded in 1348, at the same time as the last years of Mongol rule over Koryŏ.

The European Programme for the Exchange of Lecturers (EPEL) is again being sponsored by the Korea Foundation, to which we have sent in this past academic year's report with an application for the coming two years. Thank you for your reports for the past year, and we should thank our Treasurer, Dr. Koen De Ceuster, for his tireless efforts in making all the financial arrangements work and for providing detailed reports. In disseminating information to the members, we try to select important notices from the global Korean Studies mailing list, but we cannot monitor your institutional websites for announcements, so if there are any announcements of scholarships, post-doctoral positions, and academic teaching or research posts that you wish to direct to our community, please direct these notices to Dr. Giuseppina De Nicola for posting to the AKSE website. Finally, I would like to thank Prof. Vladimir Tikhonov for ably producing this Volume 40 of the AKSE Newsletter. Your institution reports are important as a way to keep up with each other, look for interesting research activities by colleagues, and to offer a historical record for the future. Please continue to submit your annual reports in the summer for fall publication.

I look forward to seeing many of you at the next conference in Prague if not beforehand.

#### Please observe the following:

- 1) Submit your next report according to instructions given below. The format of your submission should follow the style in the entry for your country and university. Please do not submit the same reports that you used for AKS or the Korea Foundation since they ask for items that are not usually included in AKSE newsletters.
- 2) As AKSE is becoming more globalized and interacts more with scholars in both America and Korea, there is more pressure to adopt American spellings of English. For future issues, American spelling conventions will be preferred.
- 3) For now, either of the two main romanization systems is acceptable McCune-Reischauer or Revised Romanization. As in the past, the Yale System can be used for linguistic purposes, and a non-standard Romanisation is acceptable if used in a title or if it is the preferred spelling of a person's name, such as Syngman Rhee.
- 4) Please do not submit any text in Korean or Chinese characters, and please use standard English forms of punctuation, especially with quotation marks. I advise NOT to include any hyperlinks as they make the text difficult to edit.

Please organise the information into the following categories:

- **1. General Information**: You may include basic information about your department or program, such as the names of main faculty members, assistant instructors, and visiting scholars.
- **2. during the past year.

- **3. Seminars and Lectures**: You may provide a list of seminars and lectures on Korea at your university during the past year. For each event, please give the date (in the format month-day-year), title of the talk, and the event and venue.
- **4. Other Activities:** Activities relating to Korean Studies which took place in your institution or country during the past year. Reports of cultural events and radio and TV programmes on Korea should be included here.
- **5. Scholars' Reports:** You may include any papers presented, research undertaken or contemplated, performances presented, conferences attended, or any other scholarly activity related to Korean Studies. Publications, however, should NOT be included here, but under category 6. Please note that a separate paragraph should be written for each person for whom information is provided. For talks and paper presentations, the format should be: date (month-day-year), title of the paper, name of the event, and name of the venue.
- **6. Publications:** You may include here you own publications or the publications of anyone else in your country which may be of serious interest to scholars of Korean Studies. # CONSTITUTION OF THE ASSOCIATION FOR KOREAN STUDIES IN EUROPE (as amended 2009)

#### **NAME**

**1.** The name of the Association shall be 'The Association for Korean Studies in Europe' (AKSE).

#### **OBJECTS**

- **2.** The Association shall be non-political and its objects shall be:
  - to stimulate and to co-ordinate academic Korean Studies in all countries of Europe;
  - to contribute to the spread of knowledge of Korea among a wider public.

The objects of the Association shall be attained:

- by organizing academic conferences on Korea;
- by issuing a newsletter;
- by encouraging and facilitating co-operation with other organizations having aims consistent with its own objects.

#### **MEMBERSHIP**

**3.** The Association shall consist of Full Members in the categories of Ordinary Members and Honorary Members, and of Associate Members in the categories of Individual Associate Members and Corporate Associate Members.

Ordinary Membership is open to persons permanently resident in Europe with a serious academic interest in Korea. Individual Associate Membership is open to persons not permanently resident in Europe. Applications and proposals for Membership are to be addressed to any member of the Council and decided upon by the Council of the Association.

**4.** Members shall pay an annual fee to be determined by the Council.

Members may be exempted partially or totally from payment of the fee upon decision of the Council. Payment of the fee shall be due on Jan First of each year.

- **5.** Membership shall expire:
  - when a Member resigns from the Association by notifying the Secretary in writing;
  - when the Membership fee has not been paid within six months of the due date;
  - when a Member is expelled from the Association by the Council for having acted in a manner detrimental to the interests or the good name of the Association.

Expulsion shall require the consent of not less than four members of the Council. Before a decision on expulsion is taken, the Secretary of the Association will write to the Member in question, stating the nature of the alleged offence, together with the name(s) of the informant(s) or source(s) of information, and allowing a reasonable time for an explanation.

**6.** Regular Membership Meetings will be held during academic conferences or when called by the Council.

The Council shall call an Extraordinary Membership Meeting upon the request of one-third of the Full Members of the Association. Notice of any business to be transacted at a Membership Meeting shall be given in writing to the Secretary, who shall prepare the agenda of the meeting.

One-third of the Full Members of the Association shall form a quorum for any Membership Meeting, and only Full Members shall have voting rights at any Membership Meeting.

#### **COUNCIL**

7. The affairs of the Association will be managed by the Council. Should the Council need to deal with any matter not explicitly provided for in this Constitution, it shall do its best to consult all Members before making any decision, and in any event submit its decision to all Members at the earliest possible opportunity.

- **8.** The Council of the Association shall consist of:
  - a President;
  - a Vice-President;
  - a Secretary;
  - a Treasurer;
  - a Councillor for Public Relations;
  - a Councillor for Membership Affairs; and

two (2) other persons.

The members of the Council must be Full Members of the Association, and shall be elected at Membership Meetings. Members of the Council shall be expected to serve normally for a period of four years.

If a motion of no confidence in any Member of the Council is supported by four (4) Members of the Council, that Member shall be dismissed from the Council and from any office which he or she holds in the Association.

Notice of any business to be transacted at a Membership Meeting shall be given in writing to the Secretary, who shall prepare the agenda of the meeting.

Vacancies on the Council arising between Membership Meetings shall be filled by co-option or by transfer of duties within the Council. Members shall be notified of any such changes.

Four (4) members of the Council shall form a quorum for Council meetings. The Treasurer is to render audited annual accounts of the finances of the Association.

#### **AMENDMENTS**

**9.** This Constitution can be amended at Membership Meetings.

Amendments shall be notified to all Members at least six months before the Membership Meeting. An amendment shall require not less than two-thirds of the votes of Full Members present at a properly constituted Membership Meeting.

The European Programme for the Exchange of Lecturers is sponsored by the Korea Foundation. Every year, AKSE accepts applications from universities to invite scholars from other institutions to give lectures in their classes. This program also offers excellent opportunities for AKSE members to meet and exchange ideas concerning both research and teaching.

# (2.) Korea Foundation Fellowships for European Graduate Students

AKSE recommends members for the screening committee to be appointed by the Korea Foundation. Final decisions are made by the Korea Foundation.

#### **AUSTRIA**

Wien

<u>Universität Wien</u> Department of East Asian Studies

#### Scholars' Reports:

Mag. Dr. Andreas Schirmer has continued to coordinate the CEEPUS-network Korean Studies in Central and Eastern Europe that he initiated in 2011. Going into its seventh year, the network now comprises 11 participating partner units from Central and Eastern Europe, as two new partners could be included, Poznan and Olomouc (in addition to Bratislava, Bucharest, Budapest, Cluj-Napoca, Ljubljana, Prague, Sofia, Vienna, and Warsaw). From the 52 mobility months assigned to the network for the 2015/2016 term he used two himself, teaching at Charles University in Prague ("Language comparison between Korean and English on the basis of translations", April 26–28, 2016) and at the University of Warsaw ("Definitions of Korean identity: what is Koreanness? Keywords and shifting discourses", May 31 –June 3, 2016). Until August 2016 he was employed at the Department of East Asian Studies with funding from the AKS OLUKS grant that the University of Vienna enjoyed from 2011 to 2016. He is currently involved in the SEED-program of Korean Studies at Babeş-Bolyai University, Cluj-Napoca, as a visiting expert and held a course ("Translating Korean literature") there from January 4–8, 2016. In 2015 he organized two workshops at the Department of East Asian Studies: "Fiction and poetry vs. reality and truth: Contesting Korean literature's place within Korean Studies" (with presentations by Antonetta Bruno, Anders Karlsson, Grace Koh, Miriam Löwensteinová, Ekaterina Pokholkova, Andreas Schirmer, Jerôme de Wit; supported by the AKS), June 13, 2015, and "Literaturübersetzung und Sprachvergleich" (Literary translation and language comparison) (with Holmer Brochlos, Stefan Knoob, Christian Lewarth, Samuel Melzner, Andreas Schirmer, Hoo Nam Seelmann, Barbara Wall, Dennis Würthner, Hanju Yang, Sun-Young Yun; supported by the Korea Literature Translation Institute), December 21–22, 2015. A proceedings volume was produced for the KLTI after the conference, containing the papers and abridged transcripts of the discussion. Schirmer presented the following papers at international conferences and workshops: "Antipolitical poetry: Kim Soo-Young's contradictions to trivial common sense", at the workshop "Fiction and poetry vs. reality and truth," University of Vienna, June 13, 2015; "Translation wars in Korea: The case of modern Korean renderings of hanmun in the context of adjacent discourses and debates" at the AKSE Conference 2015, Ruhr-Universität Bochum, July 13, 2015; "Korean images of Central Europe in the 1930s: Han Hung-su, To Yu-ho and Kim Chae-won" at the Fourteenth Conference Central and Eastern European Society of Koreanology (CEESOK), Moscow State Linguistic University, October 30, 2015; "Korean Students in Europe related to Oka Masao: Direct and Indirect Connections", at the International Symposium on Origins of Oka Masao's Anthropological Scholarship, Meiji University, Tokyo, November 27, 2015; "Warum es sich lohnt, beim Übersetzen die Mitteilungsreihenfolge zu beachten" (Why it pays off for a translator to care about the sequence of information) at the workshop "Literaturübersetzung und Sprachvergleich," University of Vienna, December 21, 2015; "Kojŏn kugyŏk e taehan tamnon kwa nonjaeng" (Discourses and debates about modern Korean renderings of hanmun), at the research seminar of the Tongbang Munhak Pigyŏ Yŏn'guhoe (Research Society for the Comparative Study of East Asian Literatures), Tenri University, Japan, February 17, 2016; "The concept of a reading tutor for advanced learners of Korean" at the Sixth EAKLE Workshop, University of Copenhagen, April 15, 2016;

"Translation as a guiding principle when writing a new textbook for learners of Korean" at the Fourth Korean International Symposium, University of Ljubljana, May 6, 2016. Recently he has completed his German translation of Park Min-gyu's influential collection of short stories *K'asŭt'era* [Castella] (with support from the KLTI). Schirmer's current research mostly relates to translation studies (issues that surface in the process of the translation of Korean literature but also the role of translation wars in contemporary South-Korea), to contemporary Korean literature (the question of literary representation as a source of knowledge about social conditions), and to some marginalized issues of colonial modernity (texts written by Korean travelers and longer-term overseas sojourners about their stays and experiences in European countries during the first half of the past century).

#### General Information:

The team of the Department consists of three full-time assistant professors - Vladimír GLOMB (in March 2016 he left CU for FU Berlin, but continues his activities as an external researcher), Tomáš HORÁK and Marek ZEMÁNEK (replaced Vladimír GLOMB in a position of the vicedirector of the CUPKS project) together with Korean lecturer CHÔNG Younwoo. The team is headed by Prof. Miriam LÖWENSTEINOVÁ. Due to AKS CUPKS funding we were able to significantly expand our teaching positions for Vladislava MAZANÁ, Blanka FERKLOVÁ or Štěpánka HORÁKOVÁ trying to build slowly the broader and better Korean Studies. The Department of Korean Studies is organizing the AKSE 2017 conference which is one the biggest academic events in Korean Studies. In March, 2016 Center of Korean Studies has been established with Jolana BLAŽIČKOVÁ as a secretary and contact person. During past five years, the activities of department, numbers of students, the library stocks, public lectures and participation in cultural events, and above all, the research output, increased in hundreds of percent.

# Scholars' Reports:

Miriam Löwensteinová (PhDr., Ph.D) has coordinated the AKS project and taught various new courses (*Methodology of Study of Korean Literature, Theory and Praxis of Korean Novel*) both at home and abroad (Vienna, Slovakia, London etc.). She is working on her project of translation and interpretation of Im Pang's *Cheonyerok*. She has attended following conferences: "Cesta, Cesty, Putování" (Way, paths, wandering), Prague, June 24, 2016, Charles University; The Third International Conference of Association of Korean Language Education Research, Prague, June 23-24, 2016, Charles University; She (co-)presented the following papers: "Translation of the *Samguk yusa* into Czech" for the conference "Pre-Modern Korean Studies in Europe: Results, Projects, and Prospects", Paris, January 20-22, 2016; "CORE Project Performance in Prague. Tasks and Results" for the conference "Global Korean Studies", University of Turku, Finland, February 25-26, 2016. She was awarded (with Vladimír Glomb) an excellent publication prize for their book *Korean religions*.

**Chong Younwoo** (lecturer) taught several language courses and continued her linguistic research and continues in her Ph.D. studies.

**Blanka Ferklová** taught – besides her duties at Sejong Institute – and has published an electronic version of her *Korean – Czech Dictionary of Onomatopoiea* (available at <a href="http://korea.ff.cuni.cz/slovnik">http://korea.ff.cuni.cz/slovnik</a> onomatopoii).

Vladimir Glomb continues his reseach on Korean Confucianism. He spent his leave at the University of Bochum and FU Berlin. As a team member he is taking part in the international project on the textbook of Classical/Medieval Korean Language and the international project on Kim Si-sŭp. From fall 2015 to spring 2016 he taught new courses *Hanmun grammar* and *Hanmun texts*. # <u>Palacký University Olomouc</u> Department of Asian Studies

#### Academic Program:

For five years before September 2015, Korean language was taught at the Department of Asian Studies at Palacký University Olomouc as an elective subject, mainly for students majoring in Chinese and Japanese. In September 2015, however, Korejština (Korean) was established as the third full-fledged Asian language program offered at Palacký University and the new BA-program has joined the ranks of the very well established majors in Chinese and Japanese studies at Olomouc. Students of Korean studies in Olomouc combine intensive training in the language, plus courses on Korean culture, history and society, with a variety of practical courses in general and economic studies. Currently, the program is limited to BA, but the aim is to expand eventually to a graduate program. 28 highly motivated students formed the cohort of the first year, and for 2016/2017 around 90 applicants from all over the country as well as from Slovakia competed to fill 30 places. Palacký University Olomouc is obviously very efficient in promoting the new program to high school students all over the country. Teaching is shouldered by two assistant professors (Korea Foundation visiting professor Myung CHEGAL, PhD, who came in September 2015 from Keimyung University Korean Language Institute and fortunately extended her contract to stay at least until 2017; and Dr. Andreas SCHIRMER) and two lecturers (Youngran KWAK, BA; Martin **STURDIK**, MA). The establishment of partnerships with universities in Korea is pursued very actively. Other efforts in a similar vein are collaborative networks with the strong Korean businesses in the region. Since 2016 the program is a participating partner unit of the CEEPUS-network Korean Studies in Central and Eastern Europe, claiming its share in a busy exchange of teachers and students among eleven participating institutions. Two professors (Codruta Sintionean from Cluj-Napoca and Pawel Kida from Poznan) are thus already scheduled to teach one course each at Olomouc, financed by the Central European Exchange Program for University Studies.

# **The University of Copenhagen**

#### General information:

The University of Copenhagen Korean Studies Unit is a part of the Department of Cross-Cultural and Regional Studies and the core faculty are: Dr Andrew David Jackson (Korean Studies), Ms Karin Jakobssen (Korean language instruction) and Ms Hyun-joo Choi (Korean language instruction). In addition, the Korean Studies Unit has affiliated members who work closely on Korean related events Dr Martin Petersen (National Museum of Denmark) and Dr Jacob Ki Nielsen (Research Assistant, Department of Public Health).

Each year the Unit holds a regular Korean Studies seminar series. These seminars are open to the Korean community in Copenhagen and are also an essential part of the Korean studies instruction at the University. This academic year (2015-16) the Korean Studies Unit held six lectures, four of which were organized under the EPEL programme.

#### Seminars and lectures

On October 29, 2015 Dr Sixiang Wang of the University of Pennsylvania gave a presentation entitled "Spurned Courtesans, Returned Gifts and Invented Pavilions: Convention, Reputaion and Mythmaking in Chosŏn-Ming Relations, 1400–1633." On February 24, 2016, Dr Udo Monig of the Department of Taekwondo, Youngsan University, Pusan, South Korea, presented a paper entitled "The Invention of Teakwondo Tradition". On March 4, 2016, Jane Jin Kaisen, from the University of Copenhagen gave a paper entitled "Cheju Uprising: Dissident Translations", and on March 11, 2016, Dr Codruta Cuc, from BABEŞ-BOLYAI University, Cluj-Napoca, Romania presented her paper "Heritage Practices during the Park Chung Hee Era: An enduring legacy". On April 29, 2016 Dr You-Kyung Ju from SOAS gave a paper titled "Linguistic Representation of the Sewol Ferry Disaster- A Corpus-based Analysis of Headlines from Two Korean Newspapers." Finally on May 2, 2016, Dr Albert Park, Clermont McKenna Colleage, California presented a paper based on his recent book called "Desiring Denmark: Danish Living in the Social Imagination of Koreans during Colonial Korea."

#### Other activities

In addition to the aforementioned seminars, we have held two large scale events. The first was a one-day workshop on the April 9, 2016 entitled 'Understanding the Other Korea: North Korea.' The workshop featured seven speakers from the UK, Denmark, South Korea and Germany and the line- up was as follows: "Current Russian and DPRK relations" (Flemming Splidsboel Hansen, Danish Institute for International Studies), "Making sense of PRC-DPRK relations in a changing East Asian security context" (Camilla T.N.Sørensen, Department of Political Science, University of Copenhagen), "Prospects for Violent insurrection in the DPRK: Victor Cha and Theoretical Approaches" (Andrew David Jackson, University of Copenhagen), "North Korea: Markets and Military Rule" (Hazel Smith,

University of Central Lancashire, UK), "Missiles, Nuclear Weapons and Regional Security" (Young Sam Ma, The Embassy of the Republic of Korea to Denmark), "Why engage North Korea?" (James Hoare, SOAS/Charham House), "North Korea and the World festival of youth and students in 1989" (Sonja Häussler, University of Stockholm, Sweden). Over seventy people were in attendance and the event was well-attended and reported in the local press. On April 14 and 15, 2016, Korean Studies at the University of Copenhagen held the 6th EAKLE (European Association for Korean Language Education) Workshop, which brought together 62 Korean language teachers from 25 countries, and 40 presentations on Korean language teaching and learning.

In addition to these events, students at Korean studies held a fortnightly Korean film evening and on October 30, in collaboration with the Embassy of the Republic of Korea to Denmark the Korean studies at University of Copenhagen held the 2015 Korean Speech Contest for non-native Korean speakers in Denmark.

The Department of World Cultures invites applications for the position of ASSISTANT PROFESSOR (tenure track) in Korean studies for an appointment as of August 1, 2017.

The professor of Korean studies will be employed in the discipline of East Asian studies within the Asian studies programme. The professor's field of teaching has not been further specified. The Asian studies programme represents multidisciplinary oriented disciplines that explore the languages, history, cultures and societies of Asian countries, in this case Korea. Key features include solid regional expertise, multidisciplinary activities, relevant language skills and high-quality research. The study programme encompasses the disciplines of Asian studies (BA), East Asian studies (MA), South Asian studies, Indo-European studies and Altaic studies. East Asian studies include not only Korean studies, but also Chinese studies as well as Japanese language and culture.

The assistant professor will carry out and supervise research work, provide research-based education on Korean history, culture and society (including politics and the economy), follow developments in research, and participate in societal interaction and international cooperation in his or her field.

According to the Regulations of the University of Helsinki, the appointee must hold a doctoral degree, have the ability to conduct independent scientific work, and have the teaching skills required by the position. Other requirements include the ability and motivation to pursue a scientific career, as demonstrated through publications or otherwise. To successfully complete the duties associated with the position, the appointee must also be familiar with both Korean and Finnish society, have good cooperation skills and show individual initiative.

According to the Government Decree on Universities, assistant professors must be proficient in Finnish. The appointee to the assistant professorship in Korean studies must also be proficient in Korean and English. According to the Regulations of the University, foreign citizens or non-native Finnish citizens may be exempted from the Finnish language requirement without a separate application.

When considering the applicant's qualifications, attention will be given to scientific publications and other research results of scientific value, teaching experience and pedagogical training, the ability to produce teaching material, participation in doctoral education, other teaching merits and, if necessary, a demonstration of teaching skills. The applicant's activity in the scientific community, success in obtaining external research funding, involvement in international research networks, elected positions, merits in international and national community relations activities as well as leadership and interaction skills will also be taken into account.

The salary will be based on level Seven of the requirement scheme for teaching and research positions in the salary system of Finnish universities. In addition, the appointee will receive a salary component based on personal work performance.

#### General information:

The Korean studies section at the Paris Diderot University was set up more than forty years ago by Charles Haguenauer, the founder of Korean studies in France, and by the Korean historian Li Ogg who put Korean studies on the map in Europe, especially through AKSE. This section is part of the Department of East Asian languages and civilizations (UFR LCAO) and offers comprehensive university courses in Korean languages and civilization for undergraduate, master and doctorate levels, which are increasingly in demand.

Paris Diderot University is a member of "Paris Consortium – Réseau des études sur la Corée (Rescor)" with two other Parisian institutions: Inalco and EHESS. Beyond joint research projects, the Rescor is aimed at developing a Francophone Korean studies network and a new generation of French Koreanists through on-line materials (articles and translations), the production of educational materials in French, and a blog featuring all academic events and publications in Francophone Korean studies. This programme had been supported for five years by the Academy of Korean Studies (KSPS Core-University) and was renewed for another five years in 2015. The Korean studies section of Paris Diderot University hosts the Rescor office. #### Academic Program:

More than 300 students are currently enrolled in the Korean studies section, and a *numerus clausus* principle is applied since 2012. The section received more than 600 applications last year, but only 115 places were assigned for first-year undergraduate students. Paris Diderot University and INALCO also continued to offer a joint Master Degree program with almost thirty students enrolled last year. The growing number of students also led to the creation of two faculty positions: one full professor (Y. Bruneton) and one associate professor (P.-E. Roux). Another associate professor position will be created in 2017.

Paris Diderot University signed agreements with two Korean universities: Kookmin University and Kyunghee University. Moreover, Paris Diderot University and Seoul National University launched in 2014 a new research program exchange aimed at developing scientific cooperation and opening antennas in both universities. An interdisciplinary workshop entitled "Le corps féminin à la croisée des pratiques sociales et médicales et des perspectives transculturelles" was held in Paris on May 26, 2016, and a second workshop will be held in Seoul in October. For the second year, a SNU Summer school was also organized in Paris Diderot University in July 2016. Next to these activities, Paris Diderot University also continued pursuing an E-schooling program with Seoul National University and the University of Budapest.

#### Other activities:

Dr. Jin-Ok Kim and Marie-Orange Rivé-Lasan organized an international conference and an exhibition at Paris Diderot. These events were prepared and financed jointly by Kookmin University and the Independence Hall of Korea, on the occasion of the 130th anniversary of the establishment of diplomatic relations between France and Korea, and the 70th anniversary of the Liberation. The conference «La France et le mouvement d'indépendance coréen - Han'guk Tongnip undong kwa P'ŭrangsŭ » was held on April 11, 2016. During the following three weeks, an exhibition showing copies of archival documents was held at University Paris Diderot. The title of the exhibition was "Corée, nation exilée: Le mouvement d'indépendance coréen et la France à l'époque de la colonisation japonaise (1910-45) (Mangmyŏng minjok: Han'guk Tongnip undong kwa P'ŭrangsŭ)". Several graduate students were involved in the selection of 100 documents (in French, with Korean translation) and in the preparation and animation of the exhibition. Korean scholars and French Koreanists presented their works and participated to round tables dealing with the future of the research in the field. More than 70 people attended the conference. An other exhibition was held in the same period in the Paris 1st area city hall: "La "Corée libre" et la France, Rêves de paix ("Chayu Han'guk"-gwa P'ŭrangsŭ : p'yŏngwha-rŭl kkum kkuda". Dr. Rivé-Lasan and Dr. Jin-Ok Kim contributed to this exhibition by reviewing translations.

Three EPEL lectures were given in 2016. An Jong-chol (Tübingen University) gave a presentation entitled "Regionalism and Political Identity: Elites in the Case of Household Head System or Hojuje Abolition Movements" (April 6). Diana Yüksel (University of Bucharest) gave a lecture on "Neo-Confucian Thought during the Chosŏn Period" (2 May). Hannes Mosler (Freie Universität Berlin) finally gave a presentation entitled "Analyzing the 20th General Elections in South Korea" (May 4).

The Korean Studies section also hosted several lectures given by international scholars. Prof. Young-mee Yu Cho (Rutgers University, USA) gave a presentation entitled "Rhymes and Puns in K-Pop: A Linguistic Revolution" (November 6, 2015) and Prof. Park Seok (Sangmyung University) gave a presentation on « Tae kyo yak chol, La grande habileté semble maladroite » (February 17, 2016). Two other professors invited by the Centre de Recherches sur la Corée (EHESS-Paris Diderot University) presented their research at the

Korean studies section. Prof. Sun Joo Kim (Harvard University) gave a presentation on "Everyday Emotions in Sixteenth Century Korea—a Reading of One Man's Diary" (February 3, 2016) and Prof. Kim Gwi-Ok (Hansung University) gave four talks: "Impact of the Division on the South Korean Society" (June 8, 2016), "Korean Separated Families since the 1945~1953 Korean Division: *Wollamins*" (June 10, 2016), "The Korean War and the Korean Military Comfort Women Station System (KCWS)" (June 15, 2016), "DMZ and Regions in South Korea: the case of Cheorwon" (June 17, 2016).

For the 18th "Printemps des Poètes 2016" (The 'Spring of Poets' national event), Dr. Rivé-Lasan and the Korean Studies section organized a special session entitled "Sur les pistes de l'Himalaya avec le poète coréen Ko Ŭn en compagnie de ses traducteurs No Mi-Sug et Prof. Alain Génetiot", with the participation of the Tibetologist Prof. Françoise Robin. The event was held on 16 March 2016 with the presentation of a new translation of *Poèmes de l'Himalaya* and readings of Ko Ŭn poems in Korean and French. Ko Ŭn sent comments from Korea to the students who offered him their poems.

#### Scholars' Reports:

Prof. Yannick Bruneton was appointed professor of Korean studies in 2016 and teached premodern history and classic Chinese. Next to his strong involvement in the Rescor activities, he was nominated at the Comité National de la Recherche scientifique (CNRS), Section 33: « Mondes modernes et contemporains ». #### General Information:

The CKS is part of a joint research unit called "China, Korea, Japan," bringing together staff from the EHESS, CNRS, and other institutions. The specific organisation and scientific activities of the CKS include the following permanent faculty and staff: Ms. Eunjoo CARRÉ-NA ("ingénieur d'études" in charge of the research library and of the scientific information of the CKS), Prof. Alain DELISSEN ("Directeur d'études" in history), Prof. Valérie GELÉZEAU ("Maîtresse de conferences avec habilitation" in geography), and Dr. Isabelle SANCHO ("Chargée de recherches de première classe" at the CNRS appointed at the CKS). The current director of the CKS is Isabelle SANCHO.

The CKS also has several research associates from different partner institutions, including four permanent members from the University of Paris Diderot (Yannick BRUNETON, Marie-Orange RIVÉ-LASAN, KIM Jin-Ok, and Pierre-Emmanuel ROUX) and five honorary members (Marc ORANGE, Alexandre GUILLEMOZ, Francis MACOUIN, Martine PROST, and LI Jine-Mieung).

Two former students of the CKS (**Dr. YIM Eunsil** and **Dr. KIM Kyungmi**) have the status of "young research associates" ("jeunes chercheurs soutenus"), a new status created in 2013 in order to facilitate the future professional integration of former students in French academia. **Dr. Stéphane THÉVENET**, one of these "young research associates," obtained in June 2016 a permanent teaching position in Korean Studies at INALCO.

**Dr. Yannick Bruneton** who has been an associate professor at Paris Diderot University was promoted to full professor of Korean Studies in June 2016.

In 2015-2016, the EHESS Centre carried out its usual academic and research activities. It had in particular the pleasure of hosting a series of special lectures taught by the EHESS distinguished visiting professors: **Prof. KIM Sunjoo** (Harvard University) in January and **Prof. KIM Gwi-ok** (Hansung University) in June (see below).

Abstract: Attached to a scientific forum organized for the French/Korea diplomatic years (see below: Forum "Urbanités coréennes") on April 8, 9, 15 & 16 at the Cité de l'Architecture et du Patrimoine with the Centre of Korean Studies and the Seoul Institute, this seminar discussed urban cultures of the Republic of Korea, a country that counts more than 85% of urban population and a dozen cities over the million inhabitants. The seminar focused on the interactions between urban forms and practices around four major topics: 1. Seoul and the long modernity (historical trajectories of Korean cities, and the national paradigm); 2. Imagined and planned Korean cities (by medieval geomantic monks or contemporary architects and movie makers); 3. High-rise cities and their backstage; 4. Public spaces, secret gardens, marginal spaces. The seminar acted as a preparatory lab for the forum: students created a platform for scientific blogging on twitter and facebook during the event. As writing exercise, the students delivered critical essays on all the movies and documentaries presented during the forum, and wrote the accounts of all the round tables. All those productions were used in the bilingual (French/Korean) final report published in June by the Seoul Institute under the title *Urbanités coréennes / Han'guk tosisŏng*.

# Capital Cities in the Korean World (V. Gelézeau dir.)

This project launched in 2011 is an offspring of the project "North/South Interfaces in the Korean Peninsula" (2006-2013: see webpage for details

http://lodel.ehess.fr/crc/document.php?id=152) that was finalized with the publication of *Debordering Korea* in 2013.

Abstract: Korean history and the Korean space have been structured by a series of capital cities. These of course include those actively competing heads of state, Seoul and Pyongyang, but what of the others? Is plural "capitality" a Korean specificity? To answer these questions, the project draws upon a multi-disciplinary approach bringing together history, geography, sociology, anthropology and archeology in order to address this problematic alongside four main directions: 1. centers and (counter-) models of capitals; 2. planning hyper-capitals: major development projects in Paris, Seoul and Pyongyang; 3. capitals and social elites; 4. capitals, sites of memory and heritage. In 2015-2016, the major task was to finalize the manuscript for the book forthcoming (2017) at the Korean Studies series of the Institut d'Études Coréennes of the Collège de France.

# North Korea: Development, Space and Society (V. Gelézeau dir.)

Since the mid-2000s, the Centre for Korean Studies develops research in the pluralist stance characterizing European Korean Studies since the epistemological turn it contributed to initiate at the turn of the 2000s. Several engaged projects towards North Korea are involved including education (one North Korean student received its masters at EHESS in 2011) and on-going building scientific and academic cooperation between EHESS, CAPA "Cité de l'architecture et du patrimoine" – Museum of Heritage and Architecture – in Paris and Pyongyang University of Architecture (PUA *P'yŏngyang kŏnch'uk chonghap taehak*) (trips in 2013, and 2014). In 2015-2016, the major task was to secure funding in order to develop the project. In June 2016, V. Gelézeau got awarded an exploratory funding by PSL University (Paris Sciences et Lettres, regrouping the EHESS, the École Normale Supérieure and the French School of Oriental Studies) on a project entitled "Alternative and creative engagement with North Korean cities" (2016-2019).

# $\label{eq:creative} CREAK~(2016\text{-}2019)-Alternative~and~creative~engagement~with~North~Korean~cities$

Combining EHESS and EFEO's research on Asia with that in urban studies of ENS' Department of geography, the project intends to open a new terrain in Korean Studies, while analyzing an object understudied by western scholarship: the post-socialist Asian city. It proposes an engaged research with North Korean cities, which differs from dominant approaches that focus on security issues, human rights, international relations or politics. Rather, the project establishes contacts with North Korean architects trained in France during the 2000s, while sharing theoretical and practical knowledge on and in cities during two onsite seminars set during the course of the program. The project is transdisciplinary (7 scholars, 5 disciplines), and the methodology combines the know how of EHESS and EFEO, already engaged in Asian Studies and the (North) Korean terrain, with the transversal and comparative urban research of the ENS geographers, who will bring to the analysis new perspectives inspired by different city experiences. The feasibility of the program is based on

ongoing pioneering actions of EFEO and EHESS with North Korea, and on the possibility of working with Chinese architects.

Conceived as an open forum mixing cinema and social sciences at the auditorium of the CAPA, this event gathered French and Korean architects, scholars and documentarists to examine Korean urban cultures, mixing social cinema, documentaries, round tables and conferences. All sessions were sustained by on-site direct interpretation French/Korean.

#### *April 8, 2016: Seoul and the long modernity*

The Korean long and rooted urban experience was discussed around a 1961 movie by Lee Bong-rae (*A petty middle manager*), and two documentaries ((*Ssanggye-dong Olympics*, by Kim Dong-won (1998); and *Watchtower*, by Moon Seung-wook (2015)). Participants to the round tables were: Alain Delissen (EHESS), Françoise Ged (CAPA), Jung Ihna (Hanyang University), Kim Soo-hyun (The Seoul Institute), Marie-Orange Rivé-Lasan (Paris-Diderot University).

April 9, 2016: An XXL imaginary, the architects of the future to Korean cities Three documentaries very diverse in style evoked multiple projects and visions, which architects, artists and planners create of Korean cities: *Talking architect*, by Jeong Jae-eun (2012), *A Roar of the Prairie*, by Oh Min-wook (2015), *Bitter Sweet Seoul*, by Park Chanwook et Park Chan-kyoung (2014). Participants to the round tables were: Sylvain Allemand (journalist), Bahk Hyun-chan (The Seoul Institute), Yannick Bruneton (historian, université Paris Diderot), Benjamin Joinau (Hongik University), Valérie Gelézeau (EHESS), Caroline Maniaque-Benton (architect, ENSA-Normandie), Oh Min-wook (documentary director).

### April 15, 2016: Backstage of the high rise city

The verticlaization of Korean cities was discussed with the famous movie by Kim Ki-duk *3-iron*, where the apartment is a metaphor of social impediments, and two other documentaries (*The lost voyage* by Seo Hyun-seok (2014) and *My father's house* by Kang Yu Garam (2011)). Participants to the round tables were: Cho Hunhee (The Seoul Institute), Françoise Ged (CAPA), Valérie Gelézeau (EHESS), Kim Hui-yeon (Inalco), Jang Yeong-hee (Seoul Housing Corporation), Stéphane Thévenet (Inalco).

#### April 16, 2016: Secret gardens and urban margins

New practices of urban public space were debated with a fiction movie by Kim Kyoung-mook (*Stateless things*, 2012), and one documentary by Kim Gina (*Faces of Seoul*, 2009).

Participants to the round tables were: Benjamin Joinau (Hongik University), Frédéric Barbe (Nantes University), Cheong Soo-bok (writer), Thierry Paquot (philosopher), Song Do-young (Hanyang University).

- April 11, 2016: "La France et le mouvement d'indépendance coréen" ("France and the Korean independence movement"). Conference organised by Marie-Orange Rivé-Lasan and Kim Jin-Ok (Paris Diderot University-CKS), the Kookmin University, and the Independance Hall of Korea at Paris Diderot University.

The conference was followed by a *tapsa* (field trip) in Paris by bus on 12 April, "following in the footsteps of Korean independance activists and their French friends from the 1920's." From April 7 to April 18, a special exhibition was also held at Paris Diderot University: "Corée, nation exilée: Le mouvement d'indépendance coréen et la France à l'époque de la colonisation japonaise (1910-1945) - quelques documents d'archives" ("Korea, exiled nation: the Korean independence movement and France during the colonial era (1910-1945)").

# Scholars' Reports:

As a senior Research Engineer, **Eunjoo Carré-Na** assists researchers and works with documentation and management services at the CKS. Her works include providing scholars and researchers with academic assistance, reference documentation, and information management services. She is also in charge of acquiring related resources from outside for the centre. In 2014-2015, Eunjoo Carré-Na was part of a collective projet to promote the unknown documentary holdings of the libraries located at the Maison de l'Asie. She organized two exhibitions: "Littérature jeunesse" (Marc 2014) and "Amour et érotisme en Asie" (January 2015). She also participated to the reorganization of the documentation service of these libraries and is currently implementing a new system.

Since May 2015, thanks to a grant from the AKS, she has been working on her project of digital publishing of the "Répertoire historique de l'administration coréenne" by Maurice Courant. She also successively obtained from the Korea Foundation a grant for the subscriptions to digital resources and a financial support to provide the CKS with the temporary position of a library assistant.

In 2015, she was the first prize-winner of the 14th contest of junior translators of the Literature Translation Institute of Korea. She co-organised in Paris the 10<sup>th</sup> annual meeting of DocAsie, a professional network of librarians (22 June 2016). She also took part in the organisation of the exhibitions, "L'Asie en fête" ("Celebrate Asia") in November 2015 and "Archivilles" in April 2016 at the Maison de l'Asie.

In 2015-2016 **Alain Delissen** carried on with the project of rethinking and reorganizing his teaching to fit better the needs and expectations of a new generation of students (more frequently French natives fully engaged in Korean studies than used to be) while not setting aside altogether the specifics and requirements of a Doctoral seminar taught at EHESS. He decided in short to teach Colonial Korea and colonial Seoul sources as a secondary, more specialized seminar and to open a new one, larger in scope, periods, texts,

even disciplines as his main teaching about Modern Korea. Because of its many meanings (including in music), the general title of this seminar ("Tempéraments historiens, modalités géographiques: une histoire de la Corée moderne") does not render easily into English. To make it short: it aims at focusing on sources -mostly texts in the actual- that deliver a discourse on Korean history even though they are not produced by labelled "historians" or produced by historians endowed with a wider range of textual production. It will not be a surprise that Yuktang Ch'oe Namsŏn resurfaced in this seminar. But in place for his major historical endeavors, students were given the opportunity to read, translate, and discuss his 1908 Kyŏngbu ch'ŏlt'oga/norae (The Ballad of the Seoul-Pusan Railway). In the wake of the Russo-japanese war and on the eve of annexation, this one volume of poetry (coeval with Sonyŏn), which has stations for stanzas was referred to more academic pieces of historiography, old and new. It was also deciphered through the lens of spaces, territories, and landscapes that unfold across the peninsula in manners that have little to do with actual places. The whole poem can be read as a carefully selective mobilization of Korean history and geography, as an accumulation of symbolic weaponry or hidden riches, which has Pusan for its target: moving up to the front line.

During this academic year also tallying with Korea-France so-called "Crossed seasons", Prof. Delissen spared a great deal of his time to talk about his research or about Korea more broadly for the general public (Musée Guimet, Dec 1<sup>st</sup>, 2015 "The Korean World and Long Modernity"; Cité de l'Architecture de Chaillot, April 8-9 and 15-16, 2016 "Korean urban Cultures" (with Valérie Gelézeau and Benjamin Joinau); EFEO-AFAO, May 16, 2016 "Seoul vs Keijô"). More conventional were his participations as a discussant in various academic symposia (Sciences Po – IEP, Dec 18, 2015 on "Mass violence Europe/Asia"; EHESS, January 20-22, 2016 " Pre-Modern Korean Studies in Europe: Results, Projects, and Prospects"; Paris-Diderot, Independence Hall of Korea, Kookmin university, April 11, 2016 "France and the Independence Movement"). On March 10, 2016 he lectured at Turku University (Finland) "Travelling Korean Modernity – Introducing to Yuktang in 1908". On June 30, 2016 he was in Francfort (Germany) in the EPEL Programme framework to give a lecture on some Seoul and Pyongyang museums he had visited recently ("Let's now praise famous men... History at the Museum in South and North Korea".

During this period he participated in four PhD defense committees (The Invention of Chinese –and Korean- "classical" dance; The Birth of Multi-Media collections in South Korea; Jang Sun-woo's "open cinema"; and The networks of *Tairiku rônin* in continental Asia around 1900) and three Search committees for positions in Korean studies in Paris universities. What was left of his time was channeled to his duty as director of the Institute of Korean Studies (IEC) at Collège de France and RESCOR activities.

In 2015-2016, **Valérie Gelézeau** was on the move for the most part. First, she spent the last part of 2015 finishing her 10 months research fellowship at the IIAS (International Institute of Asian Studies) in Leiden, for her project on "New geographies of urban cultures in Korea" and delivered a last lecture within the IIAS lunch series on February 16, 2016: "The fieldwork paradox in North Korea". During that period, she was invited abroad on three occasions. In October (4-17) to South Korea, where she gave a paper entitled "Schizo-Koreanologies. From the spatial border to divisive thinking on Korean studies" at the

conference "From confrontational division to cross-bordering and debordering in Korea and beyond" (Gyeonggi and Shinhan University). Also in October, she went to Oslo and participated in the workshop organized by Oslo Gallery 047 and Oslo University of Architecture "Building the everyday utopia: mass housing in North and South Korea" with a paper "Emergence of a 'Republic of apartments'. Mass housing as the South Korean urban middle class production factory". Finally in December, she was invited at a guest speaker by the Centre for the Study of Korea and Munk School of Global Affairs of Toronto University to a symposium "High Rise Seoul" where she gave the keynote speech "Landscapes of power: mass housing at the urban core in South Korea", and a paper on "Visual methods, landscape interpretation and the fieldwork paradox in North Korea".

During the Spring semester, she was back in Paris and, while still serving as the treasurer of AFPEC (Association Française pour l'Étude de la Corée), she packed all her EHESS seminars in particular the one on "New urban cultures in South Korea" that was attached to the organization of the forum "Urbanités coréennes" (Korean urbanities), for which she was the major scientific commissar. She also managed to squeeze in a few other conferences for the French Korea diplomatic years, and a couple of other seminars at EHESS and the ENS (Ecole normale supérieure).

During this year, she took on four new master students: one on the development of Phnom Penh, one on border issues in Southern Thailand, and two on topics regarding the esthetic surgery industry in South Korea. She also accepted one Ph.D. candidate, on a topic regarding urbanization in China, in co-direction with Dr. Françoise Ged, at the Observatoire de la Chine contemporaine of the Cité de l'Architecture et du Patrimoine. She sat also on three Ph.D. juries.

Finally during this year, she took over several responsibilities nationally and internationally: she was appointed member of the International Scientific Advisory Board of the Ruhr-University AREA-Ruhr (Alliance for Research on East Asia), and member of the jury of the ICAS-GIS Book Prize in French.

**Isabelle Sancho,** acting as the director of the CKS and vice director of the joint research unit "China, Korea, Japan" at the EHESS, took the initiative in 2015-2016 to reform the management system of the research unit. The reform process took about six months (October 2015-March 2016) and involved many meetings and various difficulties.

Under these stressful conditions, she organised an international conference at the CKS from January 20 to January 22. Funded by the AKS, the CKS, and the Collège de France, the conference entitled "Pre-Modern Korean Studies in Europe: Results, Projects, and Prospects" was set in the context of the 2015-2016 France-Korea Years, on the 130<sup>th</sup> anniversary of establishment of diplomatic relations between France and Korea. It was also meant as a tribute to late Professor Daniel Bouchez who was a founding figure of pre-modern Korean Studies in France but also in Europe. The objective of the conference was to bring together in an unprecedented academic event most of the European or Europe-based pre-modernists in Korean Studies. The main scientific goal of the conference was to obtain a comprehensive overview of what European pre-modernists were currently researching and working on, in both personal and collective projects. The conference also aimed at forming a new academic

community in Europe and, to a certain extant, within the broad field of international Korean Studies. The conference brought together 29 participants coming from no less than 12 European countries (France, Germany, UK, Czech Republic, Netherlands, Romania, Switzerland, Denmark, Sweden, Hungary, Spain, Russia). It deliberately did not give primacy to academic hierarchy that would distinguish between PhD students, junior, and senior scholars, and was characterized by mutual respect and attention. The audience was very focused but the atmosphere was always friendly and warm. The conference was unanimously considered as a collective success.

Over the same period, as in previous years, Isabelle Sancho was busy examining job applications in East Asian studies to the EHESS and CNRS and preparing for these examinations (oral and written exams) the candidates working on China, Korea, or Japan and seaking an affiliation to the joint research unit "China, Korea, Japan" of the EHESS. During the academic year, she also has been doing her part of collective duties: sitting in committees (including a search committee for a position in Korean studies in Paris), participating in the scientific management of the Rescor II, and writing reviews for academic journals.

Like her colleagues in Korean studies in France, Isabelle Sancho was involved in diverse activities during the 2015-2016 France-Korea Years. In early November, she was part of the French presidential delegation to South Korea and took part, as the only representative of Korean studies in France, in the Economic and Academic Forum organised in Seoul. She was invited again at the presidential dinner at the Elysée Palace during president Park Geunhye State visit to France. She was also invited to talk at a special literary meeting dedicated to translation of Korean Classical literature at the Paris Book Fair in March. In May, she was asked to present Korean Confucianism at a training seminar dedicated to the future senior management staff of the BPCE (second largest banking group in France) planning a trip to South Korea.

In April, she attended the AAS in Seattle. In June, she was invited as a discussant at the workshop "Switching Codes in Korean Culture" organised at the Ruhr University Bochum. In early September, she presented a paper, "Yulgok's view on Kija," at the international workshop on Yulgok studies in Paris funded by the Ministry of Culture, Sports and Tourism of the Republic of Korea and organised by the Yulgok society, INALCO, and Sungkyunkwan University.

In August 2016 she finally submitted for review the final manuscript of her annotated bilingual translation into English of the prose writings of the *Hwadam chip* (the Collected Works of Hwadam, Sŏ Kyŏngdŏk), to be published at the Korean Classics Library at the University of Hawaii Press.

# <u>Ruhr-Universität Bochum</u> Sprache und Kultur Koreas (Korean Studies)

#### General Information:

In 2015/2016, the Korean Studies Institute of Ruhr-University Bochum (RUB) continued the AKS Core University Program for Korean Studies project "Transcoding as Cultural and Social Practice", which is being jointly conducted with the Korean Studies Institute at Freie Universität Berlin (FUB) from 2014/09 to 2019/08. In the framework of this grant project, the two Korean Studies institutes have continued to collaboratively develop teaching materials, exchange lecturers, create and deepen further networks within European Korean Studies, finance post-doctoral fellowships, support M.A. students as well as PhD-candidates, and conduct research on transcoding/cultural translation as a core aspect of knowledge circulation. The AKS post-doctoral fellow in 2015/2016 at RUB was Dr. **Myoungin YU**. The international conference "Switching Codes in Korean Culture" was held on June 17 and 18 at RUB under the auspices of the grant project. As a result of the previous grant project "Circulation of Knowledge and the Dynamics of Transformation" (2009-2014), the conference volume *Integration Processes in the Circulation of Knowledge. Cases from Korea* (Frankfurt/Main: Peter Lang. 2016; Research on Korea, Vol.6) was published in 2016.

Members of RUB Korean Studies have continued to work closely with the Kaete-Hamburger-Kolleg/CERES "Dynamics in the History of Religions between Asia and Europe".

In 2016, the Korean Studies Institute at RUB was awarded the Literature Translation Institute of Korea's (LTI Korea) Korean Literature Translation Workshop Grant, which serves as the foundation of the seminar (winter term 2016/2017) "Literarisches Übersetzen: Ein Seminar inklusive Workshop mit der Autorin Kim Sum" (Literary translation: A seminar including a workshop with the author Kim Sum), during which advanced B.A. and M.A. students will prepare a translation of the short story *Woenson chabi yŏin* (My left-handed woman) which will be revised in direct cooperation with the author during a three-day workshop in order to be presented by the students in the framework of a reading in December 2016.

The Bochum Korean Studies Lecture Series was established in the fall of 2015 and is now held regularly during the semester. In the winter term 2016/2017, the Bochum Korean Studies Lecture Series will host scholars such as **Nan KIM** (University of Wisconsin-Milwaukee) and **Martina DEUCHLER** (SOAS). Furthermore, a "Korean Classics Film Club" was established in 2016, which offers students the opportunity to discover classic movies from North and South Korea during the regular semester.

<u>Goethe Universität Frankfurt am Main</u> (Frankfurt University) Korean Studies (Koreastudien), Interdisciplinary Centre for East Asian Studies (IZO)

## General Information:

Korean Studies in Frankfurt am Main is located at the Interdisciplinary Centre for East Asian Studies (Interdisziplinäres Zentrum für Ostasienstudien/IZO) and the Faculty of Linguistics, Culture and Arts (Sprach- und Kulturwissenschaften) at Goethe University Frankfurt. Since it was first established in 2007, Korean Studies has enjoyed significant growth both in terms of research output and student numbers. Currently more than 100 students are registered. In December 2014, a new professorship, with the generous support of the Korea Foundation, was established and the department has been expanding since 2015; two language instructors, **Youngju SHIN** and **Soyeon MOON**, have been teaching Korean language courses since spring 2015. Additionally **Dolf-Alexander NEUHAUS** joined the team as a research fellow in November 2015. In December **Mi-Jeong JO** and **Ruixin WEI** took positions as research fellows, funding for these two positions were provided through external grants from the Academy of Korean Studies (AKS) and the Seed Program for Korean Studies (2015-2018), for the research project entitled, "Consolidating Frankfurt Korean Studies through Research on Identity and Transnational Mobility In and Out of Korea".

Another ongoing research project, "Transnational (return) migration of former Korean female 'Guest workers' in Hessen and South Korea" is funded by the Hessen State Ministry for Higher Education, Research and the Arts as part of its research priority programme, "Dimensions of the category Gender - Women and Gender Studies in Hessen". The project analyses the experiences of former Korean nurses in the region around Frankfurt, Germany and Korea and the impact on traditional gender roles in Germany and Korea.

Our library collections continue to grow, thanks not only to our own efforts, but also through generous donations by the Korea Foundation as well as individuals. Dr. **Eja NA**, Korea Foundation, and Korea Publication Association, for example, supported us with the kind donation of their valuable collections on Korea. These contributions continue to be catalogued by the Korean Studies librarian.

Thanks to continued funding by QSL Teaching Quality Enhancement Funds, we continue to employ two part-time student assistants who provide invaluable administrative support. In addition, we have again managed to secure funds to employ three part-time tutors to support our first year language students.

### Academic Program:

During the past year, Korean Studies has seen continued growth, both in terms of student numbers and courses offered. First-year registration increased to over 100 students, so we have managed to again increase Korean language classes, which demonstrates the strength of student numbers.

Students in the undergraduate programme for the BA in Empirical Linguistics and Korean, either as major subject or as minor subject and students from Korean Language and Linguistics courses, choose from a range of content courses on modern Korean society, culture, history, literature, religion, economics and other humanities and social sciences topics. Our students have also had the opportunity to take part in distance seminars on Korean society and culture run by Ewha University and Yonsei University under the auspices of the Korea Foundation Global e-School.

Students can choose to spend a semester at a partner university in Korea (Korea University, Ewha Women's University or Chungang University), for which we have also managed to secure a sponsorship from Asiana Airlines for an airline ticket scholarship, called the Asiana Flying Scholarship, as well as discount tickets for our students.

## Project-K Festival:

Between 21 and 25 October 2015 Korean Studies in Frankfurt hosted "Project K – The Korean Film Festival" for the fourth consecutive year. Like the year before, the event took place in the CineStar Metropolis cinema located in Frankfurt's city centre. Almost entirely organised by the Korean Studies student community, again with generous financial and organisational support by the Korean Consulate General in Frankfurt as well as by individuals from the Korean community, the festival presented 21 contemporary films, some of which were screened in Germany for the first time. This included the movie "Assassination" by Dong-hun Choi who was present in Frankfurt for the screening of his work. Again, the films were accompanied by various Korea-related activities such as calligraphy workshops, traditional games, as well as K-Pop events (incl. theme parties and sing-alongs). A K-Pop dance contest attracted participants from across the nation. In total, Project K attracted many visitors.

# Tübingen

# **General Information:**

The Korean Studies Program at the University of Tübingen has been selected to receive an AKS (Academy of Korean Studies) Core University Program for Korean Studies grant from September 2016 to August 2021. During the five-year, "Tübingen Global Korea Project," the department will carry out three major initiatives: 1) institutionalize Korean Studies by establishing an independent department and the Tübingen Center for Korean Studies; 2) expand and consolidate international integrative programs of BA, MA, and PhD; and 3) strengthen research on modern Korea in a global perspective through research units on the Cold War, Colonialism, and Migration. The grant will help further expanding the department's teaching and research capacity.

The department currently offers five degree programs including Bachelor of Korean Studies; Master of Korean Studies; Double Master of Korean European Studies (MAKES); Master of Politics and Society of East Asia (MA PGO) and Doctorate of Philosophy in Korean Studies. In the winter semester of 2015/16, 254 undergraduate students were enrolled, with 198 majoring in Korean Studies. Since the introduction of the master degree course in 2014, the number of MA students has grown, and in 2015, 13 students were enrolled on the program. In April of 2016, the department welcomed one doctoral student and two postdoctoral fellows. The department has continued to run its Korean branch, the Tübingen Center for Korean Studies at Korea University (TUCKU), and the King Sejong Institute in Tübingen.

In June 2016, the department co-organized an international workshop, "Bills of Rights and Regional Institutions: Comparative and Transnational Perspectives on European and East Asian Cases", with the Asia-Pacific Law Institute at Seoul National University and the Law School at Tübingen University. # Scholars' Reports:

Jun.-Prof. **Jong Chol An** is currently researching on the Korean legal history, with a particular focus on the Korean Nationality Act, its historical changes and US legal advisors' activities in Korea. He presented several papers last year at different international conferences including "Tokil ŭi siminkwŏn chedo ŭi pyŏnhwa wa Tokil han" in: 1980

nyŏndae ihu rŭl chungsim ŭro" (The Change of the German Citizenship System and Koreans in Germany) at the Sixth International Conference "Korean Diaspora: Minority among Minorities," organized by Jeju National University (September 8, 2015); "From Existential Agony to Ideological Division: Korean Film Understanding of the Vietnam War (1964-1975) during the Post-Cold War Era" at the "Film and History Workshop: the Korean Example", organized by SOAS in London (November 5-6, 2015); "Ending the Sino-Centered World Order? The Kanghwa Treaty, Korean-American Treaty, and International Law in Early Modern Korea" at the Second Workshop of the European Forum on Korean-Japanese History in Brussels (December 19 -20, 2015); and "Linking Two Legal Traditions: Legal Changes and Limits under the US Military Occupation of Korea, 1945-48" at the 2016 Annual Meeting of the Association for Asian Studies in Seattle (March 31 - April 3, 2016). He also gave a public lecture, "Regionalism and Political Identity: Elites in the Case of Household Head System or Hojuje Abolition Movements", at Université Paris Diderot on April 6, 2016. He is currently working on a book with the tentative title, From Continental to Common Law: US Military Occupation, Republic of Korea and Legal Basis, 1945-1950. In addition, as a part of the AKS Core University Program for Korean Studies, he is organizing an international conference on the Korean nationality law and citizenship, "The Imagining of Korean Citizenship: Nationals, Citizenship, and Korean Nationality Law." The conference will be held at Tübingen University in June 2017.

Dr. Heike Berner's teaching and research interests cover Asian German Studies, Korean diaspora, and oral history. In 2015/16, she taught classes on the history of Korean migration, the Korean diaspora in Germany, and the Korean German second generation. Dr. Berner is currently working on a research project on second-generation Korean Germans, which will result in a two-volume publication, combining theory and oral histories. In March/April 2016, she spent time as a DAAD-/NRF-fellow in Seoul to conduct fieldwork and presented her research at the Korean Association of North Korean Studies Spring Academic Conference and at Korea National University of Arts. In June 2016, she gave a talk at the "Asian Diaspora Space" workshop, held in Technische Universität Berlin.

Dr. Unsuk Han (supported by the AKS until March 2016) taught various courses on Korean history, culture and society during the winter semester of 2015/16 at Tübingen and became the Managing Director of the Tübingen Center for Korean Studies at Korea University (TUCKU) in Seoul in April 2016. He gave several public lectures and presented papers at different conferences last year. Some of them include "Frieden und Wiedervereinigung in Korea" (Peace and Reunification in Korea) at Deutschen Evangelischen Kirchentag in Stuttgart on June 6, 2015; "The Help of the German Churches for Democracy- and Unification Movement in Korea in the Cold War" at the Conference of the Institute for Korean Historical Studies (August 24, 2015); "The Democracy and Unification Movement of the Korean Women's Association in Germany" at the Sixth International Conference, "Korean Diaspora: Minority among Minorities," organized by Jeju National University (September 8, 2015); "25 Years of German Reunification and its Lecture for the Korean Peninsula" at VHS Education and Research Institute (16 May 2016) and "Discourses about the German Reunification, East Germany, and East Germans: With a Special Focus on the Discourses in the Social Sciences and the Mass Media" at the Conference of the Korean Association for Public Administration (6 June 2016). Dr. Han also organized two workshops that brought scholars from Germany and Korea together: "Museumspädagogik und historische Versöhnung in Deutschland/Europa und Korea/Ostasien" in Braunschweig on July 21, 2016 and "Geschichtsunterricht und historische Verständigungsprozesse in Deutschland/Europa und Korea/Ostasien nach 1945" in Sachsenhausen on 19 July 2016.

Dr. **Taejin Hwang** joined the department as a postdoctoral fellow in April 2016. Dr. Hwang received her Ph.D. in History from the University of California at Berkeley. Her research and teaching interests concern such themes as Modern Korea, US and the World, Cold War, and Migration and Diaspora. Her current book project examines the formation of American military camps and their camptowns in Cold War Korea as well as the trans-Pacific migration of mixed-race "Amerasians." During her term as a postdoctoral fellow, she will teach seminars on pre-modern Korean history, history of early modern Korea (1876-1945), modern Korean history and society, and the connections between the Cold War and South Korean modernity. She will also present her research to Think Tank Adoption in Copenhagen in September of 2016 and at the Seventh Conference of the Association of Korean Studies in German-speaking countries in November of 2017.

Dr. **Euna Kim** has continued teaching Korean language courses. In April 2016, she participated in the Sixth EAKLE European Association for Korean Language Education Conference, held at the University of Copenhagen and presented a paper entitled "A Case Study of Korean Academic Writing and Speaking Course for Graduate Students."

**Hyemin Kim** joined the department as a language lecturer in April 2016. She is dispatched from the Korea Foundation to work at Tübingen for two semesters, and during this period, she will teach a variety of Korean language courses for undergraduate students.

**Jee-Un Kim** is a research assistant and doctoral candidate. She continued her teaching duties by offering a course on the rise of the Korean music industry as well as coordinated the eSchool-program with the Seoul National University Asia Center (SNUAC) and a tutorial for first semesters introducing them to basic skills in scientific work in the winter term of 2015/16. She is the coordinator for the DAAD stipend program "Double Master of Korean European Studies" for the period 2014-2016 while continuing her dissertation studies on copyright and the music industry in South Korea.

**Youngeun Koo** is a doctoral candidate and research assistant at Tübingen. She joined the department in April 2016. She received her master's degree (MSc in Migration Studies) from the University of Oxford. At Tübingen, she convenes BA courses on Korean migration, adoption and transnationalism, and coordinates the E-School program with the Seoul National University Asia Center. In August 2016, she participated in the first RIKS Academy held at the Research Institute of Korean Studies, Korea University and presented her doctoral project, "Transnational adoption from South Korea."

**Ari Lee** has continued her research on Korean women's labor as a doctoral candidate. She is also in charge of the King Sejong Institute Tübingen. In the summer semester of 2016, she taught a Hanja course for BA students.

Jun.-Prof. **You Jae Lee** successfully led the application "Tübingen Global Korea Project" for the AKS Core University Program for Korean Studies. Professor Lee continued his teaching and supervision duties at the department in the past year. He also participated in a number of academic events, including the Second Workshop of the European Forum on Korean-Japanese History, "Circuits of Knowledge, Goods, and People," in Brussels (December 19 - 20, 2015) and presented his papers for the following conferences and workshops: "Peculiarities of Korean Migration History in Germany" at the Sixth International Conference, "Korean Diaspora: Minority among Minorities," organized by Jeju National University (September 8, 2015); "Other Spaces Towards the Global South" at Tübingen (October 6-9, 2015); "St. Ottilien and the Beginning of the Korean Studies in Germany" at the Koreafestival, St. Ottilien (June 24-25, 2016); and "Post/Cold War Korean Community in

Berlin" at the first RIKS Academy, Korea University (August 1-10, 2016). He also coorganized a workshop, "Asian Diaspora Space in Europe at the Intersection of Gender, Sexuality and Race" (June 10-11, 2016), held at the Center for Metropolitan Studies Technische Universität Berlin, and organized a panel for the summer school, "Truth Commissions and the Culture of Dissenting Memory in the Global South" (July 25-29, 2016), at Tübingen.

Dr. **Tobias Scholl** joined the department as a postdoctoral fellow in April 2016. He taught classes on Korean modern history, Korean mixed script and translation. He is currently working on a new research project, tentative entitled "South Korea's Cold War in Japan" and preparing for the publication of his doctoral thesis. He is also in charge of the Korean Studies Library at Tübingen University.

Dr. **Moon Ey Song** is a full-time lecturer of Korean language at Tübingen. She participated in the Sixth European Association for Korean Language Education (EAKLE) workshop held at the University of Copenhagen, Denmark on April 13-16, 2016. Dr. Song presented a paper entitled "Analysis of the Grammar Errors by Mother Tongue Interference: Focusing on the German Mother Tongue Learners" in Korean.

Jun.-Prof. Jerôme de Wit is currently interested in North and South Korean wartime literature, expressions of dissent in South Korean comics and formations of identity in Korean Chinese literature. He is currently reworking his PhD dissertation on North and South Korean Wartime Literature into a book, which will be finished around the end of 2016. Hereafter he will start a project entitled "The Literary Creation of Ethnic Korean Identity in China" which deals with a literary analysis of the multiple historical expressions and formations of identity from the ethnic Korean minority in China. # **General Information**:

SOAS Centre of Korean Studies (CKS) is currently chaired by Dr Charlotte HORLYCK and numbers sixteen full-time members of academic staff, who are based in eight different departments, with the largest concentration being in the Department of the Languages and Cultures of Japan and Korea: Dr Eunsuk HONG (Department of Financial and Management Studies), Dr Charlotte HORLYCK (Department of the History of Art and Archaeology Dept), Dr Anders KARLSSON (Department of the Languages and Cultures of Japan and Korea), Dr Grace KOH (Department of the Languages and Cultures of Japan and Korea), Mrs Kyung Eun LEE (Department of the Languages and Cultures of Japan and Korea), Dr Owen MILLER (Department of the Languages and Cultures of Japan and Korea), Prof Jaehoon YEON (Department of the Languages and Cultures of Japan and Korea), Dr Noriko IWASAKI (Department of Linguistics), Dr. Jaeho KANG (Centre for Media Studies), Prof Keith HOWARD (Department of Music) and Dr. Tat Yan KONG (Department of Politics and International Studies). The Centre is also host to two Research Fellows (Dr Simon BARNES-SADLER and Dr Youkyung JU), one Doctoral Training Advisor (Dr Yenn LEE), one post-doc Research Associate (Dr Hyelim KIM), two

Professorial Research Associates (Prof. Martina DEUCHLER and Prof. Hazel SMITH) and five Research Associates (Dr Lucien BROWN, Dr James HOARE, Dr Andrew JACKSON, Dr Hyunseon LEE, and Dr Youngsook PAK). In addition, an increasing number of scholars from universities and other institutions in Korea and elsewhere are annually affiliated the Centre as Visiting Scholars, and in the academic year of 2015/16 alone the Centre has welcomed more than ten scholars. In 2011, SOAS was selected as beneficiary of the Overseas Leading University of Korean Studies after having successfully completed the AKS Korean Studies Institution Grant Programme for five years from 2006 to 2011. The new project, subsequently renamed as Core University Program for Korean Studies, has been implemented for another five years from 2011 to 2016. The grant has allowed CKS to significantly expand its manpower and infrastructure, its research program, its worldwide profile and its event calendar.

Two SOAS librarians (**Fujiko KOBAYASHI** and **Jiyoon WOOD**) who specialize in Korean material are also affiliated the Centre. They oversee and manage the SOAS Library's large holding of Korea-related material. The SOAS Library holds some 80,000 monographs for Korean studies including publications from North Korea and official reports produced by the Governor-General of Korea. In addition, there are some 400 Korean language periodicals, some 300 western language periodicals, and over 500 audio-visual materials for teaching and research in Korean studies; the online catalogue is available at www.soas.ac.uk/ library/

## Academic programs:

SOAS offers a wide range of degrees that either focus on Korea, or include Korea as a course component. Degrees that specialize in Korea are run by the Department of the Languages and Cultures of Japan and Korea, and include at undergraduate level BA Korean (single and dual subject degrees), and at Master's level: MA Korean Studies and MA Korean Literature. More recently, the Department of the Languages and Cultures of Japan and Korea has launched a two-year Korean language pathway directed at students who want to engage with Korea in a professional as well as academic way. The degree allows students to combine Korean language training with a select number of thematic or disciplinary Master's programs, such as MA History, MA Religions of Asia and Africa, MA History and MA Art and Archaeology of East Asia. Academics based in departments other than that of the Languages and Cultures of Japan and Korea run either specialized courses on Korea, or include Korea in thematic or regional courses. For example, Charlotte Horlyck teaches annually two undergraduate and two postgraduate courses on Korean art from pre-modern till the contemporary times, while Keith Howard's undergraduate and graduate courses on music and healing includes lectures on Korean shaman music and performance.

CKS offers several scholarships to SOAS MA and PhD students. This academic year, the Overseas Leading University Programmes grant provided by AKS enabled the Centre to give four scholarships to SOAS MA and PhD students working on Korea-related topics. In addition, one student received the Sochon Foundation Scholarship which is also managed by CKS.

Twenty-three PhD students are currently enrolled in Korea-focused PhD programs. For a full list of their research topics see this year's CKS Annual Review which is published on the CKS website: http://www.soas.ac.uk/koreanstudies/annual-review/

## Other activities:

As part of its growing outreach program, SOAS CKS ran close to forty seminars, workshops and other Korea-related events at SOAS on a wide range of Korea-related topics from K-pop and K-drama to art, literature and politics. Several events were co-hosted with the Korean Cultural Centre, the British Association of Korean Studies and the British-Korean Society – organisations with which the Centre has strong and long-standing links. They included a workshop organised by Dr. Owen Miller on Writing North Korean Social History, and Dr. Hyunseon Lee's two-day conference on Film and History: the Korean Example. The Centre was also involved in the three-day Joint East Asian Studies Conference which was held at SOAS in early September 2016. This triannual conference is co-hosted with the British Association for Korean Studies, British Association for Chinese Studies and British Association for Japanese Studies.

# Scholars' Reports:

Martina Deuchler had the honor of being invited to introduce her new book entitled *Under the Ancestors' Eyes: Kinship, Status, and Locality in Premodern Korea* (Harvard Asia Center, 2015) in a number of places: Paris (January 20), SOAS (March 11), Zurich (April 5), Kyujanggak (April 28), and Korea University (May 16). The book is now being translated into Korean. Martina Deuchler is busy with cataloguing the hundreds of slides she took in South Korea in the 1960s and later. Some of them document ceremonies that have disappeared in the meantime. They will eventually be bequeathed to the Ethnographic Museum of the University of Zurich.

Charlotte Horlyck continued her research and teaching activities during the academic year of 2015/16. Much of her research time, including her sabbatical in the first term, was devoted to the completion of her monograph on modern and contemporary Korean art. She gave several talks at academic institutions in the UK and Europe, including Freie Universität Berlin and Babes-Bolyai University, Cluj-Napoca. In June she was invited to present a paper at a workshop titled "Switching Codes in Korean Culture", organised by Professer Marion Eggert at Ruhr University Bochum. In September she presented the paper "Merging the Past and the Present in Contemporary Korean Art" at the Joint East Asian Studies Conference which was held at SOAS. She continued to serve as secretary of the British Association of Korean Studies (BAKS) and on the grants committee of the British Korean Society (BKS).

**Keith Howard** started his academic year with final proof editing and publication of two books, complete with a book launch at SOAS, where the room was full to capacity – most likely for the drinks, although many books were sold. Keith gave keynote presentations at an East Asian conference in the University of Chicago and for a joint conference of the Royal Musical Association and British Forum for Ethnomusicology in Bangor, co-ran a symposium in Sydney, Australia with attendees from Korea, Japan, China, Taiwan, Britain and Australia, and gave papers for symposia and conferences in Vienna, Shanghai, Kent, London, and elsewhere.

Anders Karlsson continued his normal teaching and research activities during the academic year of 2015/16. In addition, he has given lectures on Korean history, culture and society at various venues in Europe and Korea. He chaired the panel ""Rethinking Korean Legal History from a Comparative Perspective" at the annual Association for Asian Studies Conference in Seattle (March 31 to April 3, 2016) and presented the paper "Royal tablets, legal history and state power in traditional Korea" at the conference "Pre-Modern Korean Studies in Europe: Results, Projects and Prospects" (Paris, January 20-22, 2016). He continues to serve as advisor for the English translation of the *Veritable Records of the Joseon Dynasty*, a project undertaken by the National Institute of Korean History, and on the executive committee of the Committee on Korea Studies, Association of Asian Studies.

Grace Koh was the acting Chair of the Centre of Korean Studies in Term 1 (September-December 2015) during Dr Horlyck's research leave. In addition to her normal teaching and research activities, she participated in the following events: "Réseau des études sur la Corée" (RESCOR) workshop on Korean studies in the Francophone context (September 7-8, 2015, Paris Diderot University); AKS-CKS workshop on conceptions of 'life' and 'nature' in classical discourses (October 9, 2015, SOAS; workshop co-organiser); "Pre-Modern Korean Studies in Europe" conference (January 20-22, 2016, EHESS, Paris); and the Korea Foundation Korean Literature Workshop for Doctoral Students (July 5, 2016, Seoul; invited discussant). She also served as a consultant for the K-Literature Essay Contest 2015, coorganised by the Literature Translation Institute of Korea (LTI Korea), Korean Cultural Centre UK (KCCUK) and SOAS; and as a guest speaker and consultant at a subject enrichment session (Korean) at the North London Collegiate School (NLCS) on June 13-14, 2016.

**Tat Yan Kong.** The London Asia-Pacific Centre for Social Science (Co-Chairs: Tat Yan Kong, SOAS and Ramon Pacheco Pardo, KCL) was awarded USD14,938 for its Korearelated speaker series in 2016-17 by the Academy of Korean Studies (the same amount will be awarded for each of the following two years subject to satisfactory evaluation).

**Yenn Lee** has continued working closely with colleagues in South Korea in 2015/16. She has contributed columns on digital scholarship to the quarterly published by the Korea Information Society Development Institute (KISDI) throughout 2015. She will also give a talk on smart citizenship at the summer seminar of the World Association for Triple Helix and Future Strategy Studies (WATEF) in Daegu on August 24, 2016. Her research into digitally mediated phenomena in Korean society has also progressed and resulted in various publications and conference appearances, some of which are listed below.

**Owen Miller** attended a number of academic conferences and invited talks during this academic year. These included: in October 2015 a workshop at the Max Planck Institute for Social Anthropology in Halle, Germany on the topic of "Beyond the Eurocentrism Debate" where he presented on Korean historiography and the problem of Eurocentrism. In January 2016 he participated in a conference at EHESS in Paris on the subject of "Pre-Modern Korean Studies in Europe" where he presented on the topic of "The End of the Chosŏn

Dynasty from an Economic History Perspective". In April he was invited to speak at Oslo University on the topic of his recent research on the formation of the industrial working class in North Korea. Dr Miller also presented the same paper at the Comparative Histories of Asia seminar at the Institute of Historical Research, University of London. In term 2 of 2015/16 Dr Miller was on research leave, which enabled him to finish writing a chapter on Korean history for an edited volume entitled *Historical Sociology and World History*.

Jaehoon Yeon has been acting as a Project Director for Core University Programme of Korean Studies funded by Academy of Korean Studies, in addition to normal teaching and research activities. In this role, he has overseen the administration and execution of the AKS grant and research projects of SOAS Centre for Korean Studies. He is also acting as a Director for King Sejong Institute at SOAS. During the last academic year Prof Yeon presented academic papers and lectures as follows. In February 2016, he was invited to an International workshop for Korean Studies at the University of Turku, Finland, and gave a presentation on Core University programmes for Korean Studies at SOAS. In April 2016, he was invited as a key-note speaker to the Second Baltic Seminar on Korean Studies, held by University of Latvia in Riga. He gave a talk entitled "Korean Language Education in Europe and Globalization of Korean". He also gave a lecture on the Korean language and script to British students at a K-Pop Academy organized by Korean Cultural Centre in London on 12th of March. He is invited as a key-note speaker to the 26th International Conference on Korean Language Education that will be held in August at Dongguk University in Seoul. Prof Yeon will be on research leave during term 2 in the academic year 2016-17.

## **General Information:**

The Korean Studies staff consists of Dr. James B. LEWIS, University Lecturer in Korean History (Fellow of Wolfson College); Dr. Jieun Joe KIAER, Young Bin Min-KF Associate Professor in Korean Language and Linguistics (Fellow of Hertford College); Dr. CHI Young-hae, Korean Language Instructor; Mr. Minh CHUNG, Head of Bodleian Chinese Studies Library & Korean Collections; and other library staff.

## Library Expansion (Bodleian Library):

We are in the fourth year of the five year project "Window on Korea" (2013 - 2017) sponsored by the National Library of Korea (NLK). We will have received a total of some

4000 volumes from the NLK for this project by the end of 2017. Continued support from the Korea Foundation has enabled the library to subscribe to Dbpia & KRpia and also KISS (Korean studies Information service system) & KSI (Korean Studies Information Co., Ltd.) e-book.

The library has also received support from the Korea Foundation for a one year project which will fully catalogue the Library's Korean collection. There has been a growing backlog of some two thousand volumes including some rare items. The Project started in November 2015 and will end at the end of September 2016. 1885 titles were added onto the library catalogue during 2015-16. These include donations, purchases as well as backlogs.

# Academic program (graduate students):

Ms Jessica Morgan has completed her MSt in Korean Studies, having submitted her dissertation entitled "Improving integration in UK migrant communities through translanguaging, culture- specific, ESL pedagogical models and the provision of a linguistic 'safe space':a case study of the New Malden Korean community", and continues her field work in New Malden. She also presented a paper, "Early Childhood English Education in South Korea: Problems and Prospectus", co-authored with Dr. Jieun Kiaer, at the Young Language Learners (YLL) Symposium in July 2016.

Mr Sigfrid Östberg continues his preparation of a thesis tentatively entitled 'Diplomatic interaction and practice in early to mid-nineteenth-century Japanese–Korean relations', with support from the Korea Foundation. He has presented papers at the AAS conference in Seattle, WA, and elsewhere.

This research also contributed to running the *translating translation* seminars which have been ongoing since 2012. Dr Kiaer delivered a paper on translating emotions and interpersonal relations of modern Korean literature at the OCCT March this year and have hosted a number of translation related seminars, to which translators such as Deborah Smith contributed. In addition, Dr Kiaer has given talks in a number of seminars and conferences in Korea (Seoul National University and Korea University), Belgium (Ghent University), Denmark (University of Copenhagen) and UK on attitudes towards multilingualism. # General Information:

Korean language course was discontinued at the Oslo University in 2006 (originally established in 2000), due to low enrollments. Norwegian students may, however, attend the Korean language subjects at Stockholm University (Department of Asian, Middle Eastern and Turkish Studies) and have the grades recognized and included into their diplomas in Oslo. However, in Oslo too there are some Korea-related courses, both on Bachlor and Master levels. They are mostly taught by **Vladimir TIKHONOV** (Pak Noja, Department of Culture Studies and Oriental Languages), with assistance from **Elisabeth SCHOBER** (Postdoctoral Fellow, Department of Social Anthropology, Faculty of Social Science). Oslo University

continuously enjoys brisk exchange of students with its seven partner universities in South Korea. It also has an exchange agreement with Kim Il Sung University in Pyongyang (North Korea) since 2010, with a focus on cooperation between medical faculties; the agreement, however, did not result in any personell exchange so far.

### Academic Program

On the Bachelor level, 10 credit courses in Korean society/politics and religion/philosophy are being offered every other year. They are usually taken by 40-50 students on average. There are plans to offer a course on North Korea beginning in Autumn 2017. On the Master level, there is a sizable Korea-related content in such courses as *Approaches to East Asian Culture and History*, *Topics in East Asian Culture and History* etc. East Asian Culture and History (EACH) is an umbrella 2-years Master program which allows the students to write their dissertations on any East Asian society, Korean included. Currently, one EACH Master student writes her thesis on Korea, to be completed by June 2017.

## Academic Program:

31 students are currently enrolled on the B.A. Course and M.A. course (1<sup>st</sup>, 3<sup>rd</sup>, 4<sup>th</sup> year of "Korean Philology" major, 2nd year of "History of Korea" major, 1<sup>st</sup> year of M.A. course) with the full curricula (over 30 Korean studies-related disciplines taught). There are two Ph.D. candidates in Korean studies. One B.A. Thesis was defended in June, 2015 on Linguistics (Evdokia A. Novozhilova, *Natural Deduction Approach to the Analysis of Some Constructions in Contemporary Korean*, supervised by Alexey A. Vasiliev). The same student took part in the Fourth International Conference on Korean Studies "New Generation in Korean studies" (Moscow State University, Moscow, Russia) with the paper "Transitivation and detransitivation in Contemporary Korean Language".

### Other Activities:

In 2015, the Institute has finished the Academy of Korean Studies-sponsored project, inside the framework of which it was an Overseas Leading University Program for Korean Studies grant recipient.
