- **3. Seminars and Lectures**: You may provide a list of seminars and lectures on Korea at your university during the past year. For each event, please give the date (in the format month-day-year), title of the talk, and the event and venue.
- **4. Other Activities:** Activities relating to Korean Studies which took place in your institution or country during the past year. Reports of cultural events and radio and TV programmes on Korea should be included here.
- **5. Scholars' Reports:** You may include any papers presented, research undertaken or contemplated, performances presented, conferences attended, or any other scholarly activity related to Korean Studies. Publications, however, should NOT be included here, but under category 6. Please note that a separate paragraph should be written for each person for whom information is provided. For talks and paper presentations, the format should be: date (month-day-year), title of the paper, name of the event, and name of the venue.
- **6. Publications:** You may include here you own publications or the publications of anyone else in your country which may be of serious interest to scholars of Korean Studies. You should NOT list any publications that are due to be published in the following academic year. As a model, see the format used under entries for any university.
- **7. Announcements**: You may include here announcements on any events pertaining to the academic study of Korea.

PLEASE NOTE: Romanisation of Korean words and terms can be done according to either the **Revised Romanization System** or the **McCune-Reischauer System** unless the **Yale System** is used for linguistic purposes or a conventional spelling of a name is used. **Spelling** of English words should follow **American** conventions. Please do not use *Hangeul* or Chinese characters and do not use superscript text since it will appear too small to be easily readable.

Information should be provided as either an email attachment or on a diskette.

Any materials MUST be in MSWord.

Materials to be included must reach the Editor by 31 JULY 2018 at the latest.

A WORD FROM THE PRESIDENT

I hope that all Koreanists in Europe and that our friends and colleagues from many countries outside of Europe enjoyed the 28th biennial AKSE Conference held in Prague from 20 to 23 April 2017. We should express our warm appreciation for countless hours of hard organisational work to thank our colleagues at Charles University, beginning with Associate Professor Dr. Miriam Löwensteinová and Mr. Marek Zemánek and extending to the numerous students and other volunteers who made the conference such a success. Charles University is an ancient seat of learning in Europe and possesses one of the oldest research and teaching programs on Korea in Europe. While we may argue over age, I believe that it is incontrovertible that Korean studies at Prague is certainly among the most distinguished centres of learning in our midst. The very first AKSE Conference I attended was held in Prague in 1995 under the able direction of Professor Vladimir Pucek, one of the founders of Korean studies in Europe in modern times.¹

Our 2017 conference offered a vast range of outstanding papers on Korea, and I hope that we were able to offer some lustre to Charles University's Korean program. Our conference was partially supported by a generous grant from the Academy of Korean Studies, and Professor Löwensteinová and her team were awarded a mark of A ("Excellent") by the Academy's Evaluation Committee for Korean Studies Overseas.

Now, we look forward to Rome in 2019. Professor Dr. Giuseppina De Nicola of the Institute of Oriental Studies (ISO), Faculty of Philosophy and Letters, University of Rome Sapienza, will be our host. Preparation is currently underway, and we will make appropriate announcements in 2018 regarding panel and individual paper submissions.

I am happy to report that the European Programme for the Exchange of Lecturers (EPEL) has again been approved for funding by the Korea Foundation. Thanks to the detailed reports from participating institutions and the extensive financial information provided by our Treasurer, Dr. Koen De Ceuster, the Korea Foundation was satisfied with our report for 2016-2017 and approved funds for the second year (2017-2018) of our three-year Memorandum of Understanding. At the same time, we presented the Foundation with an application for funding for the third year (2018-2019), and that was also approved. In short, the EPEL program is healthy and active.

The website continues to disseminate information to AKSE members and the global community. I would encourage AKSE members to post to the Korean Studies Discussion List (koreanstudies@koreanstudies.com) in the first instance. Generally, we select notices from the Discussion List for re-posting, but please feel free to send notices about scholarships, post-doctoral positions, and academic teaching or research posts to myself or to Dr. Giuseppina De Nicola for the AKSE website.

I want to thank Prof. Vladimir Tikhonov for his tireless patience in producing this Volume 41 of the AKSE Newsletter. The Newsletter is an important historical document as well as offering current information on AKSE members, their institutional programs on Korea, and their students and colleagues. Please continue to submit your annual reports in the summer for fall publication. The next deadline will be July 31, 2018.

Finally, please pay attention to announcements for the 29th AKSE Conference, because I hope to see you at the next conference in Rome.

Please observe the following:

- 1) Submit your next report according to instructions given below. The format of your submission should follow the style in the entry for your country and university. Please do not submit the same reports that you used for AKS or the Korea Foundation since they ask for items that are not usually included in AKSE newsletters.
- 2) As AKSE is becoming more globalized and interacts more with scholars in both America and Korea, there is more pressure to adopt American spellings of English. For future issues, American spelling conventions will be preferred.
- 3) For now, either of the two main romanization systems is acceptable McCune-Reischauer or Revised Romanization. As in the past, the Yale System can be used for linguistic purposes, and a non-standard Romanisation is acceptable if used in a title or if it is the preferred spelling of a person's name, such as Syngman Rhee.
- 4) Please do not submit any text in Korean or Chinese characters, and please use standard English forms of punctuation, especially with quotation marks. I advise NOT to include any hyperlinks as they make the text difficult to edit.

CONSTITUTION OF THE ASSOCIATION FOR KOREAN STUDIES IN EUROPE (as amended in 2009)

NAME

1. The name of the Association shall be 'The Association for Korean Studies in Europe' (AKSE).

OBJECTS

- 2. The Association shall be non-political and its objects shall be:
 - to stimulate and to co-ordinate academic Korean Studies in all countries of Europe;
 - to contribute to the spread of knowledge of Korea among a wider public.

The objects of the Association shall be attained:

- by organizing academic conferences on Korea;
- by issuing a newsletter;
- by encouraging and facilitating co-operation with other organizations having aims consistent with its own objects.

MEMBERSHIP

3. The Association shall consist of Full Members in the categories of Ordinary Members and Honorary Members, and of Associate Members in the categories of Individual Associate Members and Corporate Associate Members.

Ordinary Membership is open to persons permanently resident in Europe with a serious academic interest in Korea. Individual Associate Membership is open to persons not permanently resident in Europe. Applications and proposals for Membership are to be addressed to any member of the Council and decided upon by the Council of the Association.

4. Members shall pay an annual fee to be determined by the Council.

Members may be exempted partially or totally from payment of the fee upon decision of the Council. Payment of the fee shall be due on Jan First of each year.

- **5.** Membership shall expire:
 - when a Member resigns from the Association by notifying the Secretary in writing.
 - when the Membership fee has not been paid within six months of the due date;
 - when a Member is expelled from the Association by the Council for having acted in a manner detrimental to the interests or the good name of the Association.

Expulsion shall require the consent of not less than four members of the Council. Before a decision on expulsion is taken, the Secretary of the Association will write to the Member in question, stating the nature of the alleged offence, together with the name(s) of the informant(s) or source(s) of information, and allowing a reasonable time for an explanation.

6. Regular Membership Meetings will be held during academic conferences or when called by the Council.

The Council shall call an Extraordinary Membership Meeting upon the request of one-third of the Full Members of the Association. Notice of any business to be transacted at a Membership Meeting shall be given in writing to the Secretary, who shall prepare the agenda of the meeting.

One-third of the Full Members of the Association shall form a quorum for any Membership Meeting, and only Full Members shall have voting rights at any Membership Meeting.

COUNCIL

7. The affairs of the Association will be managed by the Council. Should the Council need to deal with any matter not explicitly provided for in this Constitution, it shall do its best to consult all Members before making any decision, and in any event submit its decision to all Members at the earliest possible opportunity.

- **8.** The Council of the Association shall consist of:
 - a President:
 - a Vice-President;
 - a Secretary;
 - a Treasurer;
 - a Councillor for Public Relations;
 - a Councillor for Membership Affairs; and

two (2) other persons.

The members of the Council must be Full Members of the Association, and shall be elected at Membership Meetings. Members of the Council shall be expected to serve normally for a period of four years.

If a motion of no confidence in any Member of the Council is supported by four (4) Members of the Council, that Member shall be dismissed from the Council and from any office which he or she holds in the Association.

Notice of any business to be transacted at a Membership Meeting shall be given in writing to the Secretary, who shall prepare the agenda of the meeting.

Vacancies on the Council arising between Membership Meetings shall be filled by co-option or by transfer of duties within the Council. Members shall be notified of any such changes.

Four (4) members of the Council shall form a quorum for Council meetings. The Treasurer is to render audited annual accounts of the finances of the Association.

AMENDMENTS

9. This Constitution can be amended at Membership Meetings.

Amendments shall be notified to all Members at least six months before the Membership Meeting. An amendment shall require not less than two-thirds of the votes of Full Members present at a properly constituted Membership Meeting.

AKSE ACTIVITIES FUNDED BY THE KOREA FOUNDATION

(1.) EPEL

The European Programme for the Exchange of Lecturers is sponsored by the Korea Foundation. Every year, AKSE accepts applications from universities to invite scholars from other institutions to give lectures in their classes. This program also offers excellent opportunities for AKSE members to meet and exchange ideas concerning both research and teaching.

(2.) Korea Foundation Fellowships for European Graduate Students

AKSE recommends members for the screening committee to be appointed by the Korea Foundation. Final decisions are made by the Korea Foundation.

COUNTRY REPORTS

CZECH REPUBLIC

Praha (Prague)

<u>Univerzita Karlova v Praze</u> (Charles University) Department of Korean Studies, Institute of East Asian Studies

General Information:

The team of Prague Korean Studies, headed by Miriam LÖWENSTEINOVÁ, includes three full-time assistant professors – Tomáš HORÁK, Marek ZEMÁNEK and Vladislava MAZANÁ and a full-time lecturer JUNG Younwoo. The Department is a recipient of the Core University Program for Korean Studies grant (CUPKS). Thanks to the CUPKS, a substantial increase of both size of the department (number of teachers/scholars, students, library holdings) and quality of research (publications, international cooperation, international recognition) was possible. In 2016, the Prague Centre for Korean Studies was established and the Korean Studies activities, besides teaching, are conducted there. The main activities of the centre include research, organizing lectures and international conferences. The information on the activities of the centre is available on a Facebook page and a website of the project, where we share information about the grant activities. For detail, see https://www.facebook.com/korffuk/ and http://korea.ff.cuni.cz/.

Prague Korean Studies are considered traditionally and scholarly oriented. For dissemination of our research we use the two main channels – conferences participation and book publishing. The books we publish in Czech language are also accessible and comprehensible for a general domestic reader. As to the research, the three main activities are conducted in small teams where all levels of scholars/students cooperate. In this, we mostly follow the plan proposal of the CUPKS.

Seminars and Lectures

Department of Korean Studies at Charles University, Prague hosted the Twenty-eighth Biennial AKSE Conference from April 20 (Thursday) to 23 (Sunday) 2017 in Prague, Czech Republic. For details, see http://akse2017.ff.cuni.cz/

The second conference we organized was the Third Conference of Young Koreanists, Charles University (March 3, 2017). Under tutoring of the staff students from all three levels (B.A./M.A./Ph.D.) prepared articles which they also presented on a student workshop. By this we try to find and nurture perspective Koreanists among our (as well as Central European area) students. Hence the conference became an international event.

Scholars' Reports:

Miriam Löwensteinová (PhDr., Ph.D) has coordinated the Academy of Korean Studies (AKS) project and taught various new courses (*Methodology of Research of Korean Literature II*, *Interpretation of Modern Korean History I*, *mid 1880s - early 1920s*). She is working on her project of translation and interpretation of *p'aesŏl* literature, recently on Im Pang's *Chŏnyerok*. During the last year, she has attended following conferences: the Eighth World Congress for Korean Studies "Korean Culture, Seeking Insights for the Future", Philadelphia, October 6, 2016, University of Pennsylvania, paper title: "Globalized Space and its Peculiarity: *Saebyŏk ŭi Nana wa Uju P'isŭ Konghwaguk*"; the Fifteenth International Conference CEESOK (Central and Eastern European Society of Koreanology) "New Trends

in Korean Studies", Poznan, October 21, 2016, Adam Mickiewicz University, paper title: "Globalization of Korean Novel: how to evaluate these trends? The case of *Saebyeogeui Nana*"; AKS Core University Program for Korean Studies – Directors' Meeting, August 8 – 11, 2017, University of Tübingen, paper title: "Beauty of Korean Tradition from Interdisciplinary Perspective".

Tomáš Horák (Ph Dr., Ph.D.) has been working on translation of No Kwan-bŏm's *Kojŏn t'ongbyeŏn*, an intellectual history of Korea from eighteenth to twentieth centuries. He taught various new courses (*Theoretical Korean Grammar I, II*) and he attended The Twenty-sixth International Conference on Korean Language Education (IAKLE), August 6 - 7, Dongguk University 2016, paper title: "Naeyong ŭl chungsim ŭro han, kyoyuk kwa nŭngnyŏk ŭl chungsim ŭro han kyoyuk ŭi t'onghap: hakkujŏk mokp'yo rŭl talsŏnghagi wihan ilkki kyoyuk."

Vladislava Mazaná (Mgr.; Ph.D. candidate) has become a full faculty member of the department of Korean Studies and hence substituted Blanka Ferklová and, partially, Vladimir Glomb in their lectures. She taught various new courses (*Methodology of Research of Korean Language, Classical Korean II*). She has attended following conferences: Joint Doctoral Colloquium, Bochum, October 21 – 22, 2016, Ruhr University, paper title: "Relics of Middle Korean in Cheju Dialect"; Viennese Korean Studies Days, December 2, 2016, paper title: "Recent Development and Future Prospects of Korean Studies in the Czech Republic".

Chong Younwoo (Mgr.) taught several language courses and continued her linguistic research. Now she is in the process of writing a textbook (with Marek Zemánek) *Chinese characters in Korean for Czech learners*. She is also responsible for organizing the CEEPUS (Central European Exchange Program for University Studies) lectures.

Blanka Ferklová (Mgr., Ph.D.), taught new course – besides her duties at Sejong Institute - *Korean Onomatopoiea and Mimetics*. She resigned on her position, therefore will not be among the core members of the project from September 2017 on. Dr. Ferklova, whose expertise is in linguistic, was substituted by Ms. Vladislava Mazana.

Marek Zemánek, (Mgr., M.A., Ph.D.), continued his research on Korean Buddhism both old and modern, namely Buddhist rituals. His teaching activities comprise also lectures at the Department of Religious Studies. He taught various new courses (*Death in Buddhism*, *Modern Korean as Optional Oriental Language IV*, *Reading of Specialized Texts*) and (co-) presented the following papers at the conferences: "Modernization, Change and Bricolage in Buddhist Rites" for the Eighth World Congress for Korean Studies "Korean Culture, Seeking Insights for the Future", Philadelphia, October 6, 2016, University of Pennsylvania; "Field and Armchair: Some Remarks on Study of Rituals in Korea" for the Fifteenth International Conference CEESOK "New Trends in Korean Studies", Poznan, October 21, 2016.

Palacký University Olomouc Department of Asian Studies

Academic Program:

For five years before September 2015, Korean language was taught at the Department of Asian Studies at Palacký University Olomouc as an elective subject, mainly for students majoring in Chinese and Japanese. In September 2015, however, Korejština (Korean) was established as the third full-fledged Asian language program offered at Palacký University, and thus the new BA-program has joined the ranks of the established majors in Chinese and Japanese studies at Olomouc, going now into the third year of its existence. Students of Korean studies in Olomouc combine intensive training in the language, plus courses on Korean culture, history and society, with a variety of practical courses in general and economic studies. Currently, the program is limited to BA, but the aim is to expand eventually to a graduate program. For the upcoming year 2017/2018, 129 students applied and finally 23 were accepted.

Palacký University Olomouc efficiently promotes the new program to high school students all over the country. Teaching is covered by two assistant professors (Korea Foundation visiting professor Myung CHEGAL, PhD; and Dr. Andreas SCHIRMER) and four lecturers (Youngran KWAK, MA; Martin STURDIK, MA; Ruda SCHIMERÁ, MA; Linda STÖCKELOVÁ, MA). The establishment of partnerships with universities in South Korea is pursued very actively. During the past year, 17 one-semester scholarships could be arranged. Other efforts in a similar vein are collaborative networks with the strong Korean businesses in the region. Since 2016 the program is a participating partner unit of the CEEPUS(Central European Exchange Program for University Studies)-network Korean studies in Central and Eastern Europe, claiming its share in a busy exchange of teachers and students among the twelve participating institutions. During the summer semester of 2017, professors Dr. Codruta SINTEONEAN from Cluj-Napoca and Dr. Pawel KIDA from Poznan held one intensive course at Olomouc each thanks to CEEPUS teaching mobility, and students greatly appreciated these extra courses.

Scholars' Reports:

Andreas Schirmer (Mag. Dr.) has continued to coordinate the CEEPUS-network *Korean Studies in Central and Eastern Europe* which he initiated in 2011. For the 2017/2018 term 56 mobility months have been awarded and will be distributed among students and teachers. Going into its eighth year now, the network now comprises 12 participating partner units from Central and Eastern Europe, as one new partners could be included, Kraków (in addition to Bratislava, Bucharest, Budapest, Cluj-Napoca, Ljubljana, Olomouc, Poznan, Prague, Sofia, Vienna, and Warsaw). Schirmer fulfilled three teaching mobility stints during the 2017 summer semester, teaching at the University of Warsaw (May 15-19), the University of Sofia (May 23-26) and the Adam Mickiewicz University in Poznań (June 5-9) on "Issues of Korean Society as Mirrored in Fiction". Involved in the SEED-program of Korean Studies at Babeş-Bolyai University, Cluj-Napoca, as a visiting expert, he taught a course there from December 5-9, 2016 on "Translating Korean literature".

Besides his responsibilities at Palacký University Olomouc, Schirmer served as a lecturer at the Department of East Asian Studies of the University of Vienna, responsible for seven classes during the academic year of 2016/2017. One of these, "Translation from Korean into German: Contemporary Literature", which Schirmer co-taught with Dr. Sun-Young Yun, was funded by the Korea Literature Translation Institute as part of its *Overseas Translation Workshop Program*. It entailed a workshop together with the author Chŏng Yong-jun on

June 16-17 and a reading event, presenting the author's short story, *Sŏllŭng sanch'aek*, for which he has been awarded the Hwang Sun-wŏn prize in 2016.

Konferenz der Vereinigung der Koreaforschung e.V. im deutschsprachigen Raum, Rheinische Friedrich-Wilhelms-Universität Bonn, November 5, 2016; "Dodos and Godzillas: Analogies, Emblems, Symbols and Metaphors in Park Mingyu's Collection of Short Stories *Castella*" at the Twenty-eighth Biennial AKSE Conference, Charles University, Prague, April 22, 2017.

Having completed his German translation of Park Min-gyu's influential collection of ten short stories, *Castella*, and awaiting its being put in print, he works on a translation of Ku Hyo-sŏ's novel *Nagasak'i p'ap'a*. Schirmer's current research mostly relates to practical translation studies (issues which surface in the process of translating Korean literature), to the cultural anthropological role of translation wars in contemporary South Korea, to literary representation as a source of knowledge about South Korean mindsets, and to some marginalized issues of colonial modernity (texts written by Korean travelers and longer-term overseas sojourners about their experiences in European countries during the first half of the twentieth century). Several publications are in preparation.

General information:

The Korean studies section at the Paris Diderot University was set up more than forty years ago by Charles Haguenauer, the founder of Korean studies in France, and by the Korean historian Li Ogg who put Korean studies on the map in Europe, especially through AKSE. This section is part of the Department of East Asian languages and civilizations (UFR LCAO) and offers comprehensive university courses in Korean languages and civilization for undergraduate, master and doctorate levels, which are increasingly in demand.

Paris Diderot University is a member of "Paris Consortium – Réseau des études sur la Corée (RESCOR)" with two other Parisian institutions: INALCO and EHESS. Beyond joint research projects, the RESCOR is aimed at developing a Francophone Korean studies network and a new generation of French Koreanists through on-line materials (articles and translations), the production of educational materials in French, and a blog featuring all academic events and publications in Francophone Korean studies. This programme had been supported for five years by the Academy of Korean Studies (KSPS Core-University) and was renewed for another five years in 2015. The Korean studies section of Paris Diderot University hosts the RESCOR office. Academic Program

More than 300 students are currently enrolled in the Korean studies section, and a numerus clausus is used since 2012. The section received more than 1000 applications last year, but only 120 places were assigned for first-year undergraduate students. Paris Diderot University and INALCO also continued to offer a joint Master Degree program to almost thirty students enrolled last year. The growing number of students also led to the creation of a new faculty position for Yim Eunsil as an associate professor. Another associate professor position may also be created in 2018.

Paris Diderot University signed cooperation agreements with two new Korean universities: Pusan National University and Kyungbook University. Moreover, Paris Diderot University and Seoul National University launched in 2014 a new research program exchange aimed at developing scientific cooperation and opening antennas in both universities. Next to these activities, Paris Diderot University also continued pursuing an E-schooling program with Seoul National University and the University of Budapest.

General Information:

The CKS is part of a joint research unit called "China, Korea, Japan," bringing together staff from the EHESS, CNRS, and other institutions. The specific organisation and scientific activities of the CKS include the following permanent faculty and staff: Ms. **Eunjoo CARRÉ-NA** ("ingénieur d'études" in charge of the research library and of the scientific information of the CKS), Prof. **Alain DELISSEN** ("Directeur d'études" in history at EHESS), Prof. **Valérie GELÉZEAU** ("Maîtresse de conferences avec habilitation" in geography at EHESS), and Dr. **Isabelle SANCHO** ("Chargée de recherches de première classe" at the CNRS appointed at the CKS of the EHESS). The director of the CKS since fall 2013 is **Isabelle SANCHO**.

The CKS has several research associates from different partner institutions, including four permanent members from the University of Paris Diderot (Prof. Yannick BRUNETON, Dr. Marie-Orange RIVÉ-LASAN, Dr. KIM Jin-Ok and Dr. Pierre-Emmanuel ROUX) and five honorary members (Marc ORANGE, Alexandre GUILLEMOZ, Francis MACOUIN, Martine PROST, and LI Jine-Mieung). Dr. Eunsil YIM, a former student of the CKS who has had the status of "young research associate" ("jeune chercheur soutenu") will join in the fall of 2017 the permanent staff of the University of Paris Diderot and the CKS.

In 2016-2017, the CKS had the pleasure to host two post-doctoral fellows: Dr. **Oul Klara HAN** (Korea Foundation post-doc) and Dr. **Chloé PABERZ** (RESCOR post-doc). It also hosted several recipients of the fellowships given by the RESCOR.

Since its creation in 1989, the CKS is one of most important documentation source in France, on all areas of the social sciences and about Korean cinema. In addition to the general catalogue, the resources are accessible on a specific data base. The materials include more than 10 000 monographs (80 per cent in Korean) and 270 journals (60 per cent in Korean). In addition, important resources in the audio-visual and media fields are available. Since 2007, the CKS offers an online research service, accessible from the research platform "Hypotheses" (see: http://korea.hypotheses.org : "Carnets du Centre Corée"). In 2010, the CKS was selected and supported by the Korean Film Council (KOFIC) as a "Hub-Library for Korean Film Studies." The list of available films is accessible on the "Hypotheses" website. The cataloguing of the fund Marcel Giuglaris (1922-2010) concerning Korea (1950-1990) donated to the CKS in 2012 has been now completed and the documents are consultable at the library of the Maison de l'Asie, 22 avenue du président Wilson, 75116 Paris. The inventory list is available at: https://korea.hypotheses.org/8646.

Since 2015, the CKS has been benefiting a grant from the Korea Foundation for the cataloguing of the library and its resources, especially the transfer and processing of bibliographic records.

Abstract: This seminar is connected with a new research program on urban issues in North Korea, funded by the PSL University Cluster and entitled « Pour une approche alternative et engagée des villes nord-coréennes » (Alternative and creative approach within North Korean cities), see https://www.univ-psl.fr/fr/laureats-appel-projets-lettres-shs-ecofinances-gestion). With an urbanized population of nearly 60 per cent, North Korea presents contradictory indexes of development (an industrial economy, a low birth rate and a high literacy rate against a background of perennial food insecurity and high levels of poverty). The seminar approaches these contradictions by studying the city and its development (in architecture and urbanism), as an enduring matrix of North Korean modernization and socialist construction. Using a pluridisciplinary approach, the seminar addresses three main problematics: 1. A historicized reading of the urban landscape; 2. A social sciences reading of urban forms, morphology and architecture beyond the reductionist reading of the North Korean city as nothing but a "stage of the regime"; 3. Reading North Korean cities in the larger context of the (post)-socialist urban world. In 2016-2017, the seminar focused on the recent formation of urban scape, along with the development of the North Korean totalitarian state. A collection of articles and book reviews on the topic was started with the students. The seminar also used as a primary material for analysis the magazine Chosŏn kŏnch'uk, an architecture journal published in the DPRK since the 1990s.

Capital Cities in the Korean World (V. Gelézeau dir.)

This project launched in 2011 is an offspring of the project "North/South Interfaces in the Korean Peninsula" (2006-2013: see webpage for details (http://lodel.ehess.fr/crc/document.php?id=152) that was finalized with the publication of *De-bordering Korea* in 2013.

Abstract: Korean history and the Korean space have been structured by a series of capital cities. These of course include those actively competing heads of state, Seoul and Pyongyang, but what of the others? Is plural "capitality" a Korean specificity? To answer these questions, the project draws upon a multi-disciplinary approach bringing together history, geography, sociology, anthropology and archeology in order to address this problematic alongside four main directions: 1. centres and (counter-) models of capitals; 2. planning hyper-capitals:

major development projects in Paris, Seoul and Pyongyang; 3. capitals and social elites; 4. capitals, sites of memory and heritage. In 2015-2016, the major task was to finalize the manuscript for the book forthcoming (2017) at the Korean Studies series of the Institut d'Études Coréennes of the Collège de France. In 2017, finally the book was handed to the publisher. It will be published in 2018 under the title *Sŏrabŏl. Des capitales de la Corée* (Sŏrabŏl. About Korean capitals). Paris, éditions de l'IEC, Collège de France.

General

Since the mid-2000s, the Centre for Korean Studies develops research in the pluralist stance characterizing European Korean Studies since the epistemological turn it contributed to initiate in the beginning of the 2000s. Several engaged projects towards North Korea are involved including education (one North Korean student received the masters at EHESS in 2011) and on-going development of scientific and academic cooperation between EHESS, CAPA '"Cité de l'architecture et du patrimoine" – Museum of Heritage and Architecture – in Paris and Pyongyang University of Architecture (PUA *P'yŏngyang kŏnch'uk chonghap taehak*) (trips in 2013, and 2014). In 2015-2016, the major task was to secure funding in order to develop the project. In June 2016, V. Gelézeau was awarded exploratory funding by PSL University (Paris Sciences et Lettres, regrouping the EHESS, the École normale supérieure and the French School of Oriental Studies) on a project entitled "Alternative and creative engagement with North Korean cities" (2016-2019).

In July 2017, the project received additional funding from the French National Research Agency (ANR) for its expanded version entitled "Cities, urbanism and architecture in North Korea" (CITY-NKOR)

CITY-NKOR:

Combining area studies and the social sciences, CITY-NKOR brings together three partners (EHESS, EFEO in France and Leiden University in the Netherlands) in the forefront of new approaches in the study of (North) Korea today. CITY-NKOR differs radically from the prevailing normative focus on international relations, international politics or security issues and its predominant performative perspective that reduces the country to nothing but an object of foreign policies. Instead, CITY-NKOR adopts a posture of direct engagement with North Korea by focusing on a specific object: the city.

With an urbanized population of nearly 60 per cent North Korea presents contradictory indexes of development (an industrial economy, a low birth rate and a high literacy rate against a background of perennial food insecurity and high levels of poverty). CITY-NKOR approaches these contradictions by studying the city and its development (in architecture and urbanism), as an enduring matrix of North Korean modernization and socialist construction.

Through its scientific perspective, positionality and methodology, CITY-NKOR questions conventional understandings (in academic, media or policy circles) regarding the possibilities

of research on North Korea. Rather than to fall into the trap of Orientalizing North Korea as the 'global Other', we confront and critically challenge the notion of a totalitarian North Korea and its reductive normativity. We are fully cognizant of the fact that our position is fraught with political and scientific pitfalls, which we will avoid by developing a rigorous theoretical grounding, by building on long-term on the ground experience, and through a constant collective ethical reflection.

The project is grounded on a two-fold strategy with-in North Korea. Firstly, CITY-NKOR builds on the multidisciplinary work of a core team of scholars who all have fieldwork experience in North Korea. Secondly, building on an already established network of professional contacts in North Korea (i.e. North Korean urban archaeologists working with the EFEO in North Korea, Cambodia and France since 2008 and North Korean architects and urbanists trained in France during the 2000s who are in contact with CITY-NKOR UMR8173 team members), CITY-NKOR adopts a position of radical engagement with our North Korean partners, aiming for a mutual exchange of knowledge and expertise.

The CITY-NKOR core team consists of nine scholars who study the North Korean city, its architecture and urbanism from seven disciplinary angles, addressing three thematic approaches: 1. A historicized reading of the urban landscape; 2. A social sciences reading of urban forms, morphology and architecture beyond the reductionist reading of the North Korean city as nothing but a "stage of the regime"; 3. Reading North Korean cities in the larger context of the (post)-socialist urban world. The core team is structured in two clusters, with on the one hand, the EHESS (V. Gelézeau dir. 40% research time) and Leiden University (K. De Ceuster) in Europe, and the Seoul Centre of the EFEO in Korea (E. Chabanol dir. 30% research time) on the other. Both clusters will jointly execute the four main scientific tasks: 1) individual research projects of the core team members, integrated through regular thematic seminars & joint fieldwork; 2) group fieldtrips to North Korea for developing cooperation and collecting primary data; 3) fieldtrip to Paris for North Korean professionals (including a workshop and training); 4) archaeological excavations in North Korea; continuing the "Archaeological mission in Kaesong" (French Ministry of Foreign Affairs) started in 2011 under the direction of E. Chabanol (EFEO), where collaboration of French and North Korean archeologists is already happening.

CITY-NKOR seeks knowledge distribution and transfer through seminars and workshops in Paris/Leiden and Seoul, as well as through publications (both in print and online). On top of pushing epistemological boundaries in East Asian studies, CITY-NKOR assumes a role as cultural and social mediator for media, policy making, and business regarding North Korea.

Scholars' Reports:

As a senior Research Engineer, **Eunjoo Carré-Na** assists researchers and works with documentation and management services at the CKS. Her work includes providing scholars and researchers with academic assistance, reference documentation, and information management services. She is also in charge of acquiring related resources from outside for the centre.

Since May 2015, thanks to a grant from the AKS, she has been working on her project of digital publishing of the *Répertoire historique de l'administration coréenne* by Maurice Courant.

In 2016-2017 Alain Delissen chose Ko Un and his worldwide famous Maninbo – Ten thousand lives as the topic of his new seminar ("Tempéraments historiens, modalités géographiques : une histoire de la Corée moderne). As with Ch'oe Namson and his 1908 Kyŏngbu ch'ŏlt'oga/norae the previous year (see 2015-2016 AKSE Newsletter for a general view of the purpose and methods of this seminar), three volumes were picked from the 30 volume-series, all published in 2004, all having to do with the Korean War. What is it that poetry can add to conventional historical writing? What can be said of the many different ways Ko Un – who experienced the war as a young man – writes of the conflict beyond the reach of mere testimony, through a living montage of highly visual scenes and characters? Where do information and materials come from? And how do these three volumes fit in the overall architecture of the *Maninbo* project? In order to prepare for a panel aimed at Prague AKSE conference (The Meaningfulness of Small things), the second semester explored colonial Korea from the perspective of a specific genre consisting of different types of journalistic breves in the newspapers, striving to grasp the moving surface of daily lives as well as escaping from Japanese censorship. The seminar was also used as the main venue to host two distinguished visitors who happen to work on colonial Korea, Prof. Choi Hyaeweol (Australian National University) in March and Prof. Kim Hwansoo (Duke University) in May.

During this academic year, Prof. Delissen gave talks at Musée Guimet, January 20, 2017 "The World seen from Asia – Korean maps and cartography in a colonial context "; at Ecole Normale Supérieure (Paris), March 29, 2017, "Round-Table: Waiting for the Barbarians, China, Korea, and Japan in the ordeal of Western imperialism"; and at EHESS Area studies and History seminar, "Area studies as a method: learning from the Korean world", May 4, 2017. He also convened a panel (see above) for Prague Twenty-eighth AKSE conference, with Prof. Helen Lee (Yonsei University) and Prof. Jun Bong-gwan (KAIST) as copresenters and Prof. Grace Koh (SOAS) for a discussant. His own contribution was "Breaking News: Insistent instants from Colonial Korea in the 1920s –400 *Tonga ilbo* Columns in English and Esperanto". As of May 19-21, 2017, he was called in as a general discussant during a conference about "Korea in Global History" organized at Heidelberg university (Cluster of Excellence "Asia and Europe in a Global Context").

During this period he participated in five PhD or Habilitation defense committees: *Ethnography of a small video-game company in South Korea* by Chloé Paberz in Nanterre University; *Japanese museums of ethnography and anthropology* by Alice Berthon at INALCO; *A history of colonial sciences* by Arnaud Nanta at Paris Diderot; *Memory and history in South Blockbusters* by Aurélien Pasquier at Lyon3 University; and *The Place of Literature – the politics of literary discourse in Liberated Koreas* by Benoît Berthelier at INALCO.

What was left of his time was channeled to his duty as director of the Institute of Korean Studies (IEC) at Collège de France with the re-launching of the Institute's collection –now renamed as *Kalp'i*). Two volumes were produced and edited at the College with the

assistance of Mrs No-Genetiot Mi-Sug, librarian at the Institute. Kalp'i 1 was Yim Eunsil's Etre Coréens au Kazakhstan (To be Koreans in Kazakhstan – Identity entrepreneurs at the borders of the Korean world) while Kalp'i 2, entitled Une amitié pour la Corée/Friendship for Korea – consists in the editing of Maurice Courant's Correspondance with ambassador Colin de Plancy.

In 2016-2017, Valérie Gelézeau started the academic year inspired by a three months-long Fellowship for Field Research which was granted to her by the Korea Foundation (May 15-August 15) to work on several projects: "A cultural geography of Seoul as a world city", "Korean capital cities", and "Korean urbanities". On her way back to France she stopped back in Beijing to deliver a paper at the Thirty-third International Geographical Congress: "Songdo (South Korea), a mega-project in the making: residential neighborhood of an urban utopia" (August 23, 2016). During the year, she made two important trips for rather exceptional conference participation. The first one was to participate in the seventieth anniversary of Kim II Sung University foundation in Pyongyang, directly invited by KISU; as a geographer, she presented a paper within the panel "Life and environment sciences," on "Environmental analysis and the notion of causality in French cultural geography - a critical assessment" (September 30, 2016). The second one was an invitation as a foreign expert to a roundtable on the DPRK organized by Oxford House in the UK House of Lords. She discussed the topic: "Do sanctions really make a difference for the majority, day to day, in the DPRK - the example of academic cooperation" (January 17, 2017). Finally, in March, she went as a member of the organizing scientific committee to Hanoi (Vietnam) for the conference « Vietnam and Korea as longue durée subjects of comparison I » organized in cooperation with IIAS, VNU, SNU & EHESS (March 1-6, 2017).

During that academic year, while still serving as the treasurer of AFPEC (Association Française pour l'Étude de la Corée), she taught her regular seminar at EHESS (City, architecture and urbanism in North Korea, see above section) and was the main organizer for the EHESS CKS pluridisciplinary seminar of Korean studies. She also managed to squeeze in a few other conferences at EHESS or for the PHAROS Observatory and was on the air in the *France Culture* schow "Cultures monde" (World cultures) for a special session on the DPRK (December 2, 2016).

During this year, she took on only one new master student who chose to investigate the topic of elderly people in Seoul picking the recyclables while questioning the modernization of garbage management in the city. She sat on two Ph.D. jury, including one in Leiden in July, and was the main reviewer for a full professorship appointment at the CNRS.

Finally at the end of the year, she was elected the new President of AFPEC (Association Française pour l'Etude de la Corée) at the general assembly of 2nd June 2017.

Isabelle Sancho, the director of the CKS and vice director of the joint research unit "China, Korea, Japan" at the EHESS, was on maternity leave from mid-October 2016 to late January 2017. As in previous years, she was busy examining job applications in East Asian studies to the EHESS and CNRS and preparing for these examinations (oral and written exams) the candidates working on China, Korea, or Japan and seeking an affiliation to the joint research

unit "China, Korea, Japan" of the EHESS. She also has been doing her part of collective duties: sitting in diverse committees, participating in the scientific management of the Rescor II, and writing reviews. In early September, she presented a paper, "Yulgok's view on Kija," at the international workshop on Yulgok studies in Paris funded by the Ministry of Culture, Sports and Tourism of the Republic of Korea and organized by the Yulgok society, INALCO, and Sungkyunkwan University. In April, she attended the AKSE conference in Prague without presenting a paper.

From February 2017, when she was back from her second maternity leave, Isabelle Sancho has been spending most of her time managing the CKS and the joint-unit "China, Korea, Japan" which was experiencing many difficulties (the moving of the EHESS headquarters and offices in spring, handling the trouble generated by the sick leave of one administrative agent). The most time-consuming task she has accomplished over that period was the preparation, compilation and writing of the scientific report of the joint-unit "China, Korea, Japan" for the five-year national research contract (2014-2018). She also actively participated in the writing of the joint-unit's research programme for the upcoming national research contract (2018-2023).

Bochum

Ruhr-Universität Bochum Sprache und Kultur Koreas (Korean Studies)

General Information:

In 2016/2017, the Korean Studies Institute of Ruhr-University Bochum (RUB) continued the AKS Core University Program for Korean Studies project "Transcoding as Cultural and Social Practice", which is being jointly conducted alongside the Korean Studies Institute at Freie Universität Berlin (FUB) from September 2014 to August 2019. In the realm of this grant project, the two Korean Studies institutes have continued to collaboratively develop teaching materials, exchange lecturers, create and deepen further networks within European Korean Studies, finance post-doctoral fellowships, support M.A. students as well as PhD-candidates, and conduct research on transcoding/cultural translation as a core aspect of knowledge circulation. Also, the two Korean Studies Institutes successfully hosted a summerschool in Korea. The AKS post-doctoral fellow in 2016/2017 at RUB is Dr. Gyewon Byeon. Members of RUB Korean Studies have continued close cooperation with the Kaete-Hamburger-Kolleg/CERES "Dynamics in the History of Religions between Asia and Europe".

In 2017, the Korean Studies Institute at RUB furthermore intensified teaching and research in the field of literary translation. As a result of a translation seminar held during the winter term 2016/2017, a translation of the short-story *The left-handed woman* by South Korean author Kim Sum, entirely prepared by students of Bochum Korean Studies, was published in the journal *Hefte für Ostasiatische Literatur* 62 (May 2017). Also, the Korean Studies Institute organized several public readings during which Korean novelists and poets such as Park Sangsoon or Moon Hyejin read their original works, while students of RUB Korean Studies presented their jointly prepared German translations.

In the framework of the Bochum Korean Studies Lecture Series, which is being held regularly during the semester, the Korean Studies Institute welcomed scholars such as **Jongtae LIM** (Seoul National University), **Marie Seong-Hak KIM** (St. Cloud State University), or **Sangjin YI** (Korea National Open University). <u>Goethe Universität Frankfurt am Main</u> (Frankfurt University) Korean Studies (Koreastudien), Interdisciplinary Centre for East Asian Studies (IZO)

General Information:

Korean Studies at Goethe University of Frankfurt is part of the Interdisciplinary Centre for East Asian Studies (Interdisziplinäres Zentrum für Ostasienstudien/IZO) and the Faculty of Linguistics, Culture and Arts (Sprach- und Kulturwissenschaften). The Korean Studies, since its establishment in 2011, has enjoyed significant growth both in terms of education and research output. With currently more than 100 students registered, the Korean Studies are expecting another 100 new students in October, 2017. A new professorship, with the generous support of the Korea Foundation, was established in December, 2014, and the department has been expanding; two language instructors, **Youngju SHIN** (**Eunkyung**

PARK as of now) and Soyeon MOON, have been teaching Korean language courses since April, 2015. Additionally, Dolf-Alexander NEUHAUS joined the team as a research fellow in November, 2015. A month later, Mi-Jeong JO and Ruixin WEI took positions as research fellows, funded by external grants from the Academy of Korean Studies (AKS) and the Seed Program for Korean Studies (2015-2018), for the research project entitled, 'Consolidating Frankfurt Korean Studies through Research on Identity and Transnational Mobility In and Out of Korea'. Given the volume of administrative work with the increasing number of students, Yasemin KIŠ began to work for the department as a secretary in September, 2016.

Another ongoing research project, "Transnational (return) migration of former Korean female 'Guest workers' in Hessen and South Korea", is funded by the Hessen State Ministry for Higher Education, Research and the Arts as part of its research priority programme, "Dimensions of the category Gender - Women and Gender Studies in Hessen." The project analyses the experiences of former Korean nurses in the region around Frankfurt, Germany and Korea and the impact on traditional gender roles in both countries.

In a third project within the framework of Africa's Asian Options (AFRASO), called "Transnational mobility and belonging; Korean Migrants in South Africa," issues including transnational connectivity between country of origin and country of residence are investigated.

Our library collections continue to grow, thanks not only to our own efforts, but also through generous donations by the Korea Foundation as well as individuals. Prof. **Dae Sook KIM**, Dr. **Eja NA**, the Korea Foundation, and the Korea Publication Association, for example, supported us with the kind donation of their valuable collections on Korea. These contributions continue to be catalogued by the Korean Studies librarian.

With the help of continued funding from the QSL Teaching Quality Enhancement Funds, we continue to employ two part-time student assistants who provide invaluable administrative support. In addition, we have managed to secure funds to employ three part-time tutors to support our first year students for the Korean language courses at a beginner level. These funds have been contributing to reducing dropout rates amongst the first year students.

Academic Program:

From the academic year 2017/2018, the Korean Studies will introduce the new independent bachelor minor degree. So far, Korean Studies have seen continuous growth, including the number of registered students and offered courses. As the first-year registration has increased over 100 students, we have managed to increase the number of Korean language classes, and provide new seminars: "Transnational Mobility In and Out of Korea I," "Qualitative Research Methodology." "Modern Korea," "Religion in Korea," "Transnational Mobility and Multicultural Issues in South Korea," "Environmental Policies and Practices in South Korea," "Korea's Past, Present and Future in the Age of Globalization," "Globalization of the Korean Economy" and "Korean Conglomerates."

In the combined undergraduate programme for the BA in Empirical Linguistics and Korean—either as major subject or as minor subject— the students choose from a range of content courses on modern Korean society, culture, history, literature, religion, economics and other humanities and social sciences topics. Our students have also had the opportunity to take part in E-School seminars on Korean society and culture under the auspices of the Korea Foundation Global e-School.

Students can choose to spend a semester at a partner university in Korea (Korea University, Ewha Women's University or Chungang University), for which we have also managed to secure a sponsorship from Asiana Airlines for an airline ticket scholarship, called the Asiana Flying Scholarship, as well as discount tickets for our students. Below are the two main achievements in furthering the academic programme this year:

- The memorandum of understanding (MoU) has been signed in 2017 for exchange programs between the university and Yonsei University as well as Sungkyunkwan University, Korea.
- An independent BA Korean Studies minor program will be launched from October, 2017. This allows students to focus on minoring in the Korean Studies by taking total 60-credit courses independently on Korea, which offers new opportunities for those students interested in various subjects related to Korea.

Academic events:

As part of the AKS Seed Program, the Korean Studies held an international workshop "Home and Away: Transnational Migration, Remittance and Homeland, Korea" on January 27, 2017. The project director, co-researcher, and research assistants presented their research results and actively discussed them with other participating researchers and undergraduate students. 9 presenters and 55 participants joined the workshop and the abstract collection has been published. On June 23, 2017, the department also organized an international workshop, entitled "Transnational (return) migration of former Korean female 'Guest workers' in Hessen and South Korea" as a beneficiary of the funding from the Hessen State Ministry for Higher Education, Research and the Arts. 7 presenters and 40 participants joined this event and the abstract collection has been also published.

Career Seminars:

To meet the demands of the growing number of students interested in working at Korean corporations, the Korean Studies has organized career seminars during each semester. This year, roughly 30 students participated in the career seminar 'Career Path to Korean Companies & Job Training' where KOTRA (Korea Trade-Investment Promotion Agency) and Hyundai Motor joined. While Hyundai Motor presented potential internship opportunities, the KOTRA explained the process of job application particularly for Korean companies, such as LG Electronics, Samsung Electronics and Korea Tourism Organization. Where students proactively asked questions regarding types of internship and the Korean language proficiency, this seminar offered a good chance for students to understand what type of qualifications is required. With a good deal of positive feedbacks from participating students and companies, the Korean Studies will continue to hold this event to bridge interested students and companies.

Project-K Korean Film Festival:

Between 26 and 30 October 2016, Korean Studies in Frankfurt hosted 'Project K – The Korean Film Festival' for the fifth consecutive year. Like the year before, the event took place in the CineStar Metropolis cinema located in Frankfurt's city centre. Almost entirely organized by the Korean Studies students, again with generous financial and organizational support by the Korean Consulate General in Frankfurt as well as by individuals from the local Korean community, the festival presented a number of contemporary films, some of which were screened in Germany for the first time. This included movies such as *Handmaiden* by Park Chanwook, *A Violent Persecutor* and *Train to Pusan*. Again, the films were accompanied by various Korea-related activities such as calligraphy workshops, traditional games, as well as K-Pop events (including theme parties and sing-alongs). A K-Pop dance contest attracted participants from across the nation as well as many visitors. This event provided an opportunity for residents in Frankfurt and from the neighboring areas to experience and encounter Korean culture and film. Furthermore, through this Film Festival, Frankfurt Korean Studies has attracted the attention of high school students, some of whom are considering enrolment to study Korean Studies at Goethe University.

Prof. Yonson Ahn has been the Director of Korean Studies programme and Deputy Executive Director of Interdisciplinary Centre of East Asian Studies (IZO) since December 2014. She taught the following courses in the 2016/2017 academic year: Research Methods and Academic Writing; Introduction to Korean Studies; Transformation of Korea (1860-1910); Migration and the Korean Diaspora; Transnational mobility in and out of Korea; Korea's Past, Present and Future in the Age of Globalisation; Critical Approaches to North Korean Society; Reading Pre-modern Korean History, Society and Culture. She was nominated for 1882 University Prize for excellent lecturer (1822-Universitätspreis für exzellente Lehre).

Yonson Ahn's research interests include transnational migration and the Korean diaspora, multiculturalism in Korea, gender-based violence during conflicts, femininity and masculinity, memory politics in Korea, and the history debate in East Asia.

The Korean Studies staff consists of Prof. Dr. Yvonne **SCHULZ ZINDA**, Professor for Contemporary East Asian Cultures (China/ Korea) and Director of the Korean studies; Dr. **Barbara WALL**, research associate until August 2017; **Kangsun LEE**, Korean language Instructor; **Helene KANG**, librarian for the Korean collection.

Academic program:

Korean studies offer a B.A. (4 years) and M.A. (2 years) program. It is embedded into the International B.A. East Asia that incoporates some compulsory East Asian modules as part of the separate programs of Korean, Japanese and Chinese studies. Its profile is nineteenth to twenty-first century intellectual history, media history and North Korean studies (film, culture). Accordingly, the library has a collection of currently over 800 films, including over 50 North Korean films.

General Information:

Heidelberg University founded in 1386 is one of the most eminent research centers of Asian Studies in continental Europe with a traditional emphasis on South Asia, China and Japan. In recent years, we have begun including Korea in our research and teaching programs in East Asian Studies, History, Art History, Political Science, Sociology and Economy. Korea has been an integral part of a new innovative field of academic inquiry at Heidelberg has been Transcultural Studies (with large-scale English-language postgraduate and research capacities at the federally funded Cluster of Excellence "Asia and Europe"). Since 2012 we have been receiving KF support, enabling us to substantially increase our course offerings for BA and MA students in both Korean language and Korean studies. This support allowed us to establish a Korean Studies curriculum centered on a solid language program and regular seminars on Modern Korean Society and Culture. We have academic cooperations and are exchanging students with our partner universities in Seoul (Seoul National University, Korea University, Yonsei University, Sogang University and Sungkyunkwan University). Dr. Hyojin LEE teaches Korean Language courses (I-IV) and conducts seminars in "Modern Korean Culture, Society and Politics" (B.A. winter and spring 2016/17) and "Korean History in a Global Context" (M.A. spring and summer 2017). Dr Jaok Kwon-Hein conducts seminars in "Gesellschaftliche Entwicklungen und Veränderungen im modernen Korea und Japan" (Social Development and Changes in contemporary Korea and Japan, B.A. winter and spring 2016/17), "Asian Capitalism and Economic Organizations" (MA, spring and summer 2016/17), "Diaspora und Migration im modernen Korea und Japan" (Diaspora and Migration in comtemporary Korea and Japan, BA spring and summer 2017), "Zivilgesellschaft und soziale Bewegungen in Ostasien" (Civil Society and Social Movements in East Asia, BA spring and summer 2017), "Nordkorea in Ostasien" (North Korea in East Asia, winter and spring2017/18) and "Arbeitsmarkt und Arbeitsverhältnisse im modernen Korea und Japan" (Labour Market and Industrial Relations in contemporary Korea and Japan, winter and spring 2017/18)

Other activities:

An international conference, "Korea in Global History: The Long Nineteenth Century and the Foreign Powers" (19 - 21, May 2017), took place at the Karl Jaspers Centre in Heidelberg. The conference revised one of the central problems of modern Korean history with an emphasis on the global context, namely why Korea lost its national independence in the age of imperialism. This question has been asked before by several generations of Korea historians, but this conference posed it again, considering the insights of global history and included historians whose primary research expertise lies in other world regions.

The Korea conference started on Friday, May 19, at 9 am with the first day putting the

thematic emphasis on the question: "Re-Interpreting History?" The second day of the conference then focused on "The Demise of the Korean State, Re-Constitution of Korean Culture". It rounded off by a dinner for the conference participants on Saturday evening, May 20. Publishing plans and further practical issues concluded the event on Sunday morning. There were six sessions and more than 20 scholars from Europe, Korea and the U.S.A addressed on their research projects. Students of Cluster of Excellence Asia and Europe and East Asia Studies in Heidelberg University also actively participated in the discussion. This conference was funded by the Academy of Korean Studies and DFG (Deutsche Forschungsgemeinschaft). Heidelberg University library received KF support program (Distribution of Resources for Korean Studies) and ordered books on Korea in 2017. Korean books in the field of humanities, social science, culture, arts and Korean textbooks arrived in our library. These will be a great help for both scholars and students to study on Korea.

The group of Korean Defense Academy visited our center and had a meeting with our faculty members on September 14, 2017. We had a discussion on the current situation in Korea learning from the experience of the German reunification. We also discussed on the future and possibility of Korean Studies in Europe.

Scholars' Reports

Prof. Dr. Aurel Croissant is Professor of Political Science and Vice Dean of Research at the Faculty of Economics and Social Sciences, Ruprecht-Karls-University, Heidelberg. He has spent a total of four years as visiting researcher at major universities and research institutes in Korea at various stages of his career. His main research interests include the comparative analysis of political structures and processes in East and Southeast Asia, the theoretical and empirical analysis of democracy, civil-military relations, terrorism and political violence. Aurel Croissant has published 21 monographs, edited volumes and special issues of German and international journals, and over 150 book chapters and journal articles and his research has been published in German, English, Spanish, Korean, Indonesian and Russian. He is also referee for numerous German and international journals, publishers and academic funding institutions. And he is coeditor of the book series Politik in Afrika, Asien und Lateinamerika (Politics in Africa, Asia and Latin America, VS Verlag) and Weltregionen im Wandel (World Regions in Transition, Nomos), the Asian Journal of Political Science, the Journal of Contemporary Southeast Asian Affairs, and Democratization, and sits on the Academic Advisory Boards of the Sustainable Governance Indicators (SGI) and the Bertelsmann Transformation-Index (BTI).

Prof. Dr. **Harald Fuess** is Professor for Cultural Economic History at the Cluster for Excellence "Asia and Europe in a Global Context". Trained as a historian of Japan, his Korea-related research projects and publications explore the history of the European encounter with Korea in an East Asian context in commerce, culture, and diplomacy from the middle of the nineteenth century.

Dr. Jaok Kwon-Hein is a lecturer at the Centre for East Asian Studies since 2016. In 2012, she joined the University of Heidelberg and worked for several research projects at the Max-Weber-Institute of Sociology and lectured on the Korean society and economy at the Cluster for Excellence. Prior to joining Heidelberg University, she was a lecturer in the Graduate School of Social Sciences at Hitotsubashi University in Tokyo, where she had obtained MA and PhD (Sociology). Her research interests have focused on gender and labour, social

movements, Asian capitalism and business elites in East Asia. She is currently working on the publication of her dissertation, *Hypermasculine State and Rural Modernity and Women – 1960s-70s in South Korea*. She is also working on the research project, *Gender and Management in South Korea – Business Magazine Analysis* funded by the Academy of Korean Studies (2016-2018).

Dr. **Hyojin Lee** studied Department of East Asian Culture at the Kansai University (MA and PhD) and conducted research into the history of Korean Confucianism and the modern knowledge in the colonial period. She was a lecturer and part time researcher in Institute of Oriental and Occidental Studies at Kansai University, Osaka. She also worked as a Korean language instructor for the King Sejong Institute Foundation of Osaka. Her dissertation was published in 2016, *The Study of Korean Confucianism in Keijō Imperial University: formation and Development of Modern Knowledge* (Tokyo: Bensei Shuppan). She was a lecture of Kansai University and she is now Lecturer for Korean Language and Korean history and culture at Heidelberg University.

Prof. Dr. Markus Pohlmann is Professor for Sociology at Heidelberg Max-Weber-Institute. His main research interests include the analysis of management and work organization in industrial corporations as well as the macro-analysis of the economic development in East Asia, Germany, and the US. He has recently lead several research projects on East Asian globalisation with Korea as one of the societies under investigation:

General Information:

In September of 2016, the Korean Studies Program at the University of Tübingen successfully launched its five-year, "Tübingen Global Korea Project" (TGKP), supported by the AKS Core University Program for Korean Studies Grant (September 2016 to August

2021). Under the TGKP, the department recruited a new postdoctoral fellow/assistant professor, Sungjo Kim (Ph.D., East Asian Studies, University of Toronto), and a doctoral candidate/researcher, Isabella Jukas (Double M.A., Korean Studies, University of Tübingen & Seoul National University), to join the faculty from January 2017. Also as part of the TGKP, the department hosted two internal/regional workshops (February 3-4, 2017, and June 16-17, 2017), the inaugural international conference ("Nationality and Transnationality in Modern Korea," July 7-8, 2017), and will host the AKS Core University Program for Korean Studies Directors' Meeting in August 8-11, 2017.

Academic Program:

The department currently offers five degree programs, including Bachelor of Korean Studies, Master of Korean Studies, Double Master of Korean European Studies (MAKES), Master of Politics and Society of East Asia (MA PGO), and Doctorate of Philosophy in Korean Studies. Our BA program continues to grow and in the winter semester of 2016/17, 102 new students enrolled in Korean Studies; for the 2016/17 academic year, a total of 316 undergraduate students were enrolled in our department. Fifty-five of our undergraduate students are currently studying in Korea for their one-year of study abroad at one of the ten universities with which we have exchange programs.

Since the introduction of the master degree program in 2014, the number of MA students has also grown, and currently 15 students are enrolled in the program. In early 2017, we also had our first two graduates of the Double Master Program, the "Master of Korean European Studies" (MAKES), where students earn two MA degrees, one each from the University of Tübingen and from Seoul National University. Five MAKES students are currently enrolled at Seoul National University (SNU) and two other MA students are at Korea University as exchange students, while eight MA students are studying in Tübingen.

The department has continued to run its Korean branch, the Tübingen Center for Korean Studies at Korea University (TUCKU), and the King Sejong Institute in Tübingen.

Seminars and Lectures:

For the inaugural international conference of the Tübingen Global Korea Project (TGKP), "Nationality and Transnationality in Modern Korea" (July 7-8, 2017), scholars from Korea, Canada, the US, and Germany gathered to engage in in-depth and innovative discussions on the interrelated topics of "Nationality and Citizenship," "Migrations and Border Crossings," and "Cold War Connections and Transnational Organizations." The department has also hosted the "AKS Core University Program for Korean Studies Directors' Meeting" in August 8-11, 2017. Directors of 26 Korean Studies Programs worldwide gathered at this forum to establish an international cooperative network, amplify the synergy among researchers, and to share strategies for sound program developments. The department also organized two internal/regional workshops. The internal workshops are designed as forums to assess individual research progress and to exchange constructive feedback especially for PhD candidates, but also open to other researchers. We invited researchers from other universities from the region (two PhD candidates from the University of Frankfurt for the February 3-4, 2017, workshop and a postdoctoral fellow from Heidelberg University for the June 16-17, 2017, workshop) to participate in order to not only provide them with a productive research forum, but also to foster institutional exchanges and cooperative opportunities for young

scholars.

Dr. **Taejin Hwang** helped to launch the Tuebingen Global Korea Project by serving on the new faculty hiring committee and by organizing the inaugural international conference (July 7-8, 2017), "Nationality and Transnationality in Modern Korea," with Professor You Jae Lee. She also organized and facilitated the weekly lecture series for the 2016/17 winter semester and taught seminars on Korean history from pre-modern to contemporary periods. Dr. Hwang presented her research at invited talks and conferences, including: (September 2016) *Bringing 'Home' Our Cold War's 'Children': The U.S. Amerasian Immigration Acts of the 1980s*, at Think Tank Adoption, Copenhagen; (November 2017) *Cold War Crossings: From American Military Camptowns in Korea to Transpacific Migrations of 'GI Babies' to the U.S.*, Seventh Korean Studies Conference in German-Speaking Area, University of Bonn.

Isabella Jukas studied Korean Studies, English/American Studies, and International Studies at Tübingen University and Seoul National University. Her MA thesis deals with the Catholic Mission of the St. Ottilien Congregation in colonial Manchuria. Since January 2017, she has been a research assistant at the Department of Sinology and Korean Studies. For her PhD dissertation, she is currently conducting research on North Korean foreign affairs in the 1970s and '80s. During the 2017 summer semester, she taught an undergraduate language course, "Chinese Characters for Learners of Korean," and co-organized the internal/regional PhD workshop (June 16-17, 2017) that is part of the AKS Tübingen Global Korea Project.

Dr. **Euna Kim** has continued teaching Korean language courses. In November 2016, she participated in the Seventh Korean Studies Conference in German-Speaking Area, University of Bonn and presented a paper entitled *Ein interkultureller Vergleich der Höflichkeitsformen im Koreanischen und Deutschen – auf Basis der Sprechakte der Ablehnungen*.

Jee-Un Kim continued her duties as research assistant and her dissertation project on the rise of copyrights, piracy, and the Korean popular music industry with a focus on the 1996-2013 period. She participated in the Korean Studies Graduate Students Conference (Sept. 21-24, 2016) in Copenhagen with a presentation on *The Soribada Cases: Copyrights, New Technologies and the South Korean Music Industry in the Digital Age* and a talk (May 12, 2017) entitled *From Legal Pirates to Criminal Filesharers* at the University of Malaga. Jee-Un is the coordinator for the tutorial program for academic reading and writing for the first semester undergraduate students and also offered a course on the topic of Korean popular music and globalization.

Dr. Sungjo Kim joined the department as a Postdoctoral Fellow/Assistant Professor of Korean Studies in January 2017. He received his Ph.D. in November 2015 from the Department of East Asian Studies at the University of Toronto, where he specialized in the modern and contemporary history of Korea. He taught Korean history and culture at the University of Toronto and York University, and then did a postdoctoral fellowship in the Needham Research Institute at the University of Cambridge. Dr. Kim is currently turning his dissertation into a book monograph tentatively entitled *The Countryside and the City: A Spatial Economy of the New Village Movement in 1970s South Korea*. This study considers the hegemonic power of capitalist modernity, and contributes both to a critical understanding of the historical experience of industrial modernization in the non-West, and to the rethinking of politics between living spaces and capital. Beyond this project, he also explores the Cold War culture and technology in Korea, contextualizing Korean cases within the broader framework of world history. Dr. Kim participated in the Twenty-eighth Biennial AKSE Conference, Prague, April 21-23, 2017 and presented a working paper entitled *Unifying Time and Space in the Countryside: The Cold War Rice and the Green Revolution in 1970s South*

Korea. In Tübingen, he has taught courses such as "Critical Research and Writing in Korean Studies" and "Cultural History of Modern Korea."

Youngeun Koo is a doctoral candidate at Tübingen. In 2016/17, she convened BA courses on Korean migration, adoption, and transnationalism. She also presented her research on Korean adoption at several conferences, including (November 2016) the Seventh Korean Studies Conference in German-Speaking Area at Bonn University and (June 2017) the Global Korea Convention, organized by the Overseas Koreans Foundation, in Seoul. From March to December 2017, she is conducting fieldwork in South Korea. During this period, she is affiliated with the Kyujanggak Institute for Korean Studies at Seoul National University as a junior fellow.

Jun.-Prof. You Jae Lee finished a book manuscript with the title *Koreanische Migrationsgeschichte in Deutschland* (Korean Migration History in Germany). Professor Lee also organized with Taejin Hwang the first international conference of the AKS Tuebingen Global Korea Project, "Nationality and Transnationality in Modern Korea" (July 7-8, 2017).

Dr. **Tobias Scholl** is a postdoctoral fellow and his research interests lie in Colonial and Modern Korea and in Korean-Japanese relations. His forthcoming book deals with the "Construction of Sameness and Difference" in colonial Korea and shows how Japanese scholars and bureaucrats tried to use history and the "common ancestor theory" to incorporate colonial Korea into Japan proper. It describes how the colonizers constructed this incorporation of the colonized without endangering the colonial order and how the Koreans as colonized reacted to this colonial discourse. Besides teaching classes on premodern and modern Korean history, translations, and reading Korean texts in the mixed script, he is preparing a textbook on introduction to *hanja*.

Sunhae Shin joined the department as a language lecturer in April 2017. She is dispatched from the Korea Foundation to work at Tübingen for two semesters, and during this period, she will teach a variety of Korean language courses for undergraduate students.

General Information:

Since its establishment in 1987 with the kind support of the Korea Research Foundation, and subsequently the Korea Foundation, SOAS Centre of Korean Studies (CKS)

has been the leading academic centre of its kind in Great Britain. It coordinates work done on Korea in various departments of the School, and offers expert knowledge and advice on Korea to interested outside parties. In 2016/17 22 academics, including full-time SOAS academic staff as well as professorial research associates, research associates, research fellows and post-doctoral fellows were linked to the Centre. In addition, it hosted twelve visiting scholars from South Korean academic institutions and government ministries. The Centre is currently chaired by Dr Charlotte Horlyck.

In 2016/17 CKS initiated and organized more than 32 events, including seminars, workshops, symposium, book launches, panel discussions, film screenings and artists' talks. Some were co-hosted with other institutions and centres. Several have been funded by partners such as the Korean Embassy, the Korean Cultural Centre, and the British-Korean Society.

CKS administers several postgraduate bursaries. This includes three to five bursaries valued at £6,000 each for students undertaking a full-time postgraduate Korean Studies programme. The Sochon Foundation provides CKS with scholarships for students undertaking full-time post-graduate programmes in Korean Studies. The Sochon Foundation scholarship, valued at £7,500 in total is for tuition fees with the remainder, if any, for living costs.

All members of CKS are research active. CKS members produced more than 27 published outcomes in 2016/17.

Oxford

University of Oxford Faculty of Oriental Studies

General Information:

The Korean Studies staff consists of Dr. James B. LEWIS, University Lecturer in Korean History (Fellow of Wolfson College); Dr. Jieun Joe KIAER, Young Bin Min-KF Associate Professor in Korean Language and Linguistics (Fellow of Hertford College); Dr.

CHI Young-hae, Korean Language Instructor; Mr. **Minh CHUNG**, Head of Bodleian Chinese Studies Library & Korean Collections; and other library staff.

In the Bodleian Library, the Korean cataloguing project funded by the Korea Foundation ended October 2016. A total of 2,142 records have been created. In addition, some 40 titles have been added to the Special Collection.

The Window on Korea (a five-year project sponsored by the National Library of Korea) ends by the end of 2017. Application to extend the project for another five years is being processed. As part of the project, Oxford held two book reading events to promote the Window on Korea as well as Korean Literature. The first event was on September 26, 2016, when Deborah Smith, co-winner of the Man Booker International Prize in 2016 was invited to talk on translating *The Vegetarian* – a novel by Han Kang. The second event was on November 23, 2016, when Daniel Hahn was invited to talk on the book *The Hen Who Dreamed She Could Fly* by Sunmi Hwang.

The National Library of Korea has given us access to their digitized materials which include old books and manuscripts, old maps, official gazettes, newspapers, doctoral dissertations in Humanities, and Japanese materials up to 1945.

In the past, we have had only one fund from the Humanities, because the study of Korea has mainly focused on history, literature and language, but in recent years the demand for material on the social and economic transformation of Korea has grown rapidly. We now have a new fund for Korean Studies from the Social Sciences. In addition to the database subscriptions of DBpia & KRpia and KISS, we have also subscribed to the North Korea Pro with the support of the Social Science Section.

Apart from the usual donations from the Korea Foundation and the National Library of Korea, we have also received a large set of 20 volumes (works by Baek Yong Seong) from the Academy of Buddhist Studies, University of Dongguk.

Academic program:

Ms. Xin Wei began her doctoral studies in Michaelmas term 2014. She completed her qualifying examination in Trinity term 2015. She is the recipient of the Oxford-Marriott-Wolfson Scholarship in Korean Studies. Her DPhil thesis is entitled *The Literary Chinese Cosmopolis*, which, set against the backdrop of literary Chinese as the cosmopolitan written language across East Asia, examines two outstanding contemporaries of the Chinese literati in the ninth century, Ch'oe Ch'iwŏn from Silla Korea and Sugawara no Michizane from Heian Japan. She passed her viva on August 28, 2017 and has taken up a one-year Korea Foundation Postdoctoral Fellowship at Boston University, USA, under Professor Wiebke Denecke.

Mr Sigfrid Östberg has spent most of 2016-17 conducting archival research at the Shiryō hensanjo in Tokyo University. He continues the preparation of a thesis entitled *Nineteenth century Japanese–Korean mutual perceptions*, 1811–1882.

Ms Jean Hyun continues her preparation of a DPhil thesis entitled *The History of the Malgal: Early Korea's Northern Neighbours* with support from the Clarendon Fund Scholarship.

Ms. Yeogeun Kim is the recipient of the Oxford-Wolfson Min Sunshik Graduate Scholarship in Korean Literature and began her doctoral work from October 2016. She is reading for a thesis entitled *The Life of Popular Literature in Words and Images: Two Love Stories from Pre-modern Korea*.

Mr. Yiu Siu began his doctoral work from October 2016 and is reading for a thesis entitled *Maritime Exclusion in Traditional East Asia*.

Mr. Sang Yeoup Han finished his Master of Studies in Korean Studies degree with a thesis entitled *Mobile Instant Messaging in Korean: Linguistic Variations and Patterns*.

Scholars' Reports:

Dr. **Jieun Kiaer** finished *The Routledge Course in Korean Translation*, which was published in 2017. She also delivered a paper on translating emotions and interpersonal relations in modern Korean literature at the Oxford Comparative Criticism Conference (OCCT) in March 2017. She has also hosted a number of translation-related seminars, to which translators, such as Deborah Smith, contributed. In addition, she hosted a Translation in East Asia workshop in September 2017 with Jennifer Guest and Amy Xiofan Li. She published a paper on Korean-English hybrid words in *Asian Englishes*. Currently, she is finalizing a new manuscript to be published by Routledge, entitled *Translingual Words: An East Asian Lexical Encounter with English*, which is forthcoming in January 2018.

She continues to teach undergraduate courses on the histories of Korea and Japan, contributes to the teaching for the Master of Studies in Korean Studies and the Master of Philosophy in Traditional East Asia, and supervises graduate students.

Sheffield

The University of Sheffield School of East Asian Studies

Academic Programme:

General interest in Korea and Korean Studies has continued to increase steadily. However, the past three years has shown a dramatic increase in students admitted to do a degree in Korean Studies, or as a dual honours degree with another subject. For the academic session 2017-2018, 58 students have been admitted to do a Korean Studies degree programme, and there are 30 students doing the year abroad in Korea (the second year, called Level 1+) for intensive language tuition at one of Sheffield's partner universities. There are currently 20 students at Level 2 (third year) and 12 students in Level 3 (fourth year). At the 2017 graduation ceremony, there were 13 graduates in Korean Studies, six of whom received a first class honours degree, a greater proportion of students receiving this level of qualification than in any of the other degree programmes in the department.

The School welcomed Dr Kate Taylor-Jones as Senior Lecturer in East Asian Studies in September, 2015, and in September, 2017, Dr. Markus Bell as Lecturer in Korean and Japanese Studies. A description of their interests and research is given below.

Scholars Reports:

Dr. Markus Bell, a social and cultural anthropologist, joined Sheffield University's School of East Asian Studies in September 2016. He lectures on migration, memory, kinship, history, food and anthropology with a focus on the two Koreas and Japan. He convenes a seminar series on East Asian studies, bringing together scholars and researchers from across the UK, Europe, Asia, and North America. Dr. Bell is currently involved in a number of joint research projects with scholars based in the UK, Asia, and North America. He writes regularly for online publications such as The Conversation, National Public Radio, The Guardian, Fortune Magazine, and East Asia Forum, and regularly offers comment for media outlets, such as Vice, Al Jazeera, The LA Times, and the Washington Post on events in East Asia.

Dr. Bell's research explores Cold War and contemporary migration to and from North Korea (DPRK), and the significance of inter-generational memories of movement and resettlement in shaping a diasporic, North Korean identity. He contextualised this migration within the larger geo-political processes and historical forces that shaped the latter half of the twentieth century in Northeast Asia, and the epoch defining challenges that continue to cast a long shadow on relations between North Korea, South Korea, and Japan.

Dr. Bell lived in Korea for six years, studying at Pusan National University, Yonsei University, and Seoul National University (MA degree). He lived in Osaka for a year while doing during doctoral research, and was affiliated with the Osaka University of Economics and Law. He received the PhD from the Australian National University, School of Culture, History and Languages. He is currently working on several academic publications, including a book manuscript entitled *From Patriotic Revolutionary to Imperial Sympathizer: Memory, Identity and Migration to North Korea*.

Dr. **Judith Cherry** retired at the end of the academic year 2016-2017 after nearly four decades of association with the School of East Asian Studies.

Mrs. **Sukyeon Cho** reports that she and Ms. **Yeon-Jeong Kim**, continued to teach both the intensive Korean language modules for students doing a Korean Studies degree and the non-specialist modules for students from other degree programmes who are doing Korean language as an option. There are significantly greater number of students both doing Korean Studies and students who are taking the language as an option than in previous years.

It will also be made freely available online through the University of Sheffield's Open Access scheme. The article is based upon research funded by a Korea Foundation fieldwork grant for 2016.

Dr. Seung-young Kim continued teaching the following modules "Two Koreas and their Neighbours, International Relations in East Asia", "Modern Korean History", and "China and Korea in the Modern World". He was also the School's Director of taught postgraduate programmes, successfully launched a new MA degree in 'Politics and Media in East Asia' from Autumn, 2017. He has two research articles under review: "Cautious Realist: George Kennan and the Korean War", and "Open Door or Sphere of Influence?: The Diplomacy of the Japanese-French Entente and Fukien Question, 1905-07". He is preparing for publication a monograph on the turning points of diplomacy in Northeast Asia during the twentieth century.

She has been the recipient of a variety of grants including an AHRC Early Career Fellowship and has presented her my work across the globe in a variety of formats. She has lived and worked in Japan, Australia, France, Belgium and South Korea and conducts research around the globe focusing on a variety of topics. She is also involved in various women's education and rape and sexual abuse prevention and aid programs. She has a long-standing record of external engagement – working with film festivals, distributors, schools and diverse audiences on the topic of East Asian cinema and culture.

Dr. **Taylor-Jones** teaches modules on East Asian Cinema, East Asian Popular Culture, Korean Cinema, and Media, Culture and Society in East Asia.

SAPIENZA Università di Roma (Sapienza University of Rome)

Dip. Istituto Italiano di Studi Orientali - ISO (Dep.Italian Institute of Oriental Studies)

General Information:

Korean Studies at Sapienza University of Rome offers BA (3 years), MA (2 years), and PhD courses. The classes include Korean Language and Translation, Korean Literature, History of Korean Civilization, Korean Art History, Korean Philology and Modern Korean and Japanese Societies and Politics. In 2016 the Double Degree MA program for Chinese and Korean curriculum (MOU signed with Hanyang University) kicked off and we had increase in enrollments: including first, second and Hanyang University exchange students, we have a total of 14 students. The team of Korean Studies curriculum is composed of Prof. **Antonetta BRUNO**, a Tenure Assistant Professor in Korean Art **Filippo SALVIATI** and one full time Korean language lecturer **KIM Oenjoung**. Thanks to KF three years funding for establishing a new professorship, Sapienza opened a new position for an Assistant Professor in History of Korean Civilization, and Dr. **Giuseppina DE NICOLA** has been appointed for this position through a National Competition Exam. Sapienza has also been granted by KF of one Internship program for Korean Language and one Visiting Professor for Korean Literature. We have a new PhD student **Giovanni VOLPE** who passed the selection exam successfully and obtained a scholarship for all 3 years of PhD course at Sapienza University.

The University and the Korean Studies section is organizing the AKSE 2019 conference which is one the biggest academic events in Korean Studies. In January 2017 the Center of Korean Studies and Research has been established at University. A peer-reviewed Korean Studies Journal (in English and Italian) is being published as a result of cooperation between

Sapienza University and Aracne Publishers. The Director is Prof. **Antonetta BRUNO** and it is composed by an international scientific and editorial board. Two volumes have been published so far, one under the title *Corea: K-Pop multimediale* (Korea: Multimedia K-Pop) and another entitled *Uno sguardo alla Corea contemporanea - arte, lingua, cibo, politica e famiglia in una raccolta di saggi* (A look on Contemporary Korea – art, language, food, politcs and family in a collection of essays).

During past three years, our academic activities, numbers of students, the library stocks, lecture hours and research output all increased remarkably.

Academic program:

The Korean Studies curriculum was supported for the third year by the Korean Studies Incubation Program of the KSPS (Seed Program of Korean Studies Promotion Service of Academy of Korean Studies). Financed by AKS, a final workshop of the Seed Project was convened on December 5, 2016. Discussants in various fields were invited for productive advice and consultation: for studies on socio-cultural field, **Vladimir Tikhonov** from Oslo University in Norway; for studies on language, **Thorsten Traulsen** from Bochum University in Germany; and, for studies on art, **Beatrix Mecsi** from ELTE University in Hungary. Three invited speakers presented their articles: **Giovanni Volpe** (Ph.D candidate); **Sojin Yang** (a dispatched KF Literature Professor); and **Somin Chung** (a dispatched KF intern, teaches Korean for 2016/17). At the same time, members of the project presented on their theoretical backgrounds, previous progress, and future book plans: **Giuseppina De Nicola** on Korean family, **Imsuk Jung** on Korean linguistics, **Antonio Fiori** on Korean politics, **Filippo Salviati** on Korean Art, and **Antonetta L. Bruno** on Korean food.

The Center of Korean Studies and Research, with the support of One Asia Foundation grant, organized a number of lectures in 2016. About 20 experts will be invited yearly. In the first semester, six experts were invited for special lectures to deepen students' understanding on the issues of Asian Studies. Supported by Arts Council Korea, seminar meetings with novelist HyeJin Shin were held on November 17 and December 1.

From March to April 2017, supported by One Asia Foundation, ten more scholars were invited for special lectures. One hundred students joined these workshops, and we had a chance to hear on various Asia-related topics, such as labor, globalization issues, identity politics, cultural movements and transformations, transnationalism, urbanization, connections between the present and the past, women's agency, migration, etc. Supported by Literature Translation Institute of Korea, translation workshop with a poet, Jeong Hoseung, was held on May 18 and 19.

General Information:

Korean language course was discontinued at the Oslo University in 2006 (originally established in 2000), due to low enrollments. Norwegian students may, however, attend the

Korean language subjects at Stockholm University (Department of Asian, Middle Eastern and Turkish Studies) and have the grades recognized and included into their diplomas in Oslo. However, in Oslo too there are some Korea-related courses, both on Bachelor and Master levels. They are mostly taught by **Vladimir TIKHONOV** (Pak Noja, professor, Department of Culture Studies and Oriental Languages), with assistance from **Elisabeth SCHOBER** (associate professor, Department of Social Anthropology, Faculty of Social Science). Oslo University continuously enjoys brisk exchange of students with its seven partner universities in South Korea. It also has an exchange agreement with Kim Il Sung University in Pyongyang (North Korea) since 2010, with a focus on cooperation between medical faculties; the agreement, however, did not result in any personnel exchange so far.

Academic Program

On the BA level, 10 credit courses in Korean society/politics and religion/philosophy are being offered every other year. A course on North Korea is offered annually. These courses are usually taken by 40-50 students on average. On the MA level, there is a sizable Korea-related content in such courses as *Approaches to East Asian Culture and History*, *Topics in East Asian Culture and History* etc. East Asian Culture and History (EACH) is an umbrella 2-years MA program which allows the students to write their dissertations on any East Asian society, Korean included. Currently, one EACH Master student writes her thesis on Korea, to be completed by December 2018.

General information:

The main news about the Korean studies program is that on June 1, 2017, by an order of the university president, the **Department of Korean Studies** was established as a separate entity. Before the Korea-relevant curriculum, with more than 40 courses related to Korean studies, used to be split in between two different departments - Department of Philology of South-East Asia and Korea and Department of History of the Far East – depending on whether the students majored in philology or history of Korea. It is consolidated now. This year, the year when we celebrate the 120th Anniversary of Korean studies in our university, we became one independent department. Its faculty members are:

Prof. **Sergey O. KURBANOV** (habilitation) – a specialist in history of Korea, the acting chair of the Department of Korean Studies (since June 1, 2017), director of the Institute of Interdisciplinary Studies on Korea, full professor of the Faculty of Asian and African Studies, Saint Petersburg University.

Dr. **Inna V CHOI** (Ph.D.) – a specialist in Modern/Contemporary Korean Literature, associate professor.

Dr. **Anastasia A. GURYEVA** (Ph.D.) – a specialist in pre-modern Korean literature, associate professor.

Alexey A. VASILIEV (M.A.) – a specialist in Korean Linguistics, senior lecturer.

JEONGYang-ok (M.A.) – a specialist in Korean dance, assistant professor.

Natalia V. DMITRIEVSKAYA (M.A.) – a specialist in contemporary Korean history

Academic Program:

There are BA, MA and PhD. programs. There are two majors taught at the BA level: Korean Philology and History of Korea. Six programs are offered at the MA level: Languages/Literatures/History/Culture/International Relations/Economics/Religions of the Peoples of Asia and Africa (with a focus on Korea). Ph.D. Programs have three specializations: History/Languages/Literature of the Peoples of Asia and Africa.

As for the enrollment with the full curricula (over 40 Korean studies-related disciplines taught), in 2016-2017, we had second and fourth-years students majoring in Korean philology, third-year students majoring in history of Korea, second-year students enrolled at MA program (History/Politics and International Relations/Economics), and two doctoral students majoring in history of Korea.

Other Activities:

In 2016, we had prolonged the Academy of Korean Studies-sponsored project: AKS-2015-OLU-2250003. Three faculties are participating: Faculty of Asian and African Studies, Faculty of Sociology, and Faculty of International Relations. Our Department has been implementing several research and educational projects within its framework. In November 2016 and April 2017, we traditionally held the TOPIK examination organized with support of General Consulate of the Republic of Korea in Saint Petersburg.

In September-December, 2016, under the aegis of the Association of International Participation, we held Korean Literature Translation Seminars for Saint Petersburg University students and graduate students. Dr. Lee San Yun (a translator of contemporary Korean literature) gave a small talk on translation issues. History of Korean Studies in Vladivostok goes back to 1900, when Korean language was first taught to the students of the then Far Eastern Institute. Unfortunately, the tradition of Korean Studies was interrupted by the tragic events of the first half of the twentieth century, and was fully restored only in the 1970s. Today, Vladivostok's Department of Korean Studies is one of the biggest centers of Korea research and teaching in Russia with more than 150 students enrolled in BA and MA programs in Korean Studies, and more than 100 other students, who chose Korean language as optional subject or additional training.
