**2. Academic Program:** You may include here reports on the academic programme of study at a university or other academic institution, including reports on new developments in the programme of study, the number of students pursuing a particular degree course, numbers of graduates, or any other information relating to the academic programme of Korean Studies during the past year.

**3. Seminars and Lectures**: You may provide a list of seminars and lectures on Korea at your university during the past year. For each event, please give the date (in the format month-day-year), title of the talk, and the event and venue.

**4. Other Activities:** Activities relating to Korean Studies which took place in your institution or country during the past year. Reports of cultural events and radio and TV programmes on Korea should be included here.

**5.** Scholars' Reports: You may include any papers presented, research undertaken or contemplated, performances presented, conferences attended, or any other scholarly activity related to Korean Studies. Publications, however, should NOT be included here, but under category 6. Please note that a separate paragraph should be written for each person for whom information is provided. For talks and paper presentations, the format should be: date (month-day-year), title of the paper, name of the event, and name of the venue.

**6. Publications:** You may include here you own publications or the publications of anyone else in your country which may be of serious interest to scholars of Korean Studies. You should NOT list any publications that are due to be published in the following academic year. As a model, see the format used under entries for any university.

**7. Announcements**: You may include here announcements on any events pertaining to the academic study of Korea.

**PLEASE NOTE: Romanisation** of Korean words and terms can be done according to either the **Revised Romanization System** or the **McCune-Reischauer System** unless the **Yale System** is used for linguistic purposes or a conventional spelling of a name is used. **Spelling** of English words should follow **American** conventions. Please do not use *Hangeul* or Chinese characters and do not use superscript text since it will appear too small to be easily readable.

#### Information should be provided as either an email attachment or on a diskette. Any materials MUST be in MSWord. Materials to be included must reach the Editor by 31 JULY 2019 at the latest.

# A WORD FROM THE PRESIDENT

As of September 2018, we have gathered a large number of paper proposals and are now reviewing those to decide the program for the 29<sup>th</sup> AKSE Conference in Rome (April 11-14, 2019). By the end of November or early December, we will send out invitations. I think we should express our warm appreciation for the extensive planning and organisational work already done by Professor Dr. Giuseppina De Nicola and Mr. Giovanni Volpe of the Institute of Oriental Studies (ISO), Faculty of Philosophy and Letters, University of Rome Sapienza, who will be our host. Preparations are advancing, and we will issue informative announcements towards the end of 2018, so please watch the AKSE website and the Korean Studies email list for updates.

I am happy to report that the European Programme for the Exchange of Lecturers (EPEL) has again received approval for funding by the Korea Foundation. Over the summer, the participating institutions provided good reports on lectures, and detailed financial information was submitted by our Treasurer, Dr. Koen De Ceuster, in between trips to P'yŏngyang. The Korea Foundation accepted our report for 2017-2018 and approved funds for the third and final academic year (9.2018 to 9.2019) in our current three-year Memorandum of Understanding. On behalf of the AKSE Council, I gathered applications for the academic year 9.2019 to 9.2020 and have just sent those to the KF. In short, the EPEL program is healthy and active. As usual, reports for 9.2018 to 9.2019 will be due in the summer of 2019, so please make notes over the coming year of attendance at EPEL lectures and also note any positive feedback from your students and colleagues for the report. EPEL is designed to support institutions with small numbers of staff in need of filling out their academic programmes with lectures on fields they cannot cover. So, please apply in response to announcements. Just remember to look at the website in advance for the application template and please remind your visiting lecturers to apply for their reimbursements immediately after their visits. If we do not receive reimbursement applications by late August, then it is too late for your visitors to be reimbursed.

The most recent Graduate Student Conference took place in Rome in September (27-29), 2018 and was hosted by Mr. Giovanni Volpe of the Institute of Oriental Studies (ISO), Faculty of Philosophy and Letters, University of Rome Sapienza. By all accounts, especially past and present participants, the Graduate Student Conference is a very successful activity and is ably run by student volunteers. I encourage students and others to read the report included in this issue of the Newsletter, and I encourage colleagues at institutions across Europe to send their students to the Conference.

The website continues to disseminate information to AKSE members and the global community. I would encourage AKSE members to post to the Korean Studies Discussion List (koreanstudies@koreanstudies.com) in the first instance for maximum exposure. Generally, we select notices from the Discussion List for re-posting on the website, but please feel free to send notices about scholarships, post-doctoral positions, and academic teaching or research posts to myself or to Dr. Giuseppina De Nicola for the AKSE website.

As I have done before and will continue to do, I want to thank Prof. Vladimir Tikhonov for his tireless patience in producing this Volume 42 of the AKSE Newsletter. The Newsletter is an important historical document as well as offering current information on AKSE members, their institutional programs about Korea as well as carrying information on their students and colleagues. Please continue to submit your annual reports in the summer for fall publication. The next deadline will be July 31, 2019.

I look forward to seeing many of you at the next conference in Rome in April 2019.

# Please observe the following:

1) Submit your next report according to instructions given below. The format of your submission should follow the style in the entry for your country and university. Please do not submit the same reports that you used for AKS or the Korea Foundation since they ask for items that are not usually included in AKSE newsletters.

2) As AKSE is becoming more globalized and interacts more with scholars in both America and Korea, there is more pressure to adopt American spellings of English. For future issues, American spelling conventions will be preferred.

3) For now, either of the two main romanization systems is acceptable - **McCune-Reischauer** or **Revised Romanization**. As in the past, the Yale System can be used for linguistic purposes, and a non-standard Romanisation is acceptable if used in a title or if it is the preferred spelling of a person's name, such as Syngman Rhee.

4) Please do not submit any text in Korean or Chinese characters, and please use standard English forms of punctuation, especially with quotation marks. I advise NOT to include any hyperlinks as they make the text difficult to edit.

#### <u>CONSTITUTION OF</u> <u>THE ASSOCIATION FOR KOREAN STUDIES IN EUROPE</u> (as amended in 2009)

# NAME

**1.** The name of the Association shall be 'The Association for Korean Studies in Europe' (AKSE).

# **OBJECTS**

2. The Association shall be non-political and its objects shall be:

- to stimulate and to co-ordinate academic Korean Studies in all countries of Europe;
- to contribute to the spread of knowledge of Korea among a wider public.

The objects of the Association shall be attained:

- by organizing academic conferences on Korea;
- by issuing a newsletter;
- by encouraging and facilitating co-operation with other organizations having aims consistent with its own objects.

#### **MEMBERSHIP**

**3.** The Association shall consist of Full Members in the categories of Ordinary Members and Honorary Members, and of Associate Members in the categories of Individual Associate Members and Corporate Associate Members.

Ordinary Membership is open to persons permanently resident in Europe with a serious academic interest in Korea. Individual Associate Membership is open to persons not permanently resident in Europe. Applications and proposals for Membership are to be addressed to any member of the Council and decided upon by the Council of the Association.

4. Members shall pay an annual fee to be determined by the Council.

Members may be exempted partially or totally from payment of the fee upon decision of the Council. Payment of the fee shall be due on Jan First of each year.

#### 5. Membership shall expire:

- when a Member resigns from the Association by notifying the Secretary in writing;
- when the Membership fee has not been paid within six months of the due date;
- when a Member is expelled from the Association by the Council for having acted in a manner detrimental to the interests or the good name of the Association.

Expulsion shall require the consent of not less than four members of the Council. Before a decision on expulsion is taken, the Secretary of the Association will write to the Member in question, stating the nature of the alleged offence, together with the name(s) of the informant(s) or source(s) of information, and allowing a reasonable time for an explanation.

**6.** Regular Membership Meetings will be held during academic conferences or when called by the Council.

The Council shall call an Extraordinary Membership Meeting upon the request of one-third of the Full Members of the Association. Notice of any business to be transacted at a Membership Meeting shall be given in writing to the Secretary, who shall prepare the agenda of the meeting.

One-third of the Full Members of the Association shall form a quorum for any Membership Meeting, and only Full Members shall have voting rights at any Membership Meeting.

# COUNCIL

7. The affairs of the Association will be managed by the Council. Should the Council need to deal with any matter not explicitly provided for in this Constitution, it shall do its best to consult all Members before making any decision, and in any event submit its decision to all Members at the earliest possible opportunity.

**8.** The Council of the Association shall consist of:

a President;
a Vice-President;
a Secretary;
a Treasurer;
a Councillor for Public Relations;
a Councillor for Membership Affairs; and two (2) other persons.

The members of the Council must be Full Members of the Association, and shall be elected at Membership Meetings. Members of the Council shall be expected to serve normally for a period of four years.

If a motion of no confidence in any Member of the Council is supported by four (4) Members of the Council, that Member shall be dismissed from the Council and from any office which he or she holds in the Association.

Notice of any business to be transacted at a Membership Meeting shall be given in writing to the Secretary, who shall prepare the agenda of the meeting.

Vacancies on the Council arising between Membership Meetings shall be filled by co-option or by transfer of duties within the Council. Members shall be notified of any such changes.

Four (4) members of the Council shall form a quorum for Council meetings. The Treasurer is to render audited annual accounts of the finances of the Association.

# AMENDMENTS

9. This Constitution can be amended at Membership Meetings.

Amendments shall be notified to all Members at least six months before the Membership Meeting. An amendment shall require not less than two-thirds of the votes of Full Members present at a properly constituted Membership Meeting.

# (1.) EPEL

The European Programme for the Exchange of Lecturers is sponsored by the Korea Foundation. Every year, AKSE accepts applications from universities to invite scholars from other institutions to give lectures in their classes. This program also offers excellent opportunities for AKSE members to meet and exchange ideas concerning both research and teaching.

# (2.) Korea Foundation Fellowships for European Graduate Students

AKSE recommends members for the screening committee to be appointed by the Korea Foundation. Final decisions are made by the Korea Foundation.

# **COUNTRY REPORTS**

#### **CZECH REPUBLIC**

# Praha (Prague) <u>Univerzita Karlova v Praze</u> (Charles University) Department of Korean Studies, Institute of East Asian Studies

#### General information

The team of Prague Korean Studies, headed by Miriam LÖWENSTEINOVÁ, includes three full-time assistant professors – Tomáš HORÁK, Vladislava MAZANÁ and Marek ZEMÁNEK – and a full-time lecturer, JUNG Younwoo. The Department is a recipient of the\_Academy of Korean Studies Core University Program for Korean Studies grant (CUPKS). Thanks to the CUPKS, a substantial increase of both size of the department (number of teachers/scholars, students, library holdings) and quality of research (publications, international cooperation and recognition) was possible. In 2016, the Prague Centre for Korean Studies was established. Each year we have been organizing conferences and workshops. The information about our activities is available on Facebook and a website of the project, where we share the results of grant activities as well. For detail, see www.facebook.com/korffuk/ and korea.ff.cuni.cz/. Both the department of Korean Studies and the core staff of the Centre consist of five full-time scholars and an assistant to the centre. They are supported by project assistants, mostly doctoral and graduate students. The current structure of the staff covers different areas in Korean Studies, and we reached balance in terms of age and gender.

#### Conferences

Department of Korean Studies at Charles University, Prague organized conference *Scholar, Monk and Literatus: Kim Sisŭp and Frontiers of Korean Culture* (February 9-10, 2018). The subject of the conference, an emblematic figure of the golden age of Korean culture and literature during Chosŏn period, literate and thinker Kim Sisŭp proved to be very good choice as the conference topic. The conference successfully brought together leading scholars of traditional Korean culture and literature from Western, Central and Eastern Europe, USA, Australia, Russia etc. Extensive discussions both during and after the conference enabled us to set up a feasible timetable for the publication of the conference papers as a monograph in the Brill publication series "Korean Studies Library." #### Scholars' Reports

Associate professor **Miriam LÖWENSTEINOVÁ** (PhDr., PhD) has coordinated the Academy of Korean Studies (AKS) project and taught various new courses (*Korean Literariness I, I, Modern Korean Novel II, Methodology of Research of Korean Literature I*). She published a book of translation of Im Pang's *Ch'ŏnyerok* under the title *Zápisky za hranicí uvěřitelnosti* (Togga, 2018). Under the fellowship of Korea Foundation she spent two months in Korea working on the theme "Understanding and Significance of *Samguk Yusa* in Contemporary Korea". She has attended following conferences: *120 Years Anniversary of Korean Studies at Saint Petersburg State University*, Saint Petersburg State University, Russia (October 12-14, 2017), paper title: "1896 Russia through diaries of Min Yŏnghwan and Yun Ch'iho", International Conference on the English Translation of Korean Classics, Academy of Korean Studies, Seoul, South Korea (December 8, 2017), paper title: "Translation as a Refiguration. Samguk Yusa Chronicle", *Premodern Korean Studies in* 

*Europe Conference*. Bucharest, Rumania (May 29, 2018), paper title: "Kim Sisŭp Conference and Monograph", *Scholar, Monk and Literatus: Kim Sisŭp and Frontiers of Korean Culture*, Charles University, Prague, (February 9-10, 2018), paper title: "Kim Sisŭp's *Kŭmo sinhwa* within the context of *mongyurok* genre".

**Tomáš HORÁK** (Ph Dr., PhD) has been working on translation of No Kwanbŏm's *Kojŏn t'ongbyeŏn*, a book of essays on intellectual history of Korea from eighteenth to twentieth centuries. He taught various new courses (*Theoretical Korean Grammar I, II, Special Korean Terminology*).

**JUNG Younwoo** (Mgr.) taught several language courses and continued her linguistic research. This year she finished (with Marek Zemánek) a textbook, *Chinese characters in Korean for Czech learners* (*Čínské znaky pro koreanisty*). She is also responsible for organizing the CEEPUS (Central European Exchange Program for University Studies) lectures.

Vladislava MAZANÁ (Mgr., PhD candidate) taught various new courses (*Methodology of Research of Korean Language, Classical Korean II*). She has attended the following conference: 16th Conference of the Central and Eastern European Society of Koreanology (*CEESOK*), University of Riga, Latvia (October 29-30, 2017), paper title: "Development of corpus-based study materials on Korean suffixes describing human beings".

Marek ZEMÁNEK (Mgr., MA, PhD) continued his research on Korean Buddhism both old and modern, namely Buddhist rituals. Under the fellowship of Korea Foundation he spent two months in Korea working on the theme "Understanding and Significance of Samguk Yusa in Contemporary Korea". He finished (with Jung Younwoo) textbook, Chinese characters in Korean for Czech learners (Čínské znaky pro koreanisty). He developed and taught several new courses (Modern Korean as Optional Oriental Language IV, Reading of Specialized Texts, Introduction to the Religions of Korea, Modern Korean as Optional Oriental Language V, Textual Tradition of Korean Religions/Korean Religions in Texts, Methodology of Research of Korean Religion and Philosophy I, II: Beginnings in Studies of Korean Religions) and (co-) presented the following papers at the conferences:. "Dynamics and Change in Korean Buddhist Rituals", CKS Seminar, SOAS, University of London (November 2017); "Buddhist Ceremonies in Premodern and Contemporary Korea", Viennese Korean Studies Days (November 2017); "Critical Response to Buddhist Modernities", Oslo Buddhist Studies Forum, Oslo University (October 2017); "New Understanding of North-East Asian History through Czech History: With a Special Focus on Czech and German National Problem", Korea University, Asiatic Research Institute, Colloquium for Comparative History (September 2017).

# <u>Univerzita Palackého v Olomouci</u> (Palacký University Olomouc) Katedra asijských studií (Department of Asian Studies)

#### **General Information**

Korejština (Korean) was established as a section of the Department of Asian Studies at Palacký University in 2015, joining up the established majors Chinese and Japanese studies, while Indonesian studies came into the company two years ago. Students of Korean studies in Olomouc combine intensive language training and the courses on Korean culture, history and society with a variety of practical courses in general and economic studies to be taken outside of the Filozofická Fakulta (Faculty of Arts). In autumn 2018, the fourth cohort of students will be enrolled. From 170 applicants, 36 were chosen. Currently, the program is limited to an undergraduate program, but Korean shall be one possible language track in a future new MA & PhD program in Asian Studies that was recently designed and submitted for accreditation. Since December 2017, the section is a recipient of a SEED project grant from the Korean Studies Promotion Service (Academy of Korean Studies), titled "Consolidation and promotion of Korean studies at Palacký University through international cooperation, academic research, research-based teaching and involvement of students."

# Academic Program

Korean language courses and the various Korean studies subjects are covered by three assistant professors (Dr. Blanka FERKLOVÁ, Korea Foundation visiting professor KAWK Bumo, PhD; Dr. Andreas SCHIRMER), two regular lecturers (Youngran KWAK, MA; Martin ŠTURDIK, MA) and various additional lecturers (Ruda SCHIMERÁ, MA; Linda STÖCKELOVÁ, MA; among others). On a macro level, Korean studies at Palacký University are steered by Dr. David UHER, head of section, and Dr. František KRATOCHVÍL, head of department.

One centerpiece of the section's SEED project is a carousel lecture, i.e., a themed lecture series taking place once a year. The first carousel lecture was organized in the spring/summer semester 2018. Titled "Legacies and heritage: Aspects of premodern and modernizing Korea and their lasting (or imagined) relevance for today's Korean society," it comprised lectures from seven scholars: Marek Zemánek (Prague), Jerome de Wit (Tübingen), Vladimír Glomb (Berlin), Codruta Sintionean (Cluj-Napoca), Barbara Wall (Copenhagen), CedarBough T. Saeji (Vancouver) and Pierre-Emmanuel Roux (Paris).

Another major asset of the project was a "Winter School" providing a two-week intensive language training just before the start of the spring/summer semester. Taking place from January 29 to February, the intensive out-of-the-box teaching was very well received by 28 students. The invited teachers were Paweł Kida (Poznań), Park Hiyoul (Cologne), and Ekaterina Pokholkova (Moscow).

Just like in previous years, many one-semester scholarships were arranged again, thanks to partnerships with Korean universities. The strong presence of Korean businesses in the region provides many opportunities for internships, part time jobs and full-time employment.

Since 2016, the department is a participating partner unit of the Korean Studies network that exists under the umbrella of the Central European Exchange Program for University Studies (CEEPUS). Thanks to a CEEPUS teaching mobility, Olomouc could welcome Dr. Sun Young Yun from Vienna for a series of special lectures in April 2018. As for outgoing CEEPUS mobilities, **Blanka FERKLOVÁ** visited, in May 2018, the Jagellonian University in Cracow to give a series of lectures on "Korean Onomatopoeia and Mimetics," while Martin **ŠTURDIK** received a scholarship for research at the University of Vienna in April 2018.

Andreas SCHIRMER (Mag. Dr.) is the director of the SEED project. His teaching comprises themed courses and a regular newspaper reading class. His current research mostly relates either to the literary representations of current discourses and issues in contemporary Korean literature or to translation studies, as well as the cases of historical interactions between Koreans and Central Europeans. He has continued to coordinate the CEEPUSnetwork Korean Studies in Central and Eastern Europe which he initiated in 2011. For the 2018/2019 term fifty-nine mobility months have been awarded and will be distributed among students and teachers. Going into its ninth year now, the network now comprises fifteen participating partner units from nine countries. Three new partners (Novi Sad, Pula, and Wroclaw) were included, in addition to Bratislava, Bucharest, ELTE Budapest, Cluj-Napoca, Kraków, Ljubljana, Olomouc, Poznan, Prague, Sofia, Vienna, and Warsaw. As a visiting expert for the SEED-program of Korean Studies at Babes-Bolyai University, Cluj-Napoca, Romania, Schirmer held a course there from January 8-12, 2018 on "Translating Korean literature." 

# **General Information**

The CKS is part of a joint research unit called "China, Korea, Japan," bringing together staff from the EHESS, CNRS, and other institutions. As an administrative and educational unit proper to EHESS, the CKS includes the following permanent faculty and staff: Ms. **Eunjoo CARRÉ-NA** ("ingénieure d'études" in charge of the research library and communication at the CKS), Prof. **Alain DELISSEN** ("Directeur d'études" in modern history), Prof. **Valérie GELÉZEAU** ("Directrice d'études" in cultural geography), and Dr. **Isabelle SANCHO** (a specialist of pre-modern Korea, "Chargée de recherches de première classe" at the CNRS appointed to the CKS). The current director of the CKS is **Alain DELISSEN**.

As a team of research however, the CKS also comprises several statutory research associates from different partner institutions, including eight permanent members (all tenured professors or associate professors) from Paris Diderot University (Yannick BRUNETON, Florence GALMICHE, KIM Jin-Ok, KIM Kyung-mi, Marie-Orange RIVÉ-LASAN, Pierre-Emmanuel ROUX, YIM Eunshil and YUN-ROGER Soyoung) along with Evelyne CHÉRELI-RIQUIER (University of La Rochelle). Five honorary members must also be mentioned (Marc ORANGE, Alexandre GUILLEMOZ, Francis MACOUIN, Martine PROST, and LI Jine-Mieung).

Completing the picture are other research associates, whether statutory PhD students or nonstatutory professors from other French or South Korean universities, Korea Foundation Post-Docs (in 2017-2018 Dr **Pavel Em**, a geographer from Moscow University) and "young research associates" ("jeunes chercheurs soutenus"), a new status created in 2013 in order to facilitate their future professional integration in French academia). In April 2018, **Valérie GELÉZEAU**, who had been an associate professor at EHESS since 2007 was elected "directrice d'études" (i.e. full professor) in this same institution. As of January 2019, she will become director of the China, Korea, Japan EHESS-CNRS umbrella Research unit.

Unlike previous decades, the CKS had a gap year in 2017-2018 regarding visiting professors. Yet, this programme will resume in 2018-2019 with Prof. **Park Bae-Gyoun** (SNU) and Prof.

Eugene Park (University of Pennsylvania) visiting Paris respectively in March and May 2019.

# Academic program

Being embedded in a Graduate school, all teaching at EHESS partakes of the research seminar format. The explosion in the number of undergraduate students who pick up Korean studies experienced elsewhere in France cannot (yet?) be observed at the graduate level. All in all, the number of EHESS *enrolled* students remains stable with a yearly average of five to ten students for each level and for each professor. It should be noted, however, that EHESS seminars are also attended, in growing number, by students interested in Korea from other universities of the Paris area.

Finally, EHESS CKS redesigned its erstwhile open-to-all multi-disciplinary seminar of Korean studies (and renamed it "The Intelligence of Korea") so as to address the specific needs of the fresh MA students while exposing them to the different locations and paradigms of scholarship about Korea. It is taught jointly by **Alain DELISSEN**, **Valérie GELÉZEAU** and **Isabelle SANCHO**. This seminar alternates general sessions about "problem areas" (e.g. "Korean history and the issue of modernity/modernization" or "How to approach and research about North Korea" or "Cross-receptions of Prof. Martina Deuchler's work") and research lectures by advanced PhD students/young scholars (Dr **Pavel Em** on the geography of North Korea or **Damien Peladan** on Marine archeology in South Korea). Likewise, established scholars ready to adjust to this audience participate in this seminar. In 2017-2018, Prof. **An Jong Chol** from Tübingen University ("Modifying the Hague Convention?: US Military Occupation of Korea and Japanese Property Issues"), Prof. **Shin Hyun Bang** from LSE ("Circulations of urbanism and real estate capital: The case of Korean developers in Vietnam"), and Prof. **Barbara Wall** from the University of Copenhagen ("The construction

of heroes in the history and historiography of Korea – Crown Prince Sado in popular culture") gave lectures in this framework.

On September 13-14, 2018 the RESCOR (Réseau des études sur la Corée, a Network of research and teaching putting together three funding institutions located in Paris (Paris Diderot, INALCO and EHESS) organized an international workshop in Paris. Stemming from the second leg of an AKS-KSPS 5-year Core University Program for Korean Studies grant (CUPKS) funding (2016-2020) aimed at developing educational materials for teaching Korean studies in French, it put together, on top of other participants from all French universities with courses in Korean studies, guests from the "Francophone" academic world (Africa, Eastern Europe). The target was to deliver a *Livre blanc des études coréennes en France* (the 174-page *White Book* of Korean studies in France) to French top decision-makers while assessing the figures and local significations of the "big boom" in Korean studies observed at the undergraduate level. On top of a keynote speech (by Jeong Eun-jin (INALCO) on Korean Roman-fleuve), thematic round-tables were set out during these two days, as well as one very fine lunch on a houseboat down and up the Seine river, with more than 70 guests on board.

#### Scholars' Reports

As a senior Research Engineer, **Eunjoo CARRÉ-NA** in 2017-2018 developed her activities in two new directions. One has to do with her work as the CKS librarian and the planned relocation of all EHESS "area studies" collections in the new large research library that will take place on the Campus Condorcet, North of Paris. Another one, drawing on her expertise in the digital humanities (See previous AKSE Newsletters about her xml-ization of Courant's *Répertoire historique de l'administration coréenne*), drives her to imagine, develop, and implement new tools at the border of digital techniques and scholarly research.

In 2017-2018 Alain DELISSEN's main activity (on top of its too many academic responsibilities) was aimed at bringing about the first *Livre blanc des études coréennes en France (The White book of Korean Studies in France)* and organize, along with Yannick Bruneton (Université Paris Diderot) and Kim Daeyeol (INALCO), the RESCOR international francophone workshop where it was presented and discussed (see above).

In 2017-2018, Alain chose a 2012 South Korean webtoon (*Chayu puin*) with many echoes in South Korean literature and cinema as the main material to teach his "Historical tempers..." seminar.

The 2017-2018 academic year was marked by the compilation of important reports in France and the presentation of numerous talks abroad for **Isabelle SANCHO**. In the fall of 2017, she

was busy polishing the scientific report of the joint-unit "China, Korea, Japan" at the EHESS for the five-year national research contract (2014-2018) and writing the research programme for the upcoming contract (2018-2023) with her fellow directors of the unit and a few colleagues. She also prepared the visit of the evaluation committee and presented the scientific results of the CKS during the evaluation day in early December. In January 2018, she quit the position of the director of the CKS and vice director of the joint research unit "China, Korea, Japan," as it was agreed with her colleagues of the CKS. She was replaced by Alain Delissen in order to focus on the writing of her *habilitation* project. But as in previous years, she kept doing her part of collective duties: sitting in diverse committees, participating in the scientific management of the RESCOR II, teaching a collective seminar with Alain Delissen and Valérie Gelézeau (Intelligences de la Corée), and writing reviews. Furthermore, in January, she wrote for the CNRS evaluation process the lengthy report, which is compulsory for all CNRS researchers, on her personal research activities for the past five years and her plans for the next five years. In July, she wrote her last piece of report, a short one, for the White paper of the RESCOR to be presented at the RESCOR Workshop in September 2018.

From October to June, she gave six presentations in South Korea and across Europe. In the winter, she was asked twice by South Korean universities (Keimyung University and Sunggyungwan University) to present in details French Korean studies and French premodern Korean studies. In February 9-10, 2018, she took part in the Scholar, Monk and Literatus: Kim Sisup and Frontiers of Korean Culture conference organized by Charles University in Prague. Her talk was about the biography of Kim Sisup by Yi Yulgok, and consisted of preliminary remarks upon which an article in the collective book project on Kim Sisup (an AKS-funded project) will hopefully be prepared in the months to come. In the spring 2018, she was invited to give two EPEL talks. The first one was at the University of Cluj-Napoca and entitled "An Introduction to Confucianism: Basic Notions;" the second one was at Hamburg University and entitled "Understanding Confucianism: the Biographical Temptation." On May 29, 2018, she attended Premodern Korean Studies in Europe Conference (New Europe College, Bucharest, Rumania), the second gathering of European pre-modernists network which followed the first conference that she organized in Paris in January 2016. She presented a talk entitled "Dessine-moi le Confucianisme: Challenges of the Biographical Approaches to Confucianism." Summer was mostly dedicated to the polishing and editing of her English translations of the prose writings by Hwadam Sŏ Kyŏngdŏk.

# **INALCO (Institut National des Langues et Civilisations Orientales)**

#### **Department of Korean Studies.**

#### General information

Also known as « Langues O », The INALCO (National Institute for Oriental Languages and Civilizations) has a long history of teaching and researching about Asian, African, American, Eastern and Middle European Cultures and languages (one hundred languages and civilizations represented). It has been founded in 1668 by Colbert (Ecole des Jeunes de Langues) and merged in 1873 with The École Spéciale des Langues Orientales established in 1795.

Thanks to **Charles Haguenauer**, the first Korean Degree was created in 1959 and since then Korean culture and Korean language have been continually taught and attracted more and more students, especially after the 1980s. At the end of the 2000s, the number of students increased considerably. After being an incorporate section (Chinese and Japanese departments had their own) of the Eurasia Department for a long time, the Department of Korean Studies was established as a separate entity in 2015. Since then, one Professor position and two more Associate Professor positions has been created.

INALCO is a member of "Paris Consortium – Réseau des études sur la Corée (RESCOR)" with two other Parisian institutions: EHESS and Paris Diderot University. Beyond joint research projects, the RESCOR is aimed at developing a Francophone Korean studies network and a new generation of French Koreanists through on-line materials (articles and translations), the production of educational materials in French, and a blog featuring all academic events and publications in Francophone Korean studies. This programme had been

supported for five years by the Academy of Korean Studies (KSPS Core-University) and was renewed for another five years in 2015. The Korean studies section of Paris Diderot University hosts the RESCOR office. The BULAC (Bibliothèque Universitaire des Langues et Civilisations) is one of the largest European Library devoted to non-Western cultures and languages. It is located on the main campus of INALCO. More than 20,000 documents related to Korean culture and Korean language are available there. For more information, see <u>http://www.bulac.fr</u>

#### Academic Program

Around 500 students are currently enrolled for BA and MA degree programs. More than 1200 students apply every year but the capacity of the department is not sufficient (especially since the number of the academic positions is still reduced): the number of students allowed to register for a first year B.A is 150.

INALCO students have the possibility to combine Korean Studies and professionally-focused courses in different areas: international business, translation, international relations, communication and intercultural training, language teaching and multilingual computing. INALCO and Paris Diderot University offer a joint Master Degree program in Korean Studies.

# Scholar's Reports

**Dr. CHOI Jiyoung**, a specialist in formal and experimental linguistics, has been appointed Associated Professor at the Department of Korean Studies, INALCO. She has been teaching Korean language. Dr. **CHOI**'s research focuses on formal syntax, semantics and their interface in Korean linguistics. Her recent projects include studies on the syntax and semantics of *wh*-phrases and lexical semantics of predicates in Korean.

Since 2015, she has been participated, as a principal investigator, in the collaborative research project AThEME (*Advancing the European Multilingual Experience*; <u>http://www.atheme.eu</u>) studying multilingualism in Europe together with 17 partner institutions across 8 European countries, funded by the EU (PCDRT-7). In this project, Dr. **CHOI** experimentally investigates the interpretation of *wh*-phrases including a negative polarity item (e.g. *amwuto* 'anyone') in Heritage Korean. Her research examines to what extent French-dominant Heritage speakers of Korean (living in France) have similar or different knowledge of their Heritage Korean, compared to native speakers of Korean.

Furthermore, Dr. CHOI has just obtained a research grant from the INALCO and the CRLAO (*Centre de Recherches Linguistiques sur l'Asie Orientale*) - UMR 8563 for a collaborative research project "Interface between (morpho-) syntax and prosody: a comparative study of *wh*-words in Chinese, Japanese, Korean and Vietnamese", which will be conducted with Huy-Lin Dao (CRLAO, INALCO), Sumikazu Nishio (CRLAO, INALCO) and Victor Junnan Pan (LLF, Université Paris 7, IUF).

**Dr. Jeong Eun JIN** is Associate Professor at INALCO since 2010. After having studied French Language and Literature at Sogang University in Seoul, she obtained two PhD in France: one in French Literature at Paris Nanterre University in 1998 and the other in Korean Studies at INALCO in 2001.

She specializes in Korean literature of the modern and contemporary period, with a particular interest in how translation has been influencing Korean literature and the literary field. More generally her research interests include various aspects of the Eas-Western cultural encounters. From 2014 to 2016, she participated in a project of the Academy of Korean

Studies, *Conceptions of 'Life' and 'Nature' in Classical Discourses on Korea*, with a study on early French travellers in Korea.

She is currently participating in a Swiss project on modern European Civilization in East Asian travel literature.

**Pr. KIM Daeyeol** was the head of the Department of Korean Studies. His teaching activities included several lectures on history of Korea (general, sociopolitical, cultural) and one on the sino-korean lexicology.

As a participant of the Kim Sisŭp project, *Scholar, Monk and Literate: Kim Sisŭp and Frontiers of Korean Culture* directed by Vladimir Glomb, he presented his chapter entitled "Kim Sisŭp and the Taoist Canon" in the conference meeting held at Charles University, Prague, in February. He gave a lecture on history of Korea entitled "New cultural landscape in the Eighteenth-Century Chosŏn: Cultural Plurality and Dynamism" at the University of Bucharest within the framework of the EPEL program in April. He had a talk on the subject of "Local traditional knowledge from Late Chosŏn Korea: on alcoholic beverages in the *Kyuhap ch'ongsŏ*" in the European pre-modernist meeting held at the University of Bucharest in May. He gave also a talk entitled "Portrait d'un amateur des objets à Séoul au 18<sup>e</sup> siècle" (a collector's portrait in Eighteenth-Century Seoul) on a socio-cultural aspects of the Eighteenth-Century Chosŏn seen via Kim Hongdo's paintings. The talk was delivered within the framework of the annual conference of the Department of Korean Studies at the INALCO. The conference was organized this year in June with the title "Is there any Koreanness? – Influences, Receptions and Inventions of the Korean Art."

During this academic year, he participated in two PhD defense committees: *La naissance de l'acteur moderne en Corée (des années 1910 aux années 1930)* by Yejin CHA at EHESS; and *Réalisme picturale : Pour une étude anthropo-comparative transculturelle sur l'expérience esthétique* by Ju-Yeon HWANG at EHESS.

**Dr. KIM Hui-Yeon,** Associate Professor is a sociologist. Her main research interest is sociology of religion and migration. Her recent presentations are the following:

# Berlin <u>Freie Universität Berlin</u> Institut für Koreastudien (Institute of Korean Studies)

# **General Information**

In 2017-2018 Korean Studies in Berlin engaged in various projects, both new and old, concerning several areas of research and related teaching activities. Besides several special occasions, most of the activities were concentrated within the following research projects:

The Institute of Korean Studies at the Freie Universität Berlin continued the AKS Core University Program for Korean Studies project *Transcoding as Cultural and Social Practice*, which is being jointly conducted alongside the Korean Studies Institute of Ruhr-University Bochum (RUB) from September 2014 to August 2019. Inside the framework of this grant project, the two institutes have continued to collaboratively develop teaching materials, exchange lecturers, create and deepen further networks within European Korean Studies, finance post-doctoral fellowships, support MA students as well as PhD candidates, and

conduct research on transcoding/cultural translation as a core aspect of knowledge circulation. In addition, the two Institutes successfully hosted a summer school in Korea. Apart from the publications produced within this framework, Korean Studies at FU in March of 2018 hosted the University of Tokyo – Freie Universität Berlin Joint Workshop, in which MA students and doctoral candidates presented their respective research in front of a critical audience. The Korean Studies in Berlin further hosted the *PBBP KoreaNet and Yonsei University Joint Graduate Students' and Doctoral Candidates Workshop*, consisting of eleven presentations by graduate students from Yonsei University in addition to professors and students from Freie Universität Berlin, Ruhr-Universität Bochum, INALCO Paris, and Charles University in Prague in April 20-21, 2018. A month later, in May 2018, the IKS organized the AKS International Conference 2018 on the topic of *The Political in the Institutionalization and Ritualization of Public Remembrance*, discussing public remembrance and its relations to power, knowledge, ritual, and memorial sites. The papers presented at the conference will be published in a special volume.

In the course of the long-running project *Sharing the German Government's Documents on Unification and Integration*, which is funded by the Ministry of Unification of the Republic of Korea, several new volumes were published in the Korean edition, covering such topics as culture, agriculture, media, environment, traffic/communication, and others. Concurrently, the institute continued to organize a multitude of seminars and lectures concerning the unification of Korea and the German experience. In the autumn of 2017 the Institute of Korean Studies could intensify the cooperation with the Seoul National University under the GEnKO Programme funded by the German Academic Exchange Service (DAAD) to expand its network. The purpose of the program itself is the promotion of bilateral cooperation and partnership between German and Korean universities. The current cooperation project between the Institute of Korean Studies (FUB) and the Institute for Peace and Unification Studies (SNU) focuses on the topic of *Museumization of Memories - Dealing and Promotion of Peace*.

In December 2017, the Institute of Korean Studies (IKS) at Freie Universität Berlin launched the Berlin Forum on Korea and Northeast Asia, envisioned as a platform for debate and deliberation among professionals and stakeholders concerned with Korea. At the heart of the Berlin Forum is an annual conference bringing together stakeholders from the fields of politics, the diplomatic service, the economy, and the cultural sector with prominent scholars and observers to debate both long-standing issues regarding Korea and Northeast Asia and more contemporary challenges affecting the region. The inaugural conference in December 2017 was themed *The Role of Germany and Europe in the Maintenance of Peace on the Korean Peninsula*. On June 8, 2018, the Institute of Korean Studies at FU Berlin organized the first Kim Dae Jung Lecture in Cooperation with the Kim Dae Jung Presidential Library and the Museum of Yonsei University Seoul. Han Myeong-Sook, former Prime Minister of the Republic of Korea, gave a lecture with the title "Peace and Prosperity on the Korean Peninsula" and afterwards engaged in discussion with Dr. Norbert Baas, former Ambassador to the Republic of Korea.

Within the framework of the Collaborative Research Center *Episteme in Motion* **Eun-Jeung LEE**, **Vladimir GLOMB**, and **Martin GEHLMANN** continued the activities of the project *Knowledge Transfer in the Context of Differentiation and Institutionalization in Sixteenth-and Seventeenth-Century Korea* working on both, individual publications, the collective edited volume *Confucian Academies in East Asia*, and preparing for the next stages of the project.

The past year was further marked by many special events and conferences including: *Food und Kulinaristik aus interdisziplinären und transregionalen Perspektiven* at Freie Universität Berlin (October 19, 2017), *Three Decades after Democratization. Political System, Society and Economy* at Freie Universität Berlin (October 25-27, 2017), *Conflict and Integration as Conditions and Processes in Transitioning Societies of Eastern Europe and East Asia* at Freie Universität Berlin (November 8-9, 2017).

# Academic Program

In the academic term of 2017-2018 a total of 291 persons were enrolled as students of the Institute of Korean Studies at FU Berlin, including fourteen PhD candidates.

Scholars Reports

Eric J. BALLBACH, in the past year, taught several courses on North Koreas international relations and domestic affairs, methods of Korean Studies for graduate students, as well as an introductory course on Korean politics and economy. Inside the framework of a new cooperation agreement assigned with Stiftung Wissenschaft und Politik (SWP) he took the position as a Visiting Researcher at the SWP where he is responsible for timely and independent research on (North and South) Korea in East Asia and highlighting critical issues for the policy community and the broader public at large. Apart of his research activities he served as a an expert advisor on security on the Korean Peninsula and North East Asia for multiple organizations on both domestic and international level including the Parliament of Germany and UN-affiliated bodies. He delivered more than 60 interviews concerning Korean and inter-Korean issues for various media outlets ranging from *Deutsche Welle*, *Tagesschau*, Frankfurter Allgemeine to Phoenix, Public Radio International etc. He gave inter alia following presentations at several conferences and workshops: "Multilateral Institution-Building in Northeast Asia: Prospect and Challenges" (The Fourth Ulaanbataar Dialogue on Northeast Asian Security), "Multilateralism in East Asia and Europe: A Critical Assessment" (International Seminar Peace and Stability on the Korean Peninsula, Royal Elcano Institute), "Nordkorea in der internationalen Ordnung" (Bundesakademie für Sicherheitspolitik, Berlin), "Süd- und Nordkoreas Positionen im Nuklearkonflikt auf der koreanischen Halbinsel" (Symposium Sicherheit in Ostasien: Die Situation auf der koreanischen Halbinsel und ausgewählte Akteure, Deutsche Gesellschaft für Vereinte Nationen), "After Singapore: The Maintenance of Peace on the Korean Peninsula - A View from Europe" (International Conference on the Development of Science and Human Welfare, Kim II Sung University, Pyongyang).

**Holmer BROCHLOS** has continued teaching courses in Korean language on different levels, besides introductory courses on Korean history and culture for beginners. **Daniela CLAUS-KIM** has successfully submitted and defended her dissertation entitled *Remembering, Forgetting, Repressing – The 4.19 Student Movement in Public Memory* in November 2017. Furthermore she continued teaching courses on, i.e. modern Korean culture, gender and social movement, religion and education, and methods of Korean Studies. She also participated at a special seminar for German teachers of social sciences by giving lectures on Korean culture and family in Chemnitz.

**Martin GEHLMANN** continued the work on his dissertation project, *The transmission of the White Deer Grotto Regulations in China and Korea*, within the CRC 980. From March to June 2018 he received a scholarship as visiting scholar at the Yuelu Academy of Hunan University, Changsha, People's Republic of China. # <u>Goethe Universität Frankfurt am Main</u> (Frankfurt University) Korean Studies (Koreastudien), Interdisciplinary Centre for East Asian Studies (IZO)

#### **General Information**

Korean Studies at Goethe-University Frankfurt are located within the Faculty of Linguistics, Culture and Arts (Sprach- und Kulturwissenschaften) and form part of the Interdisciplinary Centre for East Asian Studies (Interdisziplinäres Zentrum für Ostasienstudien, IZO). Since its establishment in 2011, the institute has seen significant growth both in terms of student numbers and research output. With the generous support of the Korea Foundation, a new professorship was established in December 2014. During the past academic year, Korean language courses were taught by **Soyeon MOON**, Dr. **Hyuk-Sook KIM**, and **Eunkyung PARK** (until April 2018).

**Dolf-Alexander NEUHAUS**, **Mi-Jeong JO**, and **Ruixin WEI** worked as doctoral research assistants until June 2018. The second round of funding through the Seed Program for Korean Studies from the Academy of Korean Studies and the South Korean Ministry of Education has been approved until May 2021, supporting the institute in conducting a research project entitled *Strengthening the Korean Studies Education Capacity through the Glocalization of Frankfurt Korean Studies*. It will also help to finance two doctoral research fellow positions within the research project *Korea and the Global Society: Engagement and Reciprocity*.

Another ongoing research project, *Transnational (Return) Migration of Former Korean Female 'Guest Workers' in Hessen and South Korea*, is funded by the Hessen State Ministry for Higher Education, Research and the Arts as part of its research priority programme, *Dimensions of the Category Gender - Women and Gender Studies in Hessen* running from May 2016 till October 2017. The research project analyses the experiences of former Korean nurses in the region around Frankfurt, Germany, and Korea and the impact on traditional gender roles in both countries.

In a third project within the framework of Africa's Asian Options (AFRASO) financed by the German Federal Ministry of Education and Research (BMBF), called *Transnational Mobility and Belonging; Korean Migrants in South Africa*, issues including transnational connectivity between country of origin and country of residence are investigated.

Frankfurt's Korean Studies library collection continues to grow, thanks not only to our own efforts, but also through generous donations by the Korea Foundation as well as individuals. Prof. **Dae Sook KIM**, Dr. **Eja NA**, the Korea Foundation, and the Korea Publication

Association, for example, supported us with kind donations from their valuable collections on Korea. These contributions continue to be catalogued by the Korean Studies librarian.

With the help of ongoing funding from the Teaching Quality Enhancement Fund (QSL), we continue to employ four part-time student assistants who provide invaluable administrative support for the department and the library. In addition, we have managed to secure funds from the Starker Start ins Studium programme to employ four part-time tutors for the Introduction to Korean Studies and introductory Korean language courses to support our new students. These funds have been contributing to reducing dropout rates among first-year students.

# Academic Program

Frankfurt's Korean Studies Department offers several study options: A combined BA degree with the Institute for Empirical Linguistics (as a major or minor), an internal minor programme within a BA Empirical Linguistics, and since the beginning of the 2017-2018 academic year, an independent minor programme in Korean Studies. There are presently around 200 students enrolled in Korean Studies, and close to 100 more have registered for the programme for the new 2018/19 academic year. The department also contributes to the MA Modern East Asian Studies programme by offering additional courses on Korea.

BA students can choose from a wide range of courses on modern Korean society, history, literature, religion, economics, and other humanities and social sciences topics. Our students have also had the opportunity to take part in e-school seminars on Korean society and culture via the Korea Foundation Global e-School programme.

Students can choose to spend a semester at a partner university in Korea (Korea University, Ewha Women's University, Chungang University, Yonsei University, Sunggyungwan University, or Sogang University), for which we have also managed to secure sponsorship from Asiana Airlines for an airline ticket scholarship, called the Asiana Flying Scholarship, as well as discounted tickets for our students. Further opportunities to study abroad have been secured through additional memorandums of understanding for exchange programmes with Yonsei, Sunggyungwan, and Sogang University since 2017.

# Project K – The 6th Korean Film Festival, October 18–22, 2017, Cinestar Metropolis, Frankfurt

Originally a project started by Korean Studies students, Project K has developed into a standalone event. Among the films shown were major productions including *Taxi Driver* and *The Battleship Island* as well as short films and animations. Visitors also had the chance to participate in various cultural events and a K-Pop dance contest.

#### Translation Workshop, October 19–December 21, 2017, Goethe University Frankfurt

Dr. Hyuk-Sook Kim led this fortnightly literature translation workshop. Students tried their hands at translating a classic of Korean literature, *The Story of Sukhyang*, which was translated into modern Korean by Sang-Gu Lee, as well as a related story by Hyeran Cho. The result was the German translations *Die Geschichte der Sukhyang* and *Die bedauernswerte Sukhyang, die ausgesetzt wurde*, both of which are planned to be published in a literary magazine.

# First German UCC Contest for Korean, November 24, 2017, Goethe University Frankfurt

Frankfurt Korean Studies organised their first UCC contest for Korean, the final round of which took place in November 2017. Participants had to submit a video on the topic *Korea in* Germany and were required to put their Korean language skills to use, for example in the form of narration or interviews. The top prizes were stipends for language courses at Ewha University.

# International Conference *Identity and Transnational Mobility in and out of Korea*, February 22–23, 2018, Goethe University Frankfurt

This conference examined important socioeconomic aspects of transnational mobility in and out of Korea as well as the process in which overseas Koreans and returnees in South Korea gain agency and negotiate multiple identities. The core theme of this conference is the identity and transnational mobility of the Korean diaspora across the globe, spanning many countries and regions such as Japan, the Philippines, Germany, the USA; and Korean diaspora returnees to the homeland, covering the period from the nineteenth century till the present. This embraces a broader spectrum of mobility from short-term to long-term mobility, such as the transnational mobility of workers, marriage migrants, tourists, students, and returnees in their ongoing migratory trajectories.

## Scholars' Reports

Prof. **Yonson AHN** has been the Director of the Korean Studies programme and Deputy Executive Director of the Interdisciplinary Centre for East Asian Studies (IZO) since 2014. She has served as President of Vereinigung für Koreaforschung e.V. im deutschsprachigen Raum (The Association for Korean Studies in German Speaking Countries) since November 2016.

#### General information

The Korean Studies staff consists of Prof. Dr. Yvonne SCHULZ ZINDA, Professor for Contemporary East Asian Cultures (China/ Korea) and Director of the Korean studies; Dr. Katharina SŰBERKRŰB, research associate since March 2018 until February 2020Barbara WALL, research associate until August 2017; Kangsun LEE, Korean language Instructor; Helene KANG, librarian for the Korean collection.

#### Academic program:

Korean studies offer a BA (4 years) and MA (2 years) program. It is embedded into the International B.A. East Asia that incorporates some compulsory East Asian modules as part of the separate programs of Korean, Japanese and Chinese studies. Its profile is nineteenth to twenty-first century intellectual history, media history and North Korean studies (film, culture). Accordingly, the library has a collection of currently over 800 films, including over 50 North Korean Films.

Currently Mrs. NA-RHEE Scherfling is working on her Ph.D. thesis entitled *Die Verortung* von Heimat in den südkoreanischen Filmen der Park Chung Hee-Ära, 1961-1979 (Locating home in South Korean Films under Pak Chông-hûi, 1961-1979). Mrs. Hanna PARK is continuing her preparations for the Ph.D. thesis tentatively entitled Candlelight Demonstrations: The development of Korean Culture of Dissent. Mrs. Katharina SÜBERKRÜB is preparing her Ph.D. thesis tentatively entitled Gekauft, Gesammelt, Geraubt: die Provenienz Ethnografischer Koreasammlungen und Koreanisch-europäische Netzwerke 1876-1910 (Bought, Collected, Stolen: Provenience of Ethnographic Korea Collections and Korean-European Networks 1876-1910).

Korean studies received support through the EPEL program. Further guest lectures were given by Prof. Dr. **Burglind Jungmann** and Assoc. Prof. Dr. **Namhee Lee**. General Information Prof. Dr. **You Jae LEE** was appointed to the W3 Full Professorship of Korean Studies at the University of Tübingen on April 1, 2018. From 2010-2016, he was a Junior Professor, then a W3 substitute Professor of Korean Studies. The inauguration of Full Professorship became the cornerstone for the establishment of Korean Studies as an independent department and research institute. On July 6, 2018, a ceremony was held for the establishment of the institutions: Department of Korean Studies and Center for Korean Studies.

Furthermore, the Korean Studies Program at the University of Tübingen successfully continues its five-year, *Tübingen Global Korea Project* (TGKP), supported by the AKS Core University Program for Korean Studies Grant (September 2016 to August 2021). Under the TGKP, the department recruited two new visiting assistant professors, **Ji-yoon AN** (Ph.D., East Asian Studies, University of Cambridge) and **Birgit GEIPEL** (Ph.D., Comparative Literature, University of California, Riverside) to join the faculty from March and April 2018. Also, as part of the TGKP, the department hosted two internal/regional workshops (February 2-3, 2018, and July 7, 2018) and the second international conference (*Translational Turn in Modern Korea*, July 13-14, 2018)

#### Academic Program

The department currently offers five degree programs, including Bachelor of Korean Studies, Master of Korean Studies, Double Master of Korean European Studies (MAKES), Master of Politics and Society of East Asia (MA PGO), and Doctorate of Philosophy in Korean Studies. Our BA program continues to grow and in the winter semester of 2017/18, 82 new students enrolled in Korean Studies; for the 2017/18 academic year, a total of 282 undergraduate students (338 including Korean Studies minors) were enrolled at our department. 60 of our undergraduate students are currently studying in Korea for their one-year of study abroad at one of the ten universities with which we have exchange programs.

Since the introduction of the master degree program in 2014, the number of MA students has also grown, and currently 22 students are enrolled in the program. Additionally, three MA students graduated in the Double Master Program, the Master of Korean European Studies

(MAKES), where students earn two MA degrees, one each from the University of Tübingen and from Seoul National University. Four MAKES students are currently enrolled at Seoul National University (SNU) and two other MA students are at Korea University as exchange students, while 16 MA students are studying in Tübingen.

The department has continued to run its Korean branch, the Tübingen Center for Korean Studies at Korea University (TUCKU), and the King Sejong Institute in Tübingen.

## Seminars and Lectures

This year three conferences and workshops were organized in the context of the continuing Tübingen Global Korea Project (TGKP): During the second international conference of the Tübingen Global Korea Project, *Translational Turn in Modern Korea*, July 13-14, 2018, scholars from Korea, Japan, the USA, and Germany gathered to engage in indepth and innovative discussions on the concept of translation of culture in the Korean context. The department also organized the Third Internal and Fourth Internal TGKP Workshop. The internal workshops are designed as forums to assess individual research progress and to exchange constructive feedback especially for PhD candidates, but also open to other researchers.

For our Third Internal Workshop (February 02-03, 2018) we invited researchers from other universities in Europe and for our Fourth Internal Workshop (July 07, 2018: The Fourth Research Graduate Research Colloquium, AKS TGKP with BK 21+ Korea University) we invited professors and PhD candidates from Korea University to participate in order to not only provide our PhD candidates with a productive research forum, but also to foster institutional exchanges and cooperative opportunities for young scholars.

## Scholars' Reports

Dr. **Ji-yoon AN** joined the department as a Visiting Assistant Professor in Korean Studies in March 2018. She received her Ph.D. in February 2018 from the Department of East Asian Studies at the University of Cambridge, where she specialized in Korean cinema. Coming from a background in film studies, she is interested in cultural trends and flows, focusing particularly on the ways that changing social values and ideologies are reflected, reworked, and imagined in Korean visual culture. At Tübingen University, she is teaching BA courses on Korean history and culture, as well as overseeing the Tübingen Korean Studies Lecture Series. She was also in charge of the Opening Ceremony of the Department of Korean Studies (July, 6, 2018). Since joining Tübingen, she presented on generic hybridity in contemporary K-dramas at the Seventh Conference on Korean Screen Culture, as well as publishing an annotated bibliography chapter on Korean cinema (Lexington Books, 2018). She also has an article forthcoming in *Cross Currents: East Asian History and Culture Review* (December, 2018) and will give an invited talk at the University of Copenhagen in September 2018.

Jun.-Prof. Dr. Jong-Chol AN is a legal historian who is interested in the legal history of Korea, especially the Korean Constitution and the Nationality Law with its historical changes and US legal advisors' activities in Korea. He is currently working on his second book on Modern Korean history, the tentative title for which is *From Continental to Common Law:* US Military Occupation, Republic of Korea and Legal Basis, 1945-1950. Her doctoral thesis and current research examines literary and cinematic discourses of national division and unification in Korea and Germany. At Tübingen University she is teaching BA courses on Korean literature and recent research in Korean studies, is in charge of the visiting scholars' program, participates in curricula revision of the new Korean Studies program and co-organized the round table discussion on the recent North

Korea summits *Gipfelblick - Frieden am Horizont?* (Summit View – Peace on the Horizon?, June 25, 2018). Kim joined the KSGSC organization committee which organizes the next conference in the fall of 2018. Dr. **Sungjo KIM** is a historian of modern and contemporary Korea. He is turning his dissertation into a book monograph tentatively entitled *The Countryside and the City: A Spatial Economy of the New Village Movement in 1970s South Korea*. This study considers the hegemonic power of capitalist modernity, and contributes both to a critical understanding of the historical experience of industrial modernization in the non-West, and to the rethinking of politics between living spaces and capital. Beyond this project, he also explores the Cold War culture and technology in Korea, contextualizing Korean cases within the broader framework of world history. Dr. **KIM** organized and facilitated the weekly lecture series and taught seminar classes such as *Premodern Korean History* and *Modern Korean History since 1945* for the 2017/2018 winter semester. #### **General Information**

The Korean Studies staff consists of Dr. James B. LEWIS, University Lecturer in Korean History (Fellow of Wolfson College), Dr. Jieun Joe KIAER, Young Bin Min-KF Associate Professor in Korean Language and Linguistics (Fellow of Hertford College), Dr. CHI Young-hae, Korean Language Instructor, Mr. Minh CHUNG, Head of Bodleian Chinese Studies Library & Korean Collections, and other library staff.

The 'Window on Korea' (a five-year project sponsored by the National Library of Korea) ended last year. It has been renewed for another five years (2018-2020). The library is able to select and receive about 200 titles a year for the next five years. Ms Myoungshin Kim, the Korean cataloguer left last year and has been replaced by Ms Younji Kang.

The publication of *Korean Treasures in Oxford's Libraries and Museums, vol. 2* is being prepared and will be available in May 2019. While the published first volume of *Korean Treasures* has 5 chapters focused on: 1. Rare books and manuscripts, 2. Ceramics, 3. Photographs, 4. Scaphe sundials, and 5. Weapons and other military artefacts, the second volume will also have 5 chapters focusing on 1. Rare maps, 2. Old coins, 3. Missionaries' donations, 4. Clothes and accessories, 5. Metal work, water droppers, roof tiles, dolls, fans, weapons, and miscellaneous items. Notable items include the only surviving Korean example of an eighteenth-century world map, hand-drawn, with a set of twelve globe gores on a single sheet, and official correspondence from the archives of the United Society for the

Propagation of the Gospel, which illuminate the history of Anglican Christian missions in Korea. Additionally, the publication boasts a wealth of photographs, coins, charms, clothing, weaponry, decorative objects, manuscripts, and much more.

Apart from the increased number of purchased books thanks to the additional new book fund from the Social Sciences, and the usual receipt of generous donations from the Korea Foundation, the National Library of Korea and other institutes, there has also been expansion of the e-resources databases subscriptions that now include DBpia/KRpia, KISS, KSI e-book and *Choson Ilbo*. English language databases include: *Korea Times, The Korea Herald, NK News Pro*, and *Digital National Security Archive*: "The United States and the Two Koreas (1969-2000)"; "The United States and the Two Koreas, Part II, 1969-2010."

#### Academic program

Mr **Sigfrid ÖSTBERG** has spent most of 2016-2018 conducting archival research at the Shiryō hensanjo in Tokyo University. He continues the preparation of a thesis entitled *Nineteenth century Japanese–Korean mutual perceptions, 1811–1882.* The thesis focuses on negotiations across the Korea-Japan frontier with Tsushima at the centre.

Ms **Jean HYUN** continues her preparation of a DPhil thesis entitled *The History of the Malgal: Early Korea's Northern Neighbours*. The thesis combines history with archaeology to examine the theatre of Malgal activity in the Chinese northeast.

Ms. Yeogeun (Yŏnsu) KIM is the recipient of the Oxford-Wolfson Min Sunshik Graduate Scholarship in Korean Literature and began her doctoral work from October 2016. She is reading for a thesis entitled *The Life of Popular Literature in Words and Images: Two Love Stories from Pre-modern Korea.* The thesis examines the transference of the *Kuunmong* and *Ch'unhyang* stories from text to pre-modern visual presentations in print and on folding screens.

Mr. **Yiu SIU** began his doctoral work from October 2016 and is reading for a thesis entitled *Maritime Exclusion in Traditional East Asia*. The thesis compares Ming and Chosŏn policies regarding the control of maritime access to their countries.

Ms. **Fudie ZHAO** will begin reading for a DPhil from October 2018 with a thesis project entitled *Contextualisation of* Yŏnhaengnok *through prosopography and intertextuality*.

Ms. **Kangziyi XIA** will begin reading for a DPhil from October 2018 with a thesis project entitled *Agency and Diplomacy under the* bakuhan *system in Tokugawa Japan*.

Mr. **Sang Yeoup HAN** finished his Master of Studies in Korean Studies degree with a thesis entitled *Mobile Instant Messaging in Korean: Linguistic Variations and Patterns*.

Mr. **Derek DRIGGS** completed his Master of Studies in Korean Studies degree with Distinction and is starting a DPhil in Korean Pragmatics from October 2018.

## Scholars' Reports

Dr. Jieun KIAER finished *The Routledge Course in Korean Translation*, which was published in 2017. She also delivered a paper on translating emotions and interpersonal relations in modern Korean literature at the Oxford Comparative Criticism Conference (OCCT) in March 2017. She has also hosted a number of translation-related seminars, to which translators, such as Deborah Smith, contributed. In addition, she hosted a *Translation in East Asia* workshop in September 2017 with Jennifer Guest and Amy Xiofan Li. She published a paper on Korean-English hybrid words in *Asian Englishes*. Currently, she is finalizing a new manuscript to be published by Routledge, entitled *Translation Words: An East Asian Lexical Encounter with English*, which is forthcoming in January 2018.

## Sheffield

#### **The University of Sheffield** School of East Asian Studies

#### Academic Programme:

The numbers of entering students to do a four-year degree programme in Korean Studies at Sheffield continued to increase, as is paralleled in other institutions. New academic and language staff have been appointed in the past twelve months.

In the academic session 2017-2018, there were 12 graduates with a full four-year single honours or dual honours degree, including one in Music and Korean Studies which is in the Department of Music. The total number of full-time four-year degree students taking a Korean Studies degree was 124 students. Among the graduation dissertation subjects this session were the following topics: "Queer Time and Alienation in Yi Sang's *Wings* and Han Kang's *The Vegetarian*"; "A Comparison of the South Korean Government's Oscillating North Korea Policies in the Twenty-Firth Century: Progressive Cross Border Co-operation vs Conservative Sanctions"; and "Causes and Predictors of Geriatric Suicides in South Korea."

The intensive language programme in Korean language has been revamped with additional hours of staff-student contact. The programme of non-specialist (less intensive) Korean language for students taking it as an option with their main degree subject has been expanded. In March, a Korean Day was hosted through the department to raise awareness of Korea and interest in Korean Studies. In May, the department hosted the first Korean Video Contest which it is hoped will become a regular event.

#### Scholars Reports:

**Dr. Markus BELL**, Lecturer in Korean Studies, reported that he taught the following modules or subjects in the academic session 2017-2018: *Advanced Korean Translation* at both levels 2 and 3 (years 3 and 4 of the degree programme); *Understanding Contemporary North Korea*; *Understanding Korea*. He also reported that he gave the following seminar or conference papers:

Dr. **BELL** has been frequently interviewed by the media on North Korean affairs, notably *The Wall Street Journal*, the BBC, *Financial Times*, *The Christian Science Monitor*, *Los Angeles Times*, and *The Washington Post*. He also reported that his book entitled *Heaven Across the Water: Migration to and From North Korea* is under contract with Berghahn for publication in late 2019 and that his article "Reimagining North Korea: The Korean Diaspora's Changing Relationship to the Homeland," has been accepted for publication in *The Asia Pacific Journal of Anthropology*, in 2019. The following book chapter with Armytage Rosita is set for publication in late 2018: "Ethnography from Afar: North Korea's Border Population and Diaspora," in Adam Cathcart, et al eds., *Decoding the Sino-North Korean Borderlands*, (University of Amsterdam Press). In 2019 the following book chapter is scheduled for publication: " 'The Difference Between Life and Death': Zainichi Koreans' Food Culture in North Korea" in Stephen Epstein and Rumi Sakamoto eds., *Popular Culture and the Transformation of Japan-Korea Relations* (Routledge).

**Mrs.** Sukyeon CHO, Senior Korean Language Tutor, reported that she teaches or contributes to the teaching of the following modules: *Korean Language* I, *Korean Language* II, *Advanced Korean* I, *Advanced Korean* II, *Advanced Korean* III, and *Advanced Korean* IV. She mentioned that the School is now offering specialist Korean at all levels (for students pursuing a full four-year degree programme in Korean Studies) and non-specialist Korean (for students doing other degree programmes) at the beginner level. Korean language modules have been very popular and as a result the numbers of students doing the non-specialist modules had to be capped at 80.

During the academic year 2017-2018 the numbers of students doing Korean language was as follows: Level 1 (Year 1): 60 specialist students and 80 non-specialist students; Korea Year Abroad: 25 students; Level 2 (Year 3): 18 specialist students; Level 3 (Year 4): 12 students. Because of this demand for Korean language the School of East Asian Studies has recruited one more full-time Korean language teacher, Ms. **KIM Kyuin**, who will start teaching from September, 2018. This additional staff member will enable the School to offer non-specialist Korean language at the intermediate level from the academic year 2019-2020.

Because the School of East Asian Studies has re-organised the structures of its degree programmes, the credit value for language modules at Level 1 and Level 2 will go up from 20 credits per semester to 30 credits per semester, providing Korean Studies students with greater opportunities to enhance their Korean language skills than before.

**Deokhyo CHOI**, was appointed as Lecturer in Korean Studies beginning from the academic year 2018-2019. As a new member of staff, Dr. **CHOI** has said that his research focusses on the decolonisation of the Japanese empire, the U.S. occupation of Japan and Korea, and the Korean War. He is currently working on his first monograph which is based upon his doctoral thesis, which won the International Convention of Asia Scholars Best Dissertation Prize for 2015 in the Humanities. The book will explore transnational linkages of politics, social movements, and the so-called '*zainichi* Korean question' between U.S.-occupied Japan and Korea.

Before joining the staff of the School of East Asian Studies, Dr. **CHOI** taught at Underwood International College of Yonsei University, and the Division of International Studies at Korea University. At Yonsei University he taught in Spring 2017 and Spring 2018 *History and Memory in East Asia*, and in the autumn of 2017 *Topics in Modern Korean History*, and in the Spring of 2018 *Topics in Japanese History*. At Korea University in the autumn of 2017 he taught *Special Topics in East Asian Studies: Korea and Japan in the Past and Present*.

**Emeritus Professor James H. GRAYSON** reports that he was asked in the Spring 2018 to teach the Level 1 module *History of Korea* covering the general history of Korea. There were 73 students registered for this module who were drawn from various degree programmes in the School of East Asian Studies, and from the departments of History, Linguistics, and Geography. He gave a paper entitled "The Transmission of Buddhism into East Asia: An Exchange of Culture between Two Cultural Worlds" at the University College Cork *One Asia Seminar Series*, Cork, Ireland on April 13, 2018. He acted as a Desk Reviewer for the International Council on Monuments and Sites (United Nations) in November, 2017. He was interviewed by the media on the following occasions: *Voice of Islam* radio about the current situation in North Korea on September 13, 2017; as a member of a panel of four people by the Revd. Roy Jenkins on 'Religion in Korea' for the programme *All Things Considered* on BBC Wales on February 18, 2018; by BBC Radio 5 Live on the release of three Korean American Christians held captive in North Korea prior to the summit with Kim Chŏngŭn and

Donald Trump on May 9, 2018; and Tony Le Blanc of Quay FM (Alderney) *Quay Features* on the historic background to the situation on the Korean Peninsula which was broadcast on Monday June 18, 2018.

**Dr. Andrew KILLICK**, Reader in Ethnomusicology in the **Department of Music**, reports that he continues to teach the modules *Music of the World* and *Musical Culture in East Asia*, both of which include Korean content.

**Ms. KIM, Yeon-jeong**, Tutor in Korean language teaches or contributes to the teaching of the following specialist Korean language modules: *Korean Language* I, *Korean Language* II, *Advanced Korean* I, *Advanced Korean* II, *Advanced Korean* II, and *Advanced Korean* IV, and is also the director of the Korean Language programme for non-specialists.

**Dr Kate TAYLOR-JONES**, Senior Lecturer in East Asian Studies, reports that she continues to teach the following modules: *East Asian Cinema* (Level 1), *East Asian Popular Culture* (Level 2), *Korean Cinema* (Level 3 – final year), and *Media, Culture and Society in East Asia* (post-graduate). She is the founding editor (in 2015) and joint Co-Editor of the *East Asian Journal of Popular Culture*, the first peer-reviewed journal focussed on the Popular Culture of East Asia.

## Introduction

The KSGSC committee held the *Fifteenth Korean Studies Graduate Students Convention* at Sapienza University of Rome, Italian Institute of Oriental Studies (ISO), on September 27-29, 2018. The conference aimed to give graduate students in all Korea-related fields an opportunity to present their research, share academic interests, and strengthen ties with other junior scholars.

This conference followed the KSGSC's history marked by successful previous conventions at Ruhr University, Bochum (2004), SOAS, London (2005), the Oriental Institute, Prague (2006), Edinburgh University (2007), Leiden University (2008), Moscow State University (2009), Babes-Bolyai University (2010), Maison de l'Asie, Paris (2011), University of Warsaw (2012), University of Helsinki (2013), Saint Petersburg State University (2014), University of Malaga (2015), University of Copenhagen (2016) and University of Tübingen (2017).

# Conference

1st day (September 26): arrival and informal pre-conference drinks

Participants arrived on September 26and checked in at the hotel. There was an informal gettogether in the evening in a pub/restaurant situated in the University area (San Lorenzo), close to the hotel. In total, about twenty participants made it to the dinner and socialized together.

 $2^{nd}$  day (September 27)

On September 27there was a full day of conference. Participants met in the hotel lobby at 8:30 a.m. and walked together to the conference venue. Registration started at 9 a.m.

The opening session started at 9:30 a.m. **Giovanni VOLPE** gave a brief introduction of the conference and presented the speakers. Mr. **Soomyoung LEE**, the director of the Korean Cultural Center in Rome, opened the conference by giving congratulatory remarks. Prof. **Alessandra Brezzi** (Director of ISO at Sapienza University) and Prof. **Antonetta BRUNO** (Director of Korean Studies) gave a welcoming speech.

During this first day there were four sessions in total (see the detailed schedule below). There was one coffee-break in the morning and one in the afternoon. Buffet lunch was kindly offered by the Korean Cultural Center in Rome, which delivered delicious Korean food from a nearby Korean restaurant. Student volunteers helped to collect, lay out the food and clear it away. This event was a great success and gave everyone a opportunity to mingle and make connections with fellow Korean studies researchers.

The conference ended at 17:40. Participants went back to the hotel and met again at 19:30 to go out for dinner in a restaurant in the University area.

# 3<sup>rd</sup> day (September 28)

On September 28 there was another full day of conference divided in four sessions. Conference started at 9:00 and ended at 18:40. There was one coffee break in the morning and one in the evening. Participants had lunch at the cafeteria of the Department and dinner was held in a restaurant in the University area right after the end of the conference.

# 4<sup>th</sup> day (September 29)

On the final day, September 29, the conference went on until the early afternoon, with one coffee-break, and was followed by the KSGSC general meeting which laid out the objectives of the conference and gained valuable feedback from participants. In addition, elections were held for a new member of the committee since **Ekaterina LOGUNOVA** (Russian State University for the Humanities) stepped down. Two participants stood as candidates for the committee: **Anastasia ARTEMOVA** (HSE, Moscow) and **Younès M'GHARI** (Ecole des Hautes Etudes en Sciences Sociales). They both gave a brief 'pitch' about why they would like to serve on the committee and their ideas. **Younès M'GHARI** put forward Paris as the next venue of the KSGSC, while **Anastasia ARTEMOVA** pointed out some difficulties in organizing next year convention in Moscow and acknowledged Paris as a better option. In the end **Younès M'GHARI**, a PhD student at the Ecole des Hautes Etudes en Sciences Sociales, was elected as a new member of the organizing committee and Paris was selected as the next venue of the KSGSC for 2019.

Participants had a final lunch in a restaurant near the conference venue.

# **Conference organization**

The KSGSC committee organized the CfP, judged the abstracts, answered participants' questions, organized the panels and made a pdf booklet of the papers.

## Call for Papers

The call for papers was mainly advertised through the Korean Studies mailing list, the British Association of Korean Studies mailing list, the AKSE website and the Humanities Net (US, H-Net).

## Selection process

The organizing committee received 77 abstract applications from all over the world. This set a new record for the conference, showing an increasing interest for the KSGSC and boding well for the future of this conference and Korean Studies in Europe.

The process of selection of the applications was the following: each paper was blind reviewed (one member of the committee gathered all the abstracts in one file and shared it with other members after having eliminated all personal information). Committee members awarded each abstract a score 1-5 (5 is highest) based on the quality of the proposal. The scores were added together, and the top scorers invited to participate. This year the committee made a final list of 26 participants to invite based on the originality and academic quality of their submissions. Unfortunately, one invited participant (**Evgenia AN**, Frankfurt University) cancelled her participation a few days before the conference due to documented health reasons.

Besides invited participants, KSGSC Committee members attended the conference and participated with presentations, although they did not need to enter the competitive selection process because they volunteer to help organize the conference. This year **Luis BOTELLA** (Malaga University) had to cancel his participation due to other academic commitments.

A pdf booklet of the papers was shared by email with all participants one week in advance of the beginning of the conference.

# Panel schedule

Each year one member of the committee has to draw up the composition and order of panels. This year **Ekaterina LOGUNOVA** drew up an excellent panel schedule, the composition and order of panels had to be only slightly changed because of the schedules of individual panelists or moderators.

Most of the moderators of the panels were chosen from professors of Sapienza University, all senior scholars who could provide useful feedback to junior scholars. One panel was moderated by Prof. **You Jae LEE** (University of Tübingen), who also attended all three days of the conference. For two panels it was not possible to have moderators from the host institution and committee members moderated them. In general panels ran for between one and two hours. Each presenter was allowed 20 minutes to speak and 10 minutes for questions.

## Audience

On each day there was an average of between 35-45 people (including presenters) in a meeting room designed to seat 50 participants. Many professors of Sapienza University accepted to act as moderators for the conference sessions. Most of the MA students were involved as student helpers so attended all the conference. However, although the conference was widely advertised, very few BA students, PhD students and professors showed up.

## **Results and future plans**

The conference was deemed highly successful and enjoyable by both the Organizing Committee members, professors and other participants who all expressed their personal appreciation during and after the conference. Both the quality of papers and diversity of topics presented was high, allowing for constructive academic exchange and stimulating discussions which carried over into informal conversation during the coffee-breaks and meals.

I believe that the conference succeeded in promoting scholarship on Korea in Europe and that had a great impact and helped raise the profile of Korean studies at Sapienza University. Moreover, the gathering of graduate students from many different institutions and geographical backgrounds resulted in a lively exchange of information and the creation of connections that will likely be fruitful in the future.

The facilities were excellent and the catering overall was successful thanks to the student volunteers. The lunches, dinners and panels were carried out without any problem. Rome is a historical city and I think that participants really enjoyed their visit. The University administration was very helpful in hosting the conference.

At the KSGSC final meeting Paris was selected as the next venue of the KSGSC for 2019. The KSGSC committee will thus apply to the 2019 Korean Studies Grant for the organization of the next conference.

#### <u>Oslo University</u> (UiO) Faculty of Humanities (HF), Depatment of Culture Studies and Oriental Languages (IKOS)

#### General Information

Korean language course was discontinued at the Oslo University in 2006 (originally established in 2000), due to low enrollments. Norwegian students may, however, attend the Korean language subjects at Stockholm University (Department of Asian, Middle Eastern and Turkish Studies) and have the grades recognized and included into their diplomas in Oslo. Nevertheless, in Oslo too there are some Korea-related courses, both on Bachelor and Master

levels. They are mostly taught by **Vladimir TIKHONOV** (Pak Noja, professor, Department of Culture Studies and Oriental Languages), together with **Elisabeth SCHOBER** (associate professor, Department of Social Anthropology, Faculty of Social Science). Oslo University continuously enjoys brisk exchange of students with its seven partner universities in South Korea. It also has an exchange agreement with Kim Il Sung University in Pyongyang (North Korea) since 2010, with a focus on cooperation between medical faculties; the agreement, however, did not result in any personnel exchange so far.

#### Academic Program

On the BA level, 10 credit courses in Korean society/politics and religion/philosophy are being offered every other year. A course on North Korea is offered annually. These courses are usually taken by 40-50 students on average. A new course in South Korean popular culture is to be offered from Spring 2019. On the MA level, there is a sizable Korea-related content in such courses as *Approaches to East Asian Culture and History, Topics in East Asian Culture and History* etc. East Asian Culture and History (EACH) is an umbrella 2-years MA program which allows the students to write their dissertations on any East Asian society, Korean included. Currently, one EACH Master student writes her thesis on Korea, to be completed by December 2020. Very unfortunately, Oslo University currently plans to discontinue the EACH program from 2020 onward.
